Data Protection Privacy Notice for - Application Form – Exemption - Carriage of Munitions of War on Civil Aircraft

Part A:

We are fully committed to keeping all personal data submitted to us safe and secure. All necessary technical measures have been put in place to ensure the safety and security of the systems which hold your data.

Being open and transparent in how we process your personal data is important to us and therefore we aim to keep you informed of the purpose(s) for which your personal data will be used and why, where it may be shared elsewhere and why, and how long your data may be held by the Department.

Data Controller and Data Protection Officer

Personal data processed by the Department will only be used for the specific purpose(s) as outlined when the data is collected, or in later communications, and will only be used in accordance with the Data Protection legislation in force.

Data Subject Rights

When you provide personal data to us you have certain rights available to you in relation to that data. These rights are outlined below and can be exercised by contacting the Data Protection Officer, as detailed above, indicating which right you wish to exercise:

- The right to be informed
- The right of access
- The right to rectification
- The right to erasure
- The right to restrict processing
- The right to data portability
- The right to object
- Rights in relation to automated decision making and profiling

Finally, as a data subject, should you be unhappy with the provision of information in this Notice you can make a complaint to the Data Protection Commission, which is Ireland's Supervisory Authority for data protection matters.

Specific Purpose:

Application Form – Exemption Carriage of Munitions of War on Civil Aircraft is used for the purpose of processing an application to carry munitions of war on civil aircraft and releasing the appropriate granted/refused documentation to the air operator's representative (the data subject).

Legal Basis

There is a legal basis for the collection and processing of the personal data in the Application Form – Exemption Carriage of Munitions of War on Civil Aircraft. It is the Air Navigation (Carriage of Munitions of War, Weapons and Dangerous Goods) Orders, 1973 and 1989

Recipients:

This information is held internally by the Department of Transport though will be made available to other Government Departments, agencies under the remit of DoT and may be released through a freedom of information request or equivalent, subject to third party consultation

Retention Period

The data collected for this purpose will be held by the Department only as long as there is a business need to do so in line with the purpose(s) for which the personal data was collected. After this time it will be marked for destruction and will be destroyed in line with internal guidelines or guidelines for destruction received from the National Archives Office or associated permission received from them or in line with other statutory requirements for destruction.

Data Provision - Statutory Obligation

The personal data provided for this purpose is being requested under the requirements of the Air Navigation (Carriage of Munitions of War, Weapons and Dangerous Goods) Orders, 1973 and 1989. If the information requested in this form is not provided, your application will **not** go any further in the process.

Automated Decision Making

Automated decision making is not part of the processing of the personal data included in the Application Form – Exemption Carriage of Munitions of War on Civil Aircraft
