Letter of request for mutual legal assistance involving the production of evidential material for the purpose of a criminal investigation

In order for Ireland to provide international mutual assistance involving the production of evidential material for a criminal investigation it is necessary, in order to comply with requirements under national legislation and of the judicial authority, that certain information and assurances are provided in the letter of request. These particular requirements relate to requests for the production of specified evidential material by way of Court order. In order to facilitate the provision of the widest and most expedient measure of mutual legal assistance in the context of such production orders requesting authorities are required to provide the information and declaration of assurances set out below. The information and assurances concerned can either be provided by completing this form and declaration or including the information and declaration in the requesting State's own letter of request. The information and assurances must, in any event, be clearly provided in order for the request for the production of evidential material to be considered, processed and brought before the Court.

- (3) a defendant will be able to challenge any evidence supplied by the Irish authorities if the material is to be used at his/her trial in the requesting State.
