



Data Protection Privacy Notice for Application Form to register change of address on Motor Dealer Identity Number.

Part A:

We are fully committed to keeping all personal data submitted to us safe and secure. All necessary technical measures have been put in place to ensure the safety and security of the systems which hold your data.

Personal data processed by the Department will only be used for the specific purpose(s) as outlined when the data is collected, or in later communications, and will only be used in accordance with the Data Protection legislation in force.

Data Subject Rights

When you provide personal data to us you have certain rights available to you in relation to that data. These rights are outlined below and can be exercised by contacting the Data Protection Officer, as detailed above, indicating which right you wish to exercise:

- The right to be informed
- The right of access
- The right to rectification
- The right to erasure
- The right to restrict processing
- The right to data portability

Part B: Information Specific to the Data Being Collected in Application Form to register change of address on Motor Dealer Identity Number.

The following data is specific information in relation to the personal data for processed for the purposes of this form

Specific Purpose:

This form is used to enable Motor Dealers to register a change of address on their Motor Dealer Identity Number. This identity no. is issued by Dept. of Transport to facilitate Motor Dealers who wish to carry out the business of buying and selling motor vehicles.

The NVDF constitutes the national driver and vehicle registers and has a legal basis in Section 60 of the Finance Act 1993. The NVDF database contains details in respect of the registered vehicles and licensed drivers in the country. The NVDF plays a critical role in the collection of motor tax and vehicle ownership notification services. The NVDF also fulfils legal obligations in relation to the recording of penalty points and provides vehicle and driver related statistical analyses to assist with the business objectives of a range of stakeholders.

Legal Basis

The Motor Dealer Identity Number assigned from details furnished on this form may be used only as a basis for notifying changes of ownership under Article 10 of the Road Vehicles (Registration and Licensing) Regulations, 1992 (S.I. No 385 of 1992 as amended).

Recipients:

Section 60 of the Finance Act (No. 13 of 1993) as amended provides for access to the National Vehicle and Driver File (NVDF) data to those prescribed in Regulations by the Minister for Transport.

These include:

- Government Departments/Bodies/Agencies who use the NVDF data for business delivery purposes, assisting with investigations and assisting in the execution of a regulatory framework; and
- Other persons assisting with the provision of a commercial service which is considered in the general public interest

Transferred outside the EU/EEA and countries with which there is no adequacy agreement*

The personal information you provide in this form is not transferred outside the EU/EEA.

Retention Period

The data collected for this purpose will be held by the Department only as long as there is a business need to do so in line with the purpose(s) for which the personal data was collected. After this time it will be marked for destruction and will be destroyed in line with internal guidelines or guidelines for destruction received from the National Archives Office or associated permission received from them or in line with other statutory requirements for destruction.

Data Provision – Statutory Obligation

The personal data provided for this purpose is being requested under the requirements of Section 60 of the Finance Act 1993. The Road Vehicles (Registration and Licensing) Regulations, 1992 sets out the provisions that must be complied with when ownership of a motor vehicle changes. The law places an obligation on the seller of the vehicle to notify the Department of Transport of the sale of their vehicle and the changes are recorded on the National Vehicle and Driver File (NVDF). This prevents the seller remaining as the registered owner on the NVDF records thus becoming liable for any vehicle penalties.

Automated Decision Making

Automated decision making is not part of the processing of the personal data included in this form.

Information from a third party

Not applicable for this form. The law requires both the seller and the buyer of the vehicle to complete this form, and the new owner details are recorded on the NVDF.
