



Data Protection Privacy Notice for Safe Seas Ireland (SSI)

Part A:

We are fully committed to keeping all personal data submitted to us safe and secure. All necessary technical measures have been put in place to ensure the safety and security of the systems which hold your data.

Being open and transparent in how we process your personal data is important to us and therefore we aim to keep you informed of the purpose(s) for which your personal data will be used and why, where it may be shared elsewhere and why, and how long your data may be held by the Department.

Personal data processed by the Department will only be used for the specific purpose(s) as outlined when the data is collected, or in later communications, and will only be used in accordance with the Data Protection legislation in force.

Data Subject Rights

When you provide personal data to us you have certain rights available to you in relation to that data. These rights are outlined below and can be exercised by contacting the Data Protection Officer, as detailed above, indicating which right you wish to exercise:

Part B: Information Specific to the Data Being Collected in Safe Seas Ireland (SSI)

The following data is specific information in relation to the personal data processed for the purposes of this form.

Specific Purpose:

Certain information must be provided for administrative and procedural purposes when a ship arrives in or departs from a port in the State. Safe Seas Ireland (SSI) is Ireland's single window system to satisfy the Reporting Formalities Directive requirements, transposed by S.I. No. 166/2012 - European Union (Reporting Formalities for Ships) Regulations 2012.

SSI is used by staff in the Marine Survey Office (MSO) and employs a central national hub that will route messages originating from Ireland's ports on to the European Maritime Safety Agency (EMSA) SafeSeaNet central index.

Legal Basis

There is a legal basis for the collection and processing of the personal data in Safe Seas Ireland (SSI). It is contained in S.I. No. 166/2012 - European Union (Reporting Formalities for Ships) Regulations 2012 as amended by S.I. No. 678/2019 - European Union (Reporting Formalities for Ships) (Amendment) Regulations 2019.

Recipients:

Recipients of this data are the Marine Survey Office (MSO) and its administrative staff, Revenue, Irish Coast Guard, Department of Defence, Health Service Executive, Central Statistics Office and Commissioners of Irish Lights.

Transferred outside the EU/EEA and countries with which there is no adequacy agreement*

The personal information you provide in this form is not transferred outside the EU/EEA.

Retention Period

The data collected for this purpose will be held by the Department only as long as there is a business need to do so in line with the purpose(s) for which the personal data was collected. After this time, it will be marked for destruction and will be destroyed in line with internal guidelines or guidelines for destruction received from the National Archives Office or associated permission received from them or in line with other statutory requirements for destruction.

Data Provision – Statutory Obligation

The personal data provided for this purpose is being requested under the requirements of S.I. No. 166/2012 - European Union (Reporting Formalities for Ships) Regulations 2012 as amended by S.I. No. 678/2019 - European Union (Reporting Formalities for Ships) (Amendment) Regulations 2019. If the information requested in this form is not provided, your application will not go any further in the process.

Automated Decision Making

Automated decision making is not part of the processing of the personal data included in Safe Seas Ireland (SSI).

Information from a third party

Your personal data is obtained from shipping agents acting on behalf of shipping operators and is submitted to this department using a web based interface in Safe Seas Ireland (SSI) in line with this Department's requirement to ensure vessels are complying with their obligations as previously outlined.
