Focus on providing information, training and technical advice, guidance and mentoring to bioenergy business development and start-up enterprises.


Priority 1: Employment and Enterprise Supports.

### What the project is seeking to achieve





1) **Innovation**: This project is innovative as it will assist with the development of new green energy business which will provide employment opportunities for a transitioning workforce and drive local supply chains, satisfying local demand.



2) **Economic Sustainability**: The project will assist companies and individuals seeking to establish sustainable enterprises.



3) **Social**: The business start-ups will sustain employment and maintain the fabric of rural communities in the midlands which are impacted by the transitioning from peat and power generation.



4) **Environmental**: The business start-ups will be producing sustainable bioenergy centred on environmental protection and in compliance with the sustainability criteria set out in the Renewable Energy Directive II

### **Project Work Packages**





<u>Work Package 1:</u> Bioenergy feedstock supply and energy demand analysis for the midlands to be completed. This will be completed by a consultant with assistance from the IrBEA CEO, Technical Executive and dedicated project employee. This work package will commence in late 2021 and be completed in the first quarter of 2022. It will involve widespread engagement with stakeholders in the region.



<u>Work Package 2:</u> Knowledge, Training and Skills needs analysis of producers, stakeholders and energy users. This work package will be completed concurrently with work package 1. This will be completed in the first quarter of 2022.



Work Package 3: Information and Knowledge Transfer Programme to address the knowledge and information gaps resulting from the needs analysis regarding development of enterprises and jobs in the bioenergy sector. The design of this work package will be finalised based on the outcomes of work package 1 and 2. This work package would include a series of 16 public stakeholder information workshops throughout the region on bioenergy topics such as biomass production, biogas production, wood fuel and energy crop processing and production and biochar production and usage. Conferences and information seminars on bioenergy topics linking producers, energy users and investors will be completed.

### **Project Work Packages**

### Work Package 4:

In this work package, 12 new businesses will be provided with mentoring and technical advice to develop start-up enterprises in the bioenergy sector in the Midlands Region.

The start-ups will be in the areas of biomass production, biogas feedstock production, biogas production, wood fuel and energy crop production and processing and biochar production and usage.

The project will assist the start-ups with mentoring and technical advice in all aspects of the process of business establishment.

Competitive process to select 12 start ups.



## The Midlands Bioenergy Development project will deliver on the following priorities:



#### **Employment and Enterprise Support**

12 new bioenergy start ups will be mentored employing up to an estimated 60 people directly in total and each of the start up will indirectly support up to an average estimate of 10 suppliers/ contractors, thus up to potentially 120 employees indirectly. Each business will make investments of up to €250,000 in the establishment of their long-term sustainable bioenergy businesses.

#### **Information and Training Supports**

The project will deliver a knowledge transfer and information programme as part of work package 3 specifically developed based on the information and training needs established in work package 2.

#### **Community Transition Supports**

The project will involve widespread community engagement and interaction. The project will establish dialogue within communities on the bioenergy opportunities which exist for communities to move from fossil fuels to renewable fuels. The community will be represented on the steering group and also given every opportunity to participate. Local trading of renewable fuels will enhance community coherence, buy in and involvement.
