Notice to all Shipowners, Fishing Vessel Owners, Agents, Shipmasters, Skippers, Fishers, Yachtsmen and Seafarers

Vessel/ROV Operations in the Kinsale Head and Seven Heads Gas Fields

1. Notice of Activity

The Department of Transport has been advised that Kinsale Energy will undertake vessel based subsea ROV/removal operations in the Kinsale Head and Seven Heads Gas Fields. This is necessary to perform decommissioning activities on and around the subsea infrastructure. The works are due to commence on or around 23 August 2021 and are estimated to last 20 days. However, please note the start date and the duration of the activity is weather dependant.
