*Notice to all Shipowners, Fishing Vessel Owners, Agents, Shipmasters, Skippers, Fishers,
Yachtsmen and Seafarers*

Corrib Gas Field Pipeline Inspection and EDU B Replacement Works

1. Notice of activity

The Department of Transport has been advised by Vermilion Exploration & Production Ireland Limited of a maintenance campaign at the Corrib subsea infrastructure. The works are due to commence in the field on 01 October 2021 approximately and will last for up to 21 days.

2. Location of Activity

The maintenance work at the Corrib gas field will take place at the following location:

Latitude	Longitude
54° 20' 20.413" N,	11° 03' 30.769" W.

3. Details of Vessel

The “**Edda Sun**”, (Callsign: **LARF7**) will undertake the subsea scope of work. All equipment used will be vessel and/or remotely operated vehicle (ROV) mounted. The vessel will be listening on VHF CH 16 throughout the project. Note: Visual surveys will be conducted along the Corrib pipelines and umbilical’s using vessel mounted ROV’s and their associated camera booms. No acoustic survey equipment will be utilised during the campaign.

All mariners are reminded of their responsibilities under the International Collision Regulations and are reminded of [Marine Notice No. 17 of 2007](#), which gives general advice in relation to the activities of vessels engaged in survey work for hydrographic, seismic, fishing research and underwater operations.

The International Regulations for Prevention of Collisions at Sea (COLREGS) are implemented in Irish law by the *Merchant Shipping (Collision Regulations) (Ships and Water Craft on the Water) Order 2012* [S.I. No. 507 of 2012], and the *Signals of Distress (Ships) Rules 2012* [S.I. No.170 of 2012].
