



Data Protection Privacy Notice for Seafarers Information System (SIS)

Part A:

We are fully committed to keeping all personal data submitted to us safe and secure. All necessary technical measures have been put in place to ensure the safety and security of the systems which hold your data.

Being open and transparent in how we process your personal data is important to us and therefore we aim to keep you informed of the purpose(s) for which your personal data will be used and why, where it may be shared elsewhere and why, and how long your data may be held by the Department.

Personal data processed by the Department will only be used for the specific purpose(s) as outlined when the data is collected, or in later communications, and will only be used in accordance with the Data Protection legislation in force.

Data Subject Rights

When you provide personal data to us you have certain rights available to you in relation to that data. These rights are outlined below and can be exercised by contacting the Data Protection Officer, as detailed above, indicating which right you wish to exercise:

- The right to be informed
- The right of access
- The right to rectification
- The right to erasure
- The right to restrict processing
- The right to data portability

Part B: Information Specific to the Data Being Collected in Seafarers Information System (SIS)

The following data is specific information in relation to the personal data processed for the purposes of this form.

Specific Purpose:

The Seafarers Information System (SIS) is used to process certification applications for seafarers, fishers and recreational craft users. Certain personal data is needed to process these applications in adherence with the International Convention on Standards of Training, Certification and Watchkeeping for Seafarers (STCW).

Legal Basis

There is a legal basis for the collection and processing of the personal data in Seafarers Information System (SIS). It is contained in S.I. No. 242/2014 - European Union (Training, Certification and Watchkeeping for Seafarers) Regulations 2014, Merchant Shipping (Medical Examinations) Regulations 2014 and European Union (International Labour Organisation Work in Fishing Convention) (Medical Examination) Regulations 2020 (S.I. No. 266 of 2020).

Recipients:

Recipients of this data are the Marine Survey Office (MSO), General Practitioners (GP), course providers and examiners.

Transferred outside the EU/EEA and countries with which there is no adequacy agreement*

The personal information you provide in this form is not transferred outside the EU/EEA.

Retention Period

The data collected for this purpose will be held by the Department only as long as there is a business need to do so in line with the purpose(s) for which the personal data was collected. After this time, it will be marked for destruction and will be destroyed in line with internal guidelines or guidelines for destruction received from the National Archives Office or associated permission received from them or in line with other statutory requirements for destruction.

Data Provision – Statutory Obligation

The personal data provided for this purpose is being requested under the requirements of S.I. No. 242/2014 - European Union (Training, Certification and Watchkeeping for Seafarers) Regulations 2014, Merchant Shipping (Medical Examinations) Regulations 2014 and European Union (International Labour Organisation Work in Fishing Convention) (Medical Examination) Regulations 2020 (S.I. No. 266 of 2020). If the information requested is not provided, your application will not go any further in the process.

Automated Decision Making

Automated decision making is not part of the processing of the personal data included in Seafarers Information System (SIS).

Information from a third party

Personal data is obtained from the Maritime Colleges and from GPs in line with this Department's requirement to ensure seafarers are complying with their obligations as previously outlined.
