Background

The quarterly statistical report provides summary information on Income and Expenditure as well as total recipients of the main schemes administered by the Department of Social Protection.

The quarters referenced in this report cover the following periods

	Period
Quarter 1	January 1st - March 31st
Quarter 2	April 1st - June 30th
Quarter 3	July 1st - September 30th
Quarter 4	October 1st - December 31st

These statistics may be subject to revision and should be considered as provisional.




Overall Expenditure

Figure 1: Expenditure (€m) by quarter



- The overall expenditure of the Department of Social Protection for 2021 was €30.3 billion. This was €193 million, or 1%, lower than in 2020.
- The total expenditure for the Department in Quarter 4 2021 was €7.1 billion, around €71 million less compared to Quarter 3 2021, and €1.1 billion less compared to the same quarter in 2020.
- Expenditure on Social Assistance schemes between January and December 2021 was an estimated €15.4 billion, a decrease of -6% or €964 million compared to the same period last year.
- Expenditure on schemes financed from Social Insurance between January and December 2021 was an estimated €14.9 billion, an increase of €771 million or 5% compared to the same period last year due to the Pandemic Unemployment Payment and Enhanced Illness Benefit schemes.
- The Social Insurance Fund (SIF) recorded a current account surplus of €59 million for Quarter 4 2021. As a result, the SIF recorded a deficit of €3 billion for the 12 months of 2021, of which €2.6 billion in Exchequer subvention was required.

Figure 2: Quarterly Social Insurance Fund Income and Expenditure (€m)







Programme Expenditure

- Expenditure on Working Age Income Support payments for the full year 2021 was €7.2 billion, a decrease of €1.1 billion (13%) compared to the same period in 2020.
- Spending on Working Age Employment Support schemes was recorded at €5.2 billion to the end of December 2021, a year-on-year increase of €454 million or 10%. This is due primarily to costs associated with the Employee Wage Subsidy Scheme.
- Child related payments amounted to €2.6 billion for this year, resulting in a slight decrease of 2% or €49 million from the same period last year.

- Pension payments saw an annual increase of €451 million, or 5%, with expenditure to the end of Quarter 4 2021 estimated at €8.9 billion.
- From January to December 2021, €8.7 billion has been paid on Covid-19-related supports, of which €1.3 billion was expended in the fourth quarter of 2021.
- The estimated expenditure breakdown of the main Covid-19 related supports for the full 12 months of 2021 was as follows; Pandemic Unemployment Payment (€4billion), Employment Wage Subsidy Scheme (€4.6 billion), and Enhanced Illness Benefit (€106 million).

Pensions

- Some 692,813 people received payments across the main Pension schemes in Quarter 4 2021, a year-on-year increase of 3% (20,037) compared to Quarter 4 2020.
- The main increase in pension related payments occurred for the State Pension Contributory (SPC) scheme, which recorded a 4% year-on-year growth in recipients, from 451,910 to 470,814,
- The mean rate of payment for all Pensions schemes was €262 per week. Across the schemes the average weekly payment was €271 for SPC, €242 for SPNC, and €274 for WCP.
- Around 60% of people on the SPC were male, while females accounted for 60% of SPNC recipients and 85% of WCP recipients.

Figure 4: Pension recipients by year and by scheme






Figure 5: Pension recipients this quarter by sex and by scheme






Working Age Income Supports

- A total of 111,337 people received at least one Pandemic Unemployment Payment (PUP) in Quarter 4 2021. This was 113,779 or 51%, lower than Quarter 3 2021, and down by 77% compared to the 493,868 people who received this payment in Quarter 4 2020.
- The average weekly payment was €266 for PUP, €236 for Jobseeker's Allowance and €197 for Jobseeker's Benefit in Quarter 4 2021.

- The total number of people in receipt of Jobseeker's Benefit across Quarter 4 2021 was 60,490, an annual decrease of 2%, while the numbers availing of Jobseeker's Allowance totalled 149,956, a 12% decrease compared to one year previously.
- There were 32,704 recipients of Maternity Benefit and 8,410 recipients of Paternity Benefit in the quarter, while 17,191 people received payments from the Parent's Benefit scheme.

Figure 7: Maternity, Paternity, and Parent's Benefit recipients








Illness, Disability, and Caring


- The number of people paid Illness Benefit in Quarter 4 2021 was 165,871, an increase of 38% from the previous quarter, and up by almost 52% when compared to Quarter 4 2020.
- Of those in receipt of Illness Benefit, 64,696 people received the Enhanced Illness Benefit (EIB) in the last quarter. This was an increase of 35,882 or 126%, from the 28,814 people who received EIB in Quarter 3 2021.

- There were 157,448 people in receipt of Disability Allowance in the fourth quarter of 2021, an increase of 3,188 (2%) on the year before. The average weekly payment received on this scheme was €240.
- The total number of people receiving Carer's payments in Quarter 4 2021 was 97,118, a rise of 2,320 (3%) from Quarter 4 2020. On average, Carer's Allowance recipients received a payment of €212, while Carer's Benefit recipients received a payment of €269.

Children and Supplementary Payments

- In the last quarter a total of 639,125 families received Child Benefit payments, up by 1,814 compared to Quarter 4 2020.
- Around 98% (629,142) of recipients of Child Benefit were female, while 2% (9,983) were male.
- Year-on-year, the number of people in receipt of the Working Family Payment decreased by 4% to 49,859. The average payment for this scheme was €141.
- The number of recipients of Rent Supplement in Quarter 4 2021 totalled 14,420, a 30% decrease (-6,049) compared to the fourth quarter of 2020.
- There were 220,355 people receiving direct payments from the Household Benefits Package^[1] in the quarter, representing a yearon-year increase of 25,363 or 13%.

Figure 10: Annual change (%) in Rent Supplement recipients by county



Notes

Methodology and quality considerations

The expenditure details in this report are based on estimates. The finalised expenditure information can be viewed in the latest Appropriation Accounts for Vote 37¹, or the latest Annual Statistics Report². Note that the estimated expenditure figures in this report may not add up exactly due to rounding.

When comparing to a previous quarter or previous year, the comparison can sometimes be impacted by the number of pay days that fall in a particular quarter. This may account for skews in expenditure and/or recipient totals in certain quarter periods.

The recipient totals were extracted from the Department's administrative systems, and include people who were issued at least one payment for a particular scheme in a given quarter. In the majority of cases the date in which the payment was made reflects the entitlement period .i.e. when the payment was issued the recipient's claim was open. However payments can be issued in respect to different entitlement periods (arrears payments). The figures produced in this report are calculated with reference to the date the payment was issued, and are therefore inclusive of arrears payments. Note that a person can be in receipt of payment for more than one scheme.

The recipient figures quoted in the Annual Statistics report are not directly comparable to the numbers shown in this publication. The Annual Statistics report counts only those awarded and in receipt of payment at a point in time (December 31st) to ensure comparability with a series of statistical reports dating back to 1983.

Glossary of Terms

Recipient: A person receiving at least one Social Welfare payment in a given quarter period.

Social Assistance: payments funded from voted expenditure, which cover people who do not have sufficient PRSI contributions to qualify for the equivalent social insurance payments, or where entitlement to the social insurance payment has expired. These payments are typically means-tested.

Social Insurance Fund: a current account and an investment account managed by the Minister for Social Protection and the Minister for Finance, respectively. The current account consists of monies collected from people in employment, self-employment, and employer contributions. This money is then used to fund social insurance payments.

Open Data

Each report in this series will be available in formats consistent with the Open Data Technical Framework³. Any open data produced by the Department will be accessed through the National Open Data portal at: https://data.gov.ie/

Revisions

Revisions may occur as a result of changes in methodology, an update to a series or errors in the original data. Any significant revisions will be footnoted in the report and will describe the reason for the change and its impact on comparability (.i.e. with other schemes or over time).
