The Co-Chairs and Secretariat wish to acknowledge with thanks all the preparatory work undertaken by the Round Table members since the last meeting (29th November 2021), which has included:

- Review of the initial draft commitments circulated.
- Review 19 submissions received in the public call.
- Undertaken a 5 step evaluation of the 19 submissions received in the public call which was shared with the Secretariat for collation.

The Co-Chairs also acknowledged with thanks the work of the Secretariat and Helen Newman (facilitator) in their preparations for today's meeting.

A special welcome was extended to Shana, joining her 1st meeting, and [Barry Vaughan](#), who is the newly nominated Department of the Taoiseach Round Table member.

Round Table operation procedural note: The Secretariat wishes to bring to the Co-Chairs attention that the terms of reference, require co-representation on the Round Table, to a maximum 6 members for both Public Sector and Civil Society. With Barry Vaughan (Department of the Taoiseach) joining as a Round Table member, to ensure ongoing compliance with the terms of reference, Philip McGrath will revert to his original role of Co-Chair / Secretariat role only.

Outcome:

1. Update since last meeting (29th November 2021)

Round Table members agreed the (i) further milestones achieved since the last meeting [slides 4-5]; (ii) status update on the previous meeting next steps [slides 6-8] and the **EMBARGO: International award remains confidential until announced by the Minister**

2. To make decisions on proposals to be included in Ireland's Open Government National Action Plan.

2.1 The Round Table members agreed that three sub-groups would be established to progress the proposals 12, 26 and 15/20 (noting proposal 17 insights).

2.2 The Round Table members noted that the DPER Open Data team and the Secretariat would be bringing a draft commitment to the next meeting for their consideration.

3. Break out discussion

Following the presentation on the overview of the selection process and key findings, and mindful of the considerable breadth and depth included, Members were asked to consider the content of the presentation and of the materials circulated in advance of the Meeting and bring back any questions and/or observations to the plenary.

Leaders shared the feedback with the Round Table in plenary session. The feedback shared were broadly in three themes:

- 3.1 Subgroup remit; task; authority and process queries;
- 3.2 To ensure that ‘respect’ was central to the reasoned decision that proposers would receive.
- 3.3 Speaks to the work in the Programme for Government and national strategies (particularly for sub-group remit).

In addition the following specific feedback was noted:

- The analysis provided by Secretariat was praised and valued by the members.
- The submission process, when reviewed, will benefit from greater clarity on the selection criteria used to assess proposals by the Round Table.
- The challenge of balancing the need for long-term structural change with the shorter timeframe of the National Action Plans was noted.
- Matching funding for projects proposal was raised.
- The importance of ensuring proposals took cognisance of and where appropriate were aligned with existing processes was noted.
- The need for a sponsoring/supporting government department was questioned but no conclusion reached.

- Members requested clarity on the process for progressing the proposal to be included in the Third National Action Plan by subgroups and the road map for the next period. Specifically, members would like guidance to ensure coherence of approach and methodology, clarity on composition, remit, authority and focus for the subgroups.

4. To make decisions on proposals that will not be included and how the rationale for decisions will be communicated.

The Secretariat presented the powerpoint presentation to the Round Table members with a proposed ‘reasoned decision’ for each proposal on the basis of the Round Table members’ evaluation and intelligence gathered by the Secretariat on each proposal.

The Round Table members voted on each proposal¹. The results of the vote to adopt the ‘reasoned decision’ in the presentation was:

Agree	Reasoned decision for the proposals

Also, the Secretariat noted the 2 observations shared bilaterally by Round Table members and will revert bilaterally re inputting to the Freedom of Information Act review.

Round Table members agreed that the Secretariat would progress the drafting of a ‘reasoned decision’ to be finalised with the Co-Chairs to circulate to proposers in early February in advance of the next meeting.

5. To agree nominations for sub-Committees to progress proposals to Draft Commitments

Appendix 1

Secretariat responses to the breakout session feedback.

The Secretariat welcomes the feedback shared, which evidences the high level of engagement of Round Table members.

The Secretariat notes the feedback that the submission process would benefit from greater clarity on the selection criteria used to assess proposals by the Round Table.

- The Secretariat would welcome specific recommendations to enhance the effectiveness and efficiency of the 'pilot' submission evaluation model. In particular, a deeper understanding of how Round Table members should rank submissions.
- The Secretariat will reach out to Open Government Partnership to seek additional guidance on Step 6 indicator and will request that the international reviewer provides additional detail to the Round Table on this indicator in their 1st report.

The Secretariat invites sub-group leaders and members to review the sub-group guidance shared which seeks to address the sub-group related queries raised. *Refer appendix 2.*

- The Secretariat can provide clarity at this stage on the following:
 - Focus and membership of the sub-group: The focus, the sub-group leaders and current sub-group members are outlined at 2.1.
 - Remit of the sub-groups: Is to progress the shaping of the proposals into draft commitment in line with the Open Government Partnership requirements for the consideration of the Round Table. The draft commitment must be clear, specific and with SMART milestones that those who must implement support; that enable the Round Table to monitor implementation and that the Open Government Partnership reviewer can independently and verifiably measure (refer to the 3 draft commitments circulated in December 2021).
 - Authority of the sub-group: This derives from the Open Government Round Table which, while supported by membership of Open Government Partnership; a Programme for Government commitment; and Ministers statement in the Dáil, enter the art of persuasive engagement as there is no authority to direct an action to be taken.
 - Coherency of approach: As the sub-groups differ considerably in terms of their starting points and the breath of the remit, their journey to deliver the output from Round Table consideration will differ in terms of approach and timeframe. The Secretariat will share some initial questions for the consideration on the sub-group based on the intelligence gathered to date.
- The Secretariat has shared the intelligence gathered on the potential relevant **Programme for Government commitments; national strategies and potential pathways**, including Civic Forum which is to be established in 2022 with the purpose of being the point of engagement between Government and Civil Society. *Refer to appendix 2.*
- The Secretariat notes the Round Table members' feedback on the **challenge of balancing the need for long-term structural change with the shorter timeframe of the National Action Plan**. The Open Government Partnership (OGP) process has the potential to enable the Round Table to achieve long terms goals through the successful implementation of incremental short term milestones. There is an opportunity to explore this theory as the Civic Participation sub-group explores how to shape the medium /

longer term proposals into a series of milestones, some of which might be reflected as commitment(s) in the 3rd National Action Plan and subsequent commitment(s) in the 4th National Action Plan the process for which will commence in November / December 2022.

- The sub-group leaders are invited to arrange a bilateral call with the Secretariat (if required).

Appendix 2

Sub-group guidance

Purpose of subcommittee: to work together in accordance with OGP guidance to produce a completed SMART commitment template agreed by sub-group members for the consideration of the Round Table for the Open Government National Action Plan.

Initial tasks:

- ✓ Choose a single person to be a contact point.
- Determine governance and meeting schedule.

Ongoing tasks:

- Share sub-group output with the Secretariat by timeline for Co-Chairs/Round Table circulation.
- Sub-group update/feedback will be a standing item on each Round Table agenda.
- Consult with and keep Secretariat informed of progress and issues.

Secretariat guidance applicable to all the subgroups:

The Round Table is on a journey in shaping its processes. These sub-groups are effectively ‘pilots’. Many Round Table members will bring considerable experience into this process, thus below is a guide.

General:

- The commitment template should help to focus the discussions and identify what discussion outcomes are required.
- The strategy of capturing other new ideas and insights arising separately ensures a pipeline for the future discussion, while maintaining the focus on the current output and delivery timelines.

What	Complete an agreed draft commitment template (attached) for the consideration of the Round Table.
How	Sub-groups differ and will navigate their own path guided by the values which Round Table members have flagged - active listening, respect and impactful deliverable outcomes.
What does ‘good’ look like.	Consider the draft commitments circulated in December 2021 as benchmark and to ensure consistency.
When	(i) Initial meeting week commencing Monday 24 th January 2022. (ii) Sub-groups to organise / allocate work as deemed appropriate.

	(iii) Revised draft commitment and record keeping output to be shared with the Secretariat by 2 nd February 2022.
Record keeping	Sub-group leads are requested to keep high level note which would ensure open and transparent perspective of how the commitment was shaped. For example: Note each meeting (date, attendees etc.); agenda; meeting outcomes and actions arising. One document with all the detail to be shared with the Secretariat by 2 nd February 2022.

Please note that the Secretariat is very open and keen for sub-group leads to share any additional insights bi-laterally (cc'ing the Secretariat) to be agile in shaping a consistent productive sub-group 'way of working'.

Proposal 12: Electoral Reform:

Potentially relevant Programme for Government commitment, noting that the proposal flagged the enactment of the Electoral Reform Bill 2020 as a key milestone.

It is on the list of priority legislation for publication in the autumn legislation programme. Pre-Legislative Scrutiny of the General Scheme of the Electoral Reform Bill 2020 was completed and report published in August 2021, following the publication of the general scheme of the electoral reform bill in January 2021.

- (i) Discuss the relevance of the Electoral Reform legislation to the proposal?
- (ii) Share an update on the current status and timelines for the Electoral Reform legislation?
- (iii) Explore, identify and capture the aspects of the proposal where there is agreement with implementation milestones deliverable by August 2023. *As there are considerable challenges in timing the passage of legislation and ongoing monitoring of the commitments, the sub-group should be mindful that the milestones timelines are deliverable rather than aspiration.*

- (iv) Note, list and initially park any areas of difference, emerging to be reflected upon once all the areas of agreement have been reflected in the draft commitment template.
- (v) Explore, identify and capture how any areas of difference were addressed and/or can't be addressed in the draft commitment.

Proposal 26: Public Participation Network (PPN) barriers

The proposal appears to align with the ongoing Public Participation Network review, pursuant to objective 7, 'Sustainable, Inclusive and Empowered Communities - 5 year strategy 2019-2024', Department of Rural & Community Development (DRCD).

statutory instrument or a circular and (ii) potential joint ownership by DRCD (Community & Voluntary sector) and DHLGH (Local Government aspect).
