
OGP Members

Participation

- Embrace a spirit of sharing
- Talk to and include the people you don't know
- Ask Questions

Respect

- Respect schedules
- Listen carefully
- Manage debate, focus on the goals of the group

Inclusion

- The 'rule of 1' make one point, let others speak
- The Rule of 'n' In a group of 'n' people, speak "1/nth" of the time
- Keep a check on technical language, jargon

Ways of working



A safe environment

- Avoid language that will make others uncomfortable
- Privacy and discretion talk to the source before you share or repeat non-public information. Respect privacy of participants
- Harassment of any sort will not be tolerated and should/will be addressed immediately.

Ways of working - Lobbying



- Am I lobbying? Am I being lobbied?
 - Lobbying Commission's 'three step test'.
- Obligation is on person lobbying to register, submit returns.
- Obligation is on public official to keep proper records of their participation.
- Lobbying.ie has further information in a jargon-free format.

Are you one of the following?

- An **employer** with more than 10 employees where the communications are made on your behalf
- A **representative body** with at least one employee communicating on behalf of its members and the communication is made by a paid employee or office holder of the body
- An **advocacy body** with at least one employee that exists primarily to take up particular issues and a paid employee or office holder of the body is communicating on such issues
- A **third party** being paid to communicate on behalf of a client who fits into one of the preceding three categories
- Any **person** communicating about the <u>development or zoning of land</u>

2. Are you communicating about a relevant matter?

A relevant matter is one which relates to:

- The initiation, development or modification of any public policy or of any public programme
- The preparation or amendment of any law
- The award of any grant, loan, contract, or of any licence or other authorisation involving public funds

other than the implementation of any such policy, programme, enactment or award or any matter of a technical nature only.

There are excepted and exempted communications.

3. Are you communicating either directly or indirectly with a Designated Public Official?

Secretariat proposals re Subgroup output (1/2)



Secretariat proposed that the Round Table:

- (1) Agree with the recommendation of the Subgroup on Section 22 of Electoral Act that a commitment is not possible for the 3rd National Action Plan and that as further clarity will emerge (both the civil society campaign and the legislative process) that this matter be considered again for the 4th National Action Plan.
- (2) Note that the Subgroup on Public Participation Networks/Local Authority wishes to have a commitment in the 3rd National Action Plan, but can't agree wording. There is a deliberative process for the Structural Review of PPN, which is considering many of the issues raised. The Round Table is asked to consider and decide whether to include a commitment and the Secretariat flags that the ongoing monitoring may assist in bridging this gap.

Secretariat proposals re Subgroup output (2/2)



Secretariat proposed that the Round Table:

(3) Note the update with further clarification reached by the Subgroup on Civic Participation, on both the ambition, its pathway and this first commitment. The Round Table is asked to support the subgroup's recommendation that it progresses this work to leverage this update to draft a first commitment for the 3rd National Action Plan.



DRAFT Round Table meeting outcomes (1/2)



- (1) The Round Table agreed that below had been noted in advance of the meeting.
 - i. Round Table subgroup updates (email attachments).
 - ii. Proposed agenda (slide 3).
 - iii. Further milestones achieved since January 2022 (slides 4).
 - iv. Draft Round Table 'ways of working (slides 5 11).

The Round Table decided:

- (2) To accept the 'ways of working' as presented.
- (3) To agree with the recommendation of the Subgroup on Section 22 of Electoral Act that a commitment is not possible for the 3rd National Action Plan and that as further clarity will emerge (both the civil society campaign and the legislative process) that this matter be considered again for the 4th National Action Plan.
- (4) To agree the recommendation of Subgroup on Civil Participation that it progress its work to draft a first commitment (template format) for the consideration of the Round Table at its next meeting 16th March 2022.
- (5) As the Round Table was unable to reach a decision at the plenary meeting, that the Secretariat would arrange that a vote for Round Table members to reach a decision in relation to the deliberations of the PPN subgroup and to capture any additional guidance to bridge the gap which would be put to the subgroup members to vote upon as to whether this guidance would result in subgroup agreement being reached in a final meeting.
- (6) For the purpose of the OGP review that members' contact details etc. could be shared by the Secretariat.

DRAFT Round Table meeting outcomes (2/2)



The Co-Chairs agreed:

(7) To discuss the Civil Society Round Table members views on the process to date (circulated 15th Feb 2022). The Public Sector Co-Chair to seek Public Sector members perspective in advance, to share at the meeting.

The Secretariat advised that:

- (i) Ireland had emerged from the Open Government Partnership procedural process (as circulated 10 Feb 2022)
- (ii) The Open Government Partnership Independent Review team had commenced their review, earlier than the understood Q3 timeline. The Secretariat is in ongoing contact to determine what is involved in the process.
- (iii) The next meeting Wednesday 16th March 2022 at 10:00 (as circulated).
- (iv) Secretariat was hoping to bring a proposal on how Round Table members might integrate consideration of wider OGP themes into the meetings.
- (v) The Round Table members share their suggestions on how to increase the inclusiveness and diversity of the OGP engagement (Meeting 1) and how to enhance the submission evaluation process (meeting 2), to enable progress to be made.

- √ Public call for submissions for the next and future national action plans...
 (Reach approx. 30,000 via social media & email campaign 202 clicks 18 submissions 41% unconnected & 59% connected, 41% from/linked to Round Table members)
- $\sqrt{}$ Public sector Round Table members nominated by Secretary Generals.
