To all Ports, Port Companies, Harbour Masters, Agents, Ships Masters and Officers, Local Authorities and Ship Inspectors from the Department of Agriculture and Food

EUROPEAN COMMUNITIES (PORT RECEPTION FACILITIES FOR SHIP GENERATED WASTE AND CARGO RESIDUES) REGULATIONS 2003

GENERAL

This is to advise that the Minister for Communications, Marine and Natural Resources has signed the above Regulations (Statutory Instrument No. 117 of 2003), which gives effect to Directive 2000/59/EC regarding Port Reception Facilities for Ship Generated Waste and Cargo Residues. The Regulations are effective from the 20th March 2003.

A copy of Statutory Instrument No. 117 of 2003 is available from the Government Publications Office, Molesworth Street, Dublin 2.

The Regulations require Port Authorities (including Local Authorities) and Harbour Masters in Fishery Harbour Centres to:

- develop and implement an appropriate waste reception and handling plan (see attachment Schedule 2 (3 Pages)) for each port following consultations with the relevant parties, in particular with port users or their representatives, having regard to their obligations under the Waste Managements Acts and the requirements of Articles 4, 6, 7, 10 and 12 of the Directive (Regulations also provide for groups of ports to combine for reasons of efficiency in preparing plans provided that the need for, and availability of, reception facilities is specified in respect of each port);
- furnish to the Department on an annual basis or as may be requested in such form as the Minister shall determine a status report;
- furnish information in relation to notifications from Ships' Masters to the Department on request;
- take all necessary measures to prevent marine pollution, having consulted with the Department, if necessary by requiring the ship to deliver its waste before departure from the port;

 cover the costs of port reception facilities for ship-generated waste, including the treatment and disposal of the waste, through the collection of a fee from ships.

As regards Ships' Masters:

- The Master, of a ship, bound for a port located in the State is obliged to complete the form set out in Schedule I of the Regulations (see attachment Schedule 1 (3 pages)) and notify that information to the appropriate local competent authority at least 24 hours prior to arrival in a port or at the latest on departure from the previous port if the duration of the voyage is less than 24 hours;
- The Master of a ship must deliver the ship generated waste and cargo residues before leaving a port unless it follows that there is enough capacity left on the ship to hold the existing waste plus the waste that will be accumulated until the ship reaches the next port of delivery.

Definitions:

Local Competent Authorities means -

- (1) in the case of a Fishery Harbour Centre, the Harbour Master or such other person as the Minister may designate from time to time; and
- (2) in the case of any other port, the Port Authority concerned.

Ship means a seagoing vessel of any type whatsoever operating in the marine environment and includes hydrofoil boats, air cushion vehicles, submersibles and floating craft.

Department means Department of Communications, Marine and Natural Resources.

Exemptions

- (1) Fishing vessels are exempt from the notification requirement
- (2) Scheduled traffic with regular and frequent port calls can apply for an exemption to the local competent authority.

Requirements for Waste Reception and Handling Plans in Ports

ANNEX I OF DIRECTIVE

Plans shall cover all types of ship-generated waste and cargo residues originating from ships normally visiting the port and shall be developed according to the size of the port and the types of ships calling at that port.

The following elements shall be addressed in the plans:

- an assessment of the need for waste reception facilities, in light of the need of the ships normally visiting the port;
- a description of the type and capacity of waste reception facilities;
- a detailed description of the procedures for the reception and collection of ship-generated waste and cargo residues;
- description of the charging system;
- procedures for reporting alleged inadequacies of waste reception facilities;
- procedures for ongoing consultations with port users, waste contractors,
 terminal operators and other interested parties; and
- type and quantities of ship-generated waste and cargo residues received and handled.

In addition, the plans should include:

- a summary of relevant legislation and formalities for delivery;
- identification of a person or persons to be responsible for the implementation of the plan;
- a description of the pre-treatment equipment and processes in the port, if any;
- a description of methods of recording actual use of the waste reception facilities;
- a description of methods of recording amounts of ship-generated waste and cargo residues received; and
- a description of how the ship-generated waste and cargo residues are disposed of.

The procedures for reception, collection, storage, treatment and disposal should conform in all respects to an environmental management scheme suitable for the progressive reduction of the environmental impact of these activities. Such conformity is presumed if the procedures are in compliance with the Council Regulation (EEC) No 1836/93 of 29 June 1993⁽¹⁾ allowing voluntary participation by companies in the industrial sector in a Community eco-management and audit scheme.

Information to be made available to all port users:

- brief reference to fundamental importance of proper delivery of ship-generated waste and cargo residues;
- location of waste reception facilities applicable to each berth with diagram or map;
- list of ship-generated waste and cargo residues normally dealt with;
- list of contact points, the operators and the services offered;
- description of procedures for delivery;
- description of charging system; and
- procedures for reporting alleged inadequacies of port waste reception facilities.
