



# Draft Regulations for Providers of Home Support Services: Public Consultation Survey

## **Public Consultation on Draft Regulations for Home Support**

The Department of Health has launched a public consultation on draft regulations for providers of home support services. These regulations set out the minimum requirements that public, private, and not-for-profit providers of home support services will be required to meet to obtain a license to operate.

## How to make a response?

You can make your views known by completing this survey. This survey consists of 3 sections, with 14 questions in total. Section 1 asks you to provide information about yourself. Section 2 asks you to provide general feedback on the draft regulations. Finally, Section 3 invites you to provide focused feedback on the different parts of the draft regulations.

Only Section 1 of the survey is mandatory. This allows you to give as much or as little feedback as you would like. Where the survey gives you the opportunity to provide written feedback, please be aware that this is limited to around 200 words per answer.
