Notice to all Shipowners, Fishing Vessel Owners, Agents, Shipmasters, Skippers, Fishers, Yachtsmen and Seafarers

# Arklow Long Sea Outfall Project Commencement of Pipe Installation

## 1. Notice of Activity

Further to Marine Notice No. 25 of 2022, the Department of Transport has been advised that Van Oord Ireland are due to commence installation of a 927m long pipeline. The installation works will commence on Monday 20<sup>th</sup> June and are expected to continue until early August 2022. All operations are weather dependent.

During operations, three HDPE pipelines, each 309m in length, will be moored off alongside the North Quay in Arklow.

During pipe installation works, the harbour entrance will have limited availability to other traffic for approx. 72 hours from Monday 20<sup>th</sup> June 2022.

#### 2. Location of Activity

The working area of operations will be at the coordinates indicated in the Table below. An indicative chartlet is provided in Appendix 1.

### 3. Details of Vessels

The operations will be conducted by the following vessels:

- "RAZENDE BOL" Backhoe dredger (call sign PFSD),
- "AMS RETRIVER" Shoal buster (call sign MEHI8),

- "HUSKY" Tug (call sign 2EQI7),
- "ROS AINE" Landing craft (call sign EI-ZG-5), and
- "FASTNET SOUND" Multicat Int. LL (UK & IR) (call sign MHXQ5).

Note that all vessels will keep a VHF radio listening watch on CH. 16.
