Data Subject Rights

Specific Purpose:

Form: : IMO FAL Form 6 – Passenger List is used where a shipping vessel arrives in and/or departs from a port in the State. Certain personal data is needed to process this form correctly in adherence with S.I. No. 166/2012 - European Union (Reporting Formalities for Ships) Regulations 2012 as amended by S.I. No. 678/2019 - European Union (Reporting Formalities for Ships) (Amendment) Regulations 2019. The regulation implement and Directive 2010/65/EU of 20 October 2010 as amended by Directive (EU) 2017/2109 of 15 November 2017.

Legal Basis

There is a legal basis for the collection and processing of the personal data in Form: IMO FAL Form 6 – Passenger List. It is contained in S.I. No. 166/2012 - European Union (Reporting Formalities for Ships) Regulations 2012 as amended by S.I. No. 678/2019 - European Union (Reporting Formalities for Ships) (Amendment) Regulations 2019.

Recipients:

Recipients of this data are the Marine Survey Office (MSO) and its administrative staff, Revenue, Irish Coast Guard, Department of Defence, Health Service Executive, Central Statistics Office and Commissioners of Irish Lights.

Transferred outside the EU/EEA and countries with which there is no adequacy agreement*

The personal information you provide in this form is not transferred outside the EU/EEA.

Retention Period

The data collected for this purpose will be held by the Department only as long as there is a business need to do so in line with the purpose(s) for which the personal data was collected. After this time, it will be marked for destruction and will be destroyed in line with internal guidelines or guidelines for destruction received from the National Archives Office or associated permission received from them or in line with other statutory requirements for destruction.

Data Provision – Statutory Obligation

The personal data provided for this purpose is being requested under the requirements of S.I. No. 166/2012 - European Union (Reporting Formalities for Ships) Regulations 2012 as amended by S.I. No. 678/2019 - European Union (Reporting Formalities for Ships) (Amendment) Regulations 2019. If the information requested in this form is not provided, your application will not go any further in the process.

Automated Decision Making

Automated decision making is not part of the processing of the personal data included in Form: IMO FAL Form 6 – Passenger List.

Information from a third party

Your personal data in relation to IMO FAL Form 6 – Passenger List is obtained from shipping agents acting on behalf of shipping operators and is submitted to this department using a web based interface in Safe Seas Ireland (SSI) in line with this Department's requirement to ensure vessels are complying with their obligations as previously outlined.
