

## Marine Notice No. 54 of 2022

Notice to all Shipowners, Fishing Vessel Owners, Agents, Shipmasters, Skippers, Fishers, Yachtsmen and Seafarers

### HAVHINGSTEN FIBRE OPTIC TELECOMMUNICATION CABLE SYSTEM

#### 1. Surface laid/exposed cable at Loughshinny Harbour

Earlier this year, Alcatel Submarine Networks (ASN) was contracted to carry out construction activities for the Havhingsten cable system. Those works are now complete and this notice is issued to inform mariners of the as-laid shallow burial areas and short sections of surface laid/exposed cable at Loughshinny Harbour in Irish territorial waters in the Irish Sea (Photo at Appendix 1). The cable is double armoured (38mm in diameter) with articulated pipe protection. The areas of shallow burial and surface laid cable are due to hard ground or rock where cable burial to the target depth was not possible. No further burial or protection works are planned for the Havhingsten cable at this time. Please refer to the Table below for detailed co-ordinates.

It is requested that all vessels operating in this area keep their distance and avoid any works near the cable position. The Admiralty Mariner's Handbook (NP100) advises: *"In order to minimize the risk of such damage as much as possible, vessels should avoid any such activity at a minimum distance of 0.25 nautical mile, on either side of submarine cables."*

**Note**: Shallow burial is defined as a burial depth of less than 0.2m; all areas are located in less than 3m water depth.
