Table 1 – Analysis of COVID-19 Enhanced Illness Benefit

To date 554,538 people have been medically certified for receipt of a Covid-19 related Illness Benefit payment, of whom 297,289 are female and 257,249 are male.

Some 2,665 people are currently in receipt of an Enhanced Illness Benefit payment.
