

Marine Notice No. 71 of 2022

Notice to all Shipowners, Fishing Vessel Owners, Agents, Shipmasters, Skippers, Fishers, Yachtsmen and Seafarers

Oriel Wind Farm - Unmanned Surface Vessel Survey - Trial operations in the Irish Sea Approximately 22km off the coast of Dundalk, Co Louth

1. Notice of Activity

The Department of Transport has been advised that trial operations of remotely piloted Uncrewed Surface Vessels (USVs) are planned to take place in the Dundalk Bay area during October and November 2022. Operations are planned to take place from **20th October for approximately 4 weeks**, subject to weather and operational constraints.

The vessels will be engaged in survey activities associated with the investigation of a site for development of the Oriel Wind Farm in the Irish Sea approximately 22km off the coast of Dundalk, Co Louth.

This is a non-invasive survey, and no contact with the seabed or any other infrastructure is planned during survey operations.

2. Location of Activity

The USVs will transit from/to Carlingford Lough to the area of operation, bounded by the coordinates given in the table below. Further location information is available in Appendix 1.

3. Details of Vessels

Two of the below-listed vessels will be used for the operations. These are XO-450 type USVs with the characteristics as shown below in Appendix 2.

- > X06 Uncrewed (call sign MGMK5);
- > X17 Uncrewed (call sign MKMB4);
- > X18 Uncrewed (call sign MKMB6);
- > X20 Uncrewed (callsign MLUK4);
- > X21 Uncrewed (call sign MLUL2);
- > X22 uncrewed (call sign MMIM7).

The USV sends real time images and situational awareness data over satellite to a team of operators keeping watch and controlling the vessel remotely 24/7.

4. Safety Precautions

Although the vessel is uncrewed, it is monitored and controlled throughout the 24-hour operations, piloted remotely using 360-degree cameras and other navigational aids.

The USV is equipped with the following to make it conspicuous to other marine traffic:

- AIS,
- Navigation Lights & Sound Signal,
- Active Radar Reflector, and
- Superstructure Painted Yellow.

All vessels operating within this area are requested to avoid contact with the vessel and be aware of the operational area during this period.

A Radio Navigation Warning will be in place during operations.


