INTRODUCTION

SAR STRUCTURE & OPERATION

Irish Coast Guard (IRCG)

IRCG has as part of its structure, a Marine Rescue Co-ordination Centre (MRCC) at Dublin and two MRSCs located at Malin Head and Valentia. See MAP at page 7 for areas of SAR responsibility.

The Irish Aviation Authority, on behalf of the Department of Transport, operates an Aviation Rescue Co-ordination Centre (ARCC) at Shannon Air Traffic Control Centre (ATCC) and a Rescue Sub-Centre (ARSC) at Dublin Air Traffic Control Centre.

INTRODUCTION ARCC and ARSC

1. Structure & Operation of ARCC

1.1 The Department of Transport while retaining overall responsibility for Aviation Search and Rescue Operations (ICAO Annex 12) has determined that the Irish Aviation Authority shall operate the ARCC requirements of ICAO Annex 12 as agent of the Department of Transport (Ref. ICAO Annex 12; S.I. No. 171 of 1995; S.I. No. 172 of 1995).

2. Aviation Search & Rescue Region

2.1 The Aviation Search and Rescue Region covers an area coincident with the Shannon FIR/UIR.

3. Irish Aviation Authority Aviation Rescue Coordination Structure

3.1 The Irish Aviation Authority has established an Aviation Rescue Co-ordination Centre at Shannon Air Traffic Control Centre.



INTRODUCTION MRCC/MRSC

1. Structure & Operations of Irish Coast Guard MRCC/MRSC

1.1 The Department of Transport has responsibility for co-ordination of Maritime Search and Rescue as required by IMO International Convention on Maritime Search & Rescue (Hamburg) 1979 and Safety of Life at Sea (SOLAS) 1974/92.

The Irish Coast Guard (IRCG) is the Division within the Department with delegated responsibility for Maritime Search and Rescue.

2. Maritime Search & Rescue Region

2.1 The Maritime Search & Rescue Region covers an area coincident with the Shannon FIR.

3. The IRCG Co-ordination Structure

3.1 IRCG has established a Marine Rescue Co-ordination Centre (MRCC) at IRCG Headquarters in Leeson Lane, Dublin, and two Marine Rescue Sub Centres (MRSC's) at Malin Head, County Donegal, and Valentia Island, Co. Kerry.


- 1. The Valentia Division encompasses that part of the Irish SRR lying between the littoral area and the SRR boundary from Youghal, County Cork to Slyne Head, Co. Galway. (See attached map p. 8)
- 2. The Malin Head Division encompasses that part of the Irish SRR lying between the littoral area and the SAR boundary from Slyne Head, Co Galway to Inishowen, Co Donegal.
- **3.** Valentia MRSC and Malin Head MRSC have delegated authority to coordinate all IRCG SAR operations in their respective divisional areas of responsibility within the Irish Search and Rescue Region (SRR).
- **4**. Pollution response and salvage and wreck operations will remain with MRCC Dublin.

Section 1

General

- In the event of an aviation emergency over a maritime or littoral area, ARCC/ARSC shall co-ordinate the incident in close liaison with MRCC/MRSC.
- 2. Should an aircraft force land in a maritime area, ARCC/ARSC shall be responsible for determining the initial search area, but co-ordination shall then transfer to MRCC/MRSC with continued close co-operation and back-up services from ARCC/ARSC.
- 3. Copies of relevant parts of operating procedures manual(s) shall be exchanged between IAA and IRCG.
- 4. In the event of an emergency meeting at the Irish Coast Guard Marine Emergency Room, requiring an aviation input, the Head of ARCC Shannon shall decide on the appropriate representation.
- 5. There shall be bi-lateral meetings at managerial level between IAA and IRCG at least on an annual basis.
- 6. Nothing in these procedures shall prevent ARCC/ARSC and MRCC/MRSC operations controllers from agreeing an alternative course of action, should such an alternative be considered more appropriate in the prevailing circumstances.

Routine Communications

- 1. Routine communication shall take place by means of documentary, electronic or verbal transfer.
- 2. ARCC/ARSC shall be included as information addressee in routine SITREPs issued by MRCC/MRSC where the incident may require or include an aviation response.

Section 3

IRCG Helicopters

- 1. IRCG Helicopters as a SAR resource may only be tasked by IRCG.
- 2. ARCC/ARSC may request the use of IRCG helicopters in the case of aviation SAR incidents, by contacting MRCC/MRSC.
- IRCG shall be responsible for maintenance of routine safety checks (i.e. 15 minute reports) with IRCG SAR helicopters both on operational and training missions.
- 4. Should an IRCG helicopter fail to respond to routine safety check procedures, MRCC/MRSC shall immediately inform ARCC/ARSC giving such procedural details of the flight concerned as are necessary for further ARCC action.
- 5. Where 4 above applies ARCC/ARSC shall be responsible for the coordination of the SAR response.
- 6. Where IRCG helicopters are tasked in response to an aviation incident, ARCC/ARSC shall be responsible for initiation of appropriate Air Traffic Services.
- 7. Should an IRCG helicopter force land in a maritime area, ARCC/ARSC shall be responsible for determing the initial search area (except where the location is already known), but co-ordination shall then be transferred to MRCC/MRSC with appropriate back-up services from ARCC/ARSC.

Note: During such an incident, the aircraft may have established two-way communications with the relevant CRS. It may be deemed appropriate to continue such communications arrangements provided appropriate relay procedures with ARCC/ARSC are in place.

Section 4

Aviation Related Services

- 1. Where a maritime incident requires an aviation response, MRCC/MRSC shall liaise directly with agencies which may supply such resources. MRCC/MRSC shall be responsible for the provision of refuelling, accommodation, security and any additional related services.
- 2. Where aviation resources are required in response to an aviation incident, ARCC/ARSC shall be responsible for the provision of resources and any such support services as are required.
- 3. Where airport facilities for maritime related incidents are required outside the normal hours of availability of such facilities, MRCC shall be responsible for the call-out of such services as required.

Section 5

Maritime SAR Services

- 1. Maritime SAR services shall remain, at all times, under the operational direction of IRCG.
- 2. Where an aviation incident requires a maritime response ARCC/ARSC shall be responsible for requesting from MRCC/MRSC such maritime resources as may be available to MRCC/MRSC.
- 3. Where 2 above applies, there shall be direct ARCC/ARSC/MRCC/MRSC contact for the purpose of agreement on the level of response required, etc, supported as necessary by documentary transfer.

Section 6

COSPAS/SARSAT

- 1. The Mission Control Centre (MCC) at RCC Kinloss shall advise MRCC of all relevant COSPAS/SARSAT reports.
- 2. ARCC/ARSC shall be responsible for initial co-ordination of Aeronautical COSPAS/SARSAT and ELT type incidents.
- 3. Transfer of co-ordination to <u>MRCC</u> shall take place when the location as calculated by merged solution as offshore or in the littoral area (i.e. coastal) <u>and</u> all aircraft in the vicinity have been accounted for.
- 4. MRCC may transfer coordination to MRSC Malin Head or Valentia as appropriate.
- 5. Subsequent to transfer of co-ordination MRCC or MRSC shall keep ARCC informed of all Mission Control Centre (MCC) reports.
- 6. ARCC/ARSC shall ensure relevant aircraft reports are communicated to MRCC.

Section 7

Irish Lights Helicopter

- 1. IRCG will provide a position monitoring (flight watch) service for CIL's service contract helicopter through their coast radio service (CRS).
- Should the Irish Lights helicopter fail to respond to routine safety check procedure, MRCC/MRSC shall immediately inform ARCC giving such procedural details of the flight concerned as are necessary for further ARCC/ARSC action.
- 3. Where 2 above applies ARCC/ARSC shall be responsible for the coordination of the SAR response.
- 4. Should the aircraft force land in a maritime area, ARCC/ARSC shall be responsible for determining the initial search area (except where the location is already known), but co-ordination shall then be transferred to MRCC/MRSC with appropriate back-up services from ARCC/ARSC.

Note: During such an incident, the aircraft may have established two-way communications with the CRS. It may be deemed appropriate to continue such communications arrangements, provided appropriate relay procedures with ARCC/ARSC are in place.

5. Where 2, and/or 4 apply, there shall be direct ARCC/ARSC/MRCC, MRSC contact, supported as necessary by documentary transfer.

Temporary Restricted Areas Established for SAR Purposes

- 1. ARCC/ARSC shall be the co-ordinating agency for establishment of Temporary Restricted Areas when so required for SAR purposes.
- 2. Clearance to enter, operate in or leave any of the above mentioned areas shall be obtained from the appropriate ATS units.

- 1. Aircraft reports of sea pollution or other maritime interest, received by ATS units shall be immediately transmitted to MRCC.
- 2. MRCC may request the ATS unit concerned to obtain further relevant reports. Such reports shall be immediately transmitted to MRCC.
