Notice to all Masters, Owners and Users of Pleasure and Recreational Craft

Closing date for submissions is extended to 9 December 2022

# Public Consultation on a review of the Code of Practice for the Safe Operation of Recreational Craft

The purpose of this Marine Notice is:

- (a) to inform owners, operators and users of recreational craft that the Department of Transport has commenced a review and updating of the Code of Practice for the Safe Operation of Recreational Craft to take into account legislative and other developments in recent years, and
- (b) to invite submissions to the review process from interested parties.

As outlined in Marine Notice No. 32 of 2022, the Code of Practice provides information on the legislation that applies to recreational craft, as well as safety information, advice and best practice operational guidance for owners, operators and users of a range of recreational craft operating in Irish coastal and inland waters. At present, the Code of Practice is divided into two Parts and a series of Appendices as follows:

- **Part A** (Chapter 1) outlines the legislative requirements that apply to all recreational craft or to specific types or size of craft.
- Part B (Chapters 2 to 11) contains recommended guidance and best practice information in relation to the safe operation of specific types of recreational craft. Chapters 10 and 11 provide general information on safety operations and emergency procedures.
- A series of 11 Appendices offer further advice and guidance, covering a range of topics including radiocommunications, collision prevention, weather and sea states, lifejacket use, passage planning, buoyage, anchoring, advice on purchasing a recreational craft and training course providers.

The current review will look at the content, structure and design of the Code of Practice, including at ways to improve the understanding of the content for end users, both in terms of presentation and layout. In line with a Core Objective of the 2021-2025 Irish Maritime Directorate Strategy, to "Enhance Maritime Safety", the Department is also taking this opportunity to explore ways of increasing awareness of the existence of the Code of Practice, and we invite suggestions in that regard.

To be of assistance, a list of questions that might be considered as part of the process of preparing a submission is set out in the Appendix to this Marine Notice. Of course, we welcome views generally on the Code of Practice and on how we might improve the understanding and promotion of its content.

- 6. Is there particular content in the Code of Practice that you find difficult to understand? Why? What are your suggestions to improve the understanding for end users?
- 7. What are your views on the various formats in which the Code is available to the public? Are there other formats that should be considered and why?
- 8. What are your suggestions regarding how the Code of Practice could be made more user friendly?
