# Data Protection Privacy Notice for applicants undertaking the internal process for appointment to State Boards under the aegis of the Department of Transport

## Part A:

We are fully committed to keeping all personal data submitted to us safe and secure. All necessary technical measures have been put in place to ensure the safety and security of the systems which hold your data.

Being open and transparent in how we process your personal data is important to us and therefore we aim to keep you informed of the purpose(s) for which your personal data will be used and why, where it may be shared elsewhere and why, and how long your data may be held by the department.

Personal data processed by the department will only be used for the specific purpose(s) as outlined when the data is collected, or in later communications, and will only be used in accordance with the Data Protection legislation in force.

#### **Data Subject Rights**

When you provide personal data to us you have certain rights available to you in relation to that data. These rights are outlined below and can be exercised by contacting the Data Protection Officer, as detailed above, indicating which right you wish to exercise:

- The right to be informed
- The right of access
- The right to rectification
- The right to erasure
- The right to restrict processing
- The right to data portability
- The right to object
- Rights in relation to automated decision making and profiling

Finally, as a data subject, should you be unhappy with the provision of information in this Notice you can make a complaint to the Data Protection Commission, which is Ireland's Supervisory Authority for data protection matters.

# Part B: Information Specific to the Data Being Collected for applicants undertaking the internal process for appointment to State Boards under the aegis of the Department of Transport

The following data is specific information in relation to the personal data for processed for the purposes of this form

#### **Specific Purpose:**

The collection and processing of the personal data is to maintain a list of appointed Board Members and publish this list of names on the department's and the Department of Public Expenditure, National Development Plan Delivery and Reform stateboards.ie websites.

#### Legal Basis

There is a legal basis for the collection and processing of the personal. It is the

- the establishing legislation (and subsequent amendments) of each agency under the aegis of the department, and in keeping with the legislative basis for consent may require the approval of the Minister for Public Expenditure, National Development Plan Delivery and Reform; and
- Department of Public Expenditure, National Development Plan Delivery and Reform guidelines on appointments to State Boards 2014.

## **Recipients:**

The personal data relating to your State Board application is retained by the department's State Board Liaison Officer and stored securely on the department's network, validated by login and password with restricted access. The department may disclose your personal data to others in connection with the above purposes, including:

- The Minister for Public Expenditure, National Development Plan Delivery and Reform in keeping with the legislative basis for consent of the appointment,
- Public Appointments Service for the purpose of recruitment and appointment of members to the board, and
- New Economy and Recovery Authority (NewERA) in relation to their financial and commercial advisory services provided in relation to commercial State bodies and to assist with the processing of the State board appointments.

## Transferred outside the EU/EEA and countries with which there is no adequacy agreement\*

The personal information you provide for this process is not transferred outside the EU/EEA i.e., the EU and Norway, Iceland and Liechtenstein.

#### **Retention Period**

The data collected for this purpose will be held by the department only as long as there is a business need to do so in line with the purpose(s) for which the personal data was collected. After this time, it will be marked for destruction and will be destroyed in line with internal guidelines or guidelines for destruction received from the National Archives Office or associated permission received from them or in line with other statutory requirements for destruction.

#### **Data Provision – Statutory Obligation**

The personal data provided for this purpose is being required under the:

- Establishing legislation (and subsequent amendments) of each agency under the aegis of the department, and in some instances may require the consent of the Minister for Public Expenditure, National Development Plan Delivery and Reform; and
- Department of Public Expenditure, National Development Plan Delivery and Reform guidelines on appointment to State Boards 2014.

#### **Automated Decision Making**

You have the right not to be subject to a decision based solely on automated processing, where such decisions would have a legal or significant effect concerning you.

The data held by the Department of Transport for the purposes of State Board appointments is provided to us by the Public Appointments Service and/or NewERA under the Department of Public Expenditure, National Development Plan Delivery and Reform Guidelines on State Board appointments 2014, following a publicly advertised recruitment campaign and a shortlisting assessment process.
