## Springboard – Logistics and Supply Chain related programmes

Springboard+ began in 2011 as part of the Government’s Jobs Initiative. Its aim is to provide free and heavily subsidised upskilling and reskilling opportunities through higher education in areas where there is an identified skills need. The initiative’s initial primary target group were unemployed people with a previous history of employment. Over recent years the focus was changed to include more people in employment and those returning to the workforce.

Springboard+ complements the core State-funded education and training system and is one of a number of initiatives designed to support people back into employment, improve the skills of those in employment, and to build the supply of skilled graduates to meet current and future skill needs of the Irish economy.

### Logistics Associate Apprenticeship

The Logistics Associate Apprenticeship was born of the need to address the Skills shortage within the Irish Freight, Logistics, Shipping and Distribution industries. As the economy grows, there is an increasing need to fill these skilled and knowledgeable roles. The Logistics Associate Apprenticeship provides academic education and practical training across the Freight, Logistics, Shipping and Distribution industries. Apprentices enter a contract of 2 years duration, where they will work with an Employer and spend one day a week with Technological University Dublin (TU Dublin) or Munster Technological University (MTU) for their academic studies. The Freight Transport Association Ireland (FTA Ireland) operates as an industry partner for this Apprenticeship. Completion of this programme will lead to a Level 6 Award on the National Framework of Qualifications.

On completion of this two-year apprenticeship, you will become a fully qualified logistics associate, with a QQI Level 6 Higher Certificate in Logistics. You may then choose to work in a number of roles including as a logistician, freight forwarder, distribution manager, inventory manager, process engineer, supply chain manager, shipping agent, transport manager or warehouse manager.

Logistic associates are required in a range of industries from freight, distribution, haulage, warehousing, and shipping. As a logistics associate, your work will typically involve liaising with transportation companies to create a good working relationship. You will prepare invoices for orders and deliveries as part of record keeping measures.

You will keep records of all shipping activities, documenting procedures, guidelines and changes in procedures for reference purposes. A logistics associate is responsible for ensuring compliance with customs duties, controls, tariff, international conventions and agreements.

For Apprentices, this programme is the perfect entry point into the Freight, Logistics, Shipping and Distribution industries, with broad exposure allowing persons to decide about their desired career direction upon completion. ### **[Transport Operations and Commercial Driving Apprenticeship](#)**

Atlantic Technological University (ATU) Sligo in partnership with Freight Transport Association Ireland (FTA Ireland), is now offering the Transport Operations and Commercial Driving Apprenticeship, the nation's first academic qualification for commercial driving. This 2-year, Level 6 Higher Certificate provides a great pathway into the industry for students who wish to become professional drivers. ATU Sligo, the coordinating provider, and FTA Ireland, the lead proposer, have worked with a dynamic consortium of key industry stakeholders and employers, to develop this apprenticeship.

On completion of this two-year apprenticeship, you will become a fully qualified transport operations and commercial driver, with an NFQ Level 6 Higher Certificate in Business in Transport Services, full C/CE licence and Driver CPC.

You may then choose to work as a transport operations & commercial driver for any number of retail, wholesale, haulage, or logistics companies. You may also use the qualification to progress within the sector and/or to higher education programmes.

As a transport operations and commercial driver, you will be involved in the daily activities of a commercial driver and other roles within the freight distribution and logistics sector such as transport planning and distribution operations.

You will have a good understanding in a range of activities such as the management of working time and tachographs, implementing legislation governing the operation of a commercial transport business,

loading, and transporting cargo, and performing administrative tasks. Further information on Transport Operations and Commercial Driving Apprenticeships is available on.

### **Supply Chain Apprenticeships**

IPICS The Supply Chain Management Institute, in partnership with the University of Limerick, have developed the first suite of supply chain apprenticeship programmes, from NFQ Level 7 (Ordinary Degree) all the way up to NFQ Level 10 (Doctoral Degree). These apprenticeships have been developed by industry for industry. They are work-based education programmes which support the development of the supply chain knowledge base amongst practitioners in organisations. They combine learning in the workplace with blended and online learning through the University of Limerick.

#### [Supply Chain Associate Level 7 Diploma](#)

On completion of this two-year apprenticeship, you will become a fully qualified supply chain associate, with a NFQ Level 7 Diploma in Supply Chain Management. You may then choose to work as a supply chain associate in the manufacturing, production, and service sectors. In your role as a supply chain associate you will be involved in forecasting, planning, purchasing, procurement, logistics, operations, inventory management, customer service, transport, distribution, and warehousing in your organisation. As a supply chain associate you will implement design, plan, execute, control, and oversee supply chain activities. You will work as part of a team to implement and carry out supply chain activities.

#### [Supply Chain Specialist Level 8 Degree](#)

On completion of this two-year apprenticeship, you will become a fully qualified supply chain specialist, with a NFQ Level 8 Bachelors of Science in Supply Chain Management. You may then choose to work as a supply chain specialist in industries such as MedTech, pharmaceutical, support services, outsourcing, engineering, aviation, healthcare, and technology. As a supply chain specialist, you will be responsible for forecasting and planning; purchasing; procurement; logistics; operations; inventory management; customer service; transport; distribution and warehousing of supplies. You will oversee the implementation of IT solutions and the adoption of new supply chain technologies in your organisation. Your work will involve being able to proactively anticipate and troubleshoot day to day problems within an organisation.

## [Supply Chain Manager Level 9 Masters](#)

On completion of this two-year apprenticeship, you will become a fully qualified supply chain manager, with a NFQ Level 9 Masters of Science in Supply Chain Operations. You may then choose to work as a supply chain manager in industries such as MedTech, pharma, support services, outsourcing, engineering, aviation, healthcare, and technology.

As a supply chain manager, you will be responsible for forecasting and planning; purchasing; procurement; logistics; operations; inventory management; customer service; transport; distribution and warehousing of supplies. You will oversee the implementation of IT systems and the adoption of new supply chain technologies in organisations, and proactively anticipate and troubleshoot day to day problems with supply systems.

## **Logistics and Services - Traineeship Programmes**

Traineeships are free to access and open to potential participants of all ages and backgrounds including school leavers, older learners, and those in, or seeking employment. A Traineeship combines learning in the classroom and experience in the workplace. Partner Employers provide work-based learning opportunities and collaborate with Education and Training Boards (ETBs) on existing and new programmes to identify skills gaps in different sectors and industries. ### **Logistics and Distribution - Traineeship**

The Logistics and Distribution – Traineeship provides the skills and knowledge to manage effective and efficient supply chain services. Content can include business and finance management, purchasing and procurement and inventory management. This traineeship typically lasts 52 weeks and includes a minimum of 30 percent on-the-job training. Upon completion, trainees may receive a QQI-FE Level 6 in Supply Chain Logistics.

## Professional HGV Training Programme

The programme was developed in conjunction with the IRHA with the purpose of increasing standards within the industry. The programme is funded under the SOLAS Traineeship scheme (Shaping skills, building careers) and is accredited by City and Guilds.

The Accredited element of the programme is based around the competencies demonstrated by the learners during the 8-week work experience built into this course; this includes assessed competencies for areas such as route planning, food safety, health & safety, and customer service.

The aim of the course is to provide learners with the skills and related knowledge in the rules of the road, driving a heavy goods vehicle - rigid and artic body, care, and maintenance of the vehicle, loading and unloading the vehicle, customer care and documentation and to develop personal effectiveness and job seeking skills. ## SMART Driving

Included in the course is The [SMART Driving](#) training programme which is an innovative programme that provides essential training on vehicle and road craft to HGV drivers. The programme is designed to upskill drivers in areas including telematics and in-cab technologies. The SMART Driving training programme will deliver immediate benefits to employers, drivers, and the environment.

The SMART Driving programme is funded through the SOLAS Skills to Advance 'Innovation through Collaboration' Fund. The 3-day SMART Driving programme monitors drivers existing behaviours and uses this information to teach them techniques to improve fuel efficiency and road safety. By improving drivers' awareness of their driving style and how this impacts on vehicle efficiency, drivers learn skills to increase fuel efficiency and lower carbon emissions.

Drivers will also learn advanced driving skills to anticipate the behaviour of less-skilled road users and recognise and respond to road conditions. Using this knowledge, drivers will learn the skills to anticipate and avoid incidents. The SMART Driving programme is certified as a QQI Level 5 Certificate in Digital Assisted Eco Driving (HGV). A full current Category B Driving Licence and Irish learner permit Category C is a minimum learner entry requirement.

## SOLAS and QQI

SOLAS is the State agency tasked with building a world class Further Education and Training (FET) sector to fuel Ireland's future. ## Further Education and Training (FET)

Further Education and Training or FET, offers a wide variety of life-long education options to anyone over 16. FET includes apprenticeships, traineeships, Post-Leaving Cert (PLC) courses, community, and adult education as well as core literacy and numeracy services. FET courses and programmes are provided through the Education and Training Board network throughout the country as well as through other local providers including online through SOLAS' eCollege. FET courses are provided at Levels 1 to 6 on the [National Framework of Qualifications \(NFQ\)](#).

FET is for anyone who is over 16 who wants to learn new skills or enhance existing skills to get the right job, progress to third-level or to support the achievement of personal goals. Depending on the course you choose, there may be certain eligibility criteria – contact your course provider or ETB for more information. FET Training Allowances – Training courses provided by the ETB Training Centres are free (except for evening courses) and you may be paid a training allowance for the duration of your course. You can also claim an accommodation allowance if you need to live away from home for the duration of the course or a travel allowance. You may qualify for a free childcare place for your child. FET allowances are not taxable.
