Background

The quarterly statistical report provides summary information on Income and Expenditure as well as total recipients of the main schemes administered by the Department of Social Protection.

The quarters referenced in this report cover the following periods

Quarter 3	July 1st - September 30th
Quarter 4	October 1st - December 31st

These statistics may be subject to revision and should be considered as provisional.




Overall Expenditure

Figure 1: Expenditure (€m) by quarter



- The overall expenditure of the Department of Social Protection to end of first Quarter 2023 was €5.9 billion. This was €344 million, or 6%, lower than the same period in 2022.
- Expenditure on Social Assistance schemes between January and March 2023 was an estimated €3.0 billion, a decrease of 11%, or €382 million, compared to the same period in 2022. This is mainly due to the closure of the Employment Wage Subsidy Scheme and Pandemic Unemployment Payment in 2022 and an increase in expenditure on Pensions.
- Expenditure on schemes financed from Social Insurance between January and March 2023 was an estimated €2.9 billion, an increase of €38 million, or 1%, compared to the same period in 2022.
- Income exceeded expenditure from the Social Insurance Fund to the tune of €867 million in Q1 2023.

Figure 2: Quarterly Social Insurance Fund Income and Expenditure (€m)







Programme Expenditure

- Expenditure on Working Age Income Support payments for the first Quarter of 2023 was €937 million, a decrease of €51 million (5%) compared to the same period in 2022.
- Spending on Working Age Employment Support schemes was recorded at €158 million to the end of the first Quarter 2023, a year-on-year decrease of €651 million or 80%.
- Child related payments amounted to €702 million in Q1 2023, resulting in a rise of 6% or €42 million from the same period in 2022.

- Pension payments for the first Quarter 2023 stood at €2.4 billion, an increase of 16%, or €324 million, from the same period last year.
- In the period January to March 2023, expenditure on Illness, Disability and Carers was recorded at €1.2 billion, a decrease of 1% (€8 million) from the same period in 2022.
- Expenditure on Supplementary & Miscellaneous services stood at €312 million in Q1 2023. This is a decrease of 6%, or €21 million, compared with the first Quarter of 2022.

Figure 3: Expenditure to date by Social Protection Programme (€): This period and same period last year









Pensions

- Some 720,089 people received payments across the main Pension schemes in Quarter 1 2023, a year-on-year increase of 3% (23,686) compared to Quarter 1 2022.
- The main increase in pension related payments occurred for the State Pension Contributory (SPC) and State Pension Non Contributory (SPNC) both recorded a 4% year-on-year growth in recipients, while recipients of Widow(er)'s Contributory Pension (WCP) increased by 1% since Q1 2022.

- Across the schemes the average weekly payment was €269 for SPC, €249 for SPNC, and €290 for WCP.
- 60% of people on the SPC were male, while females accounted for 60% of SPNC recipients and 84% of WCP recipients.

Figure 5: Pension recipients this quarter by sex and by scheme








Working Age Income Supports


- A total of 173,639 people received Jobseeker's Allowance in the last Quarter. This is an increase of over 27,000, or 19%, compared to Q1 2022.
- The total number of people in receipt of Jobseeker's Benefit across Quarter 1 2023 was 65,871, a decrease of 1% from 67,414 in the fourth Quarter of 2022, and a year-on-year decrease of 20%, or 16,655, from the 82,526 recipients in the first Quarter of 2022.

- Jobseeker's Benefit (Self-Employed) recipients stood at 1,242 in the Quarter, an increase of 32%, when compared with the same period in 2022. However, there was a decrease of 5% when compared with Quarter 4 2022.
- There were 27,499 recipients of Maternity Benefit and 6,710 recipients of Paternity Benefit in the Quarter. 20,589 people received payments from the Parent's Benefit scheme, a decrease of 14% on the previous Quarter, but up by 32% compared to Q1 2022.

Figure 7: Maternity, Paternity, and Parent's Benefit recipients






Illness, Disability, and Caring


- The number of people paid Illness Benefit in Q1 2023 was 122,521, a decrease of 5% from the previous Quarter, and down by over 200,000, or 63%, when compared to Q1 2022. This is largely due to the closure of the Enhanced Illness Benefit scheme in Q3 2022.
- In Q1 2023, there were 57,835 recipients of Invalidity Pension (INVP), a decrease of 52 (<1%) from the Q4 2022. This is the 9th successive Quarter in which there has been a decrease in INVP recipients.

- There were 161,073 people in receipt of Disability Allowance in the first Quarter of 2023, an increase of 2% (3,236) on the previous year. The average weekly payment received on this scheme was €243.
- The total number of people receiving Carer's payments in Quarter 1 2023 was 99,626, a rise of 2,181, or 2%, from Quarter 1 2022. On average, Carer's Allowance recipients received a payment of €215, while Carer's Benefit recipients received a payment of €281.

Figure 9: Annual Change (%) in recipient numbers by scheme






Children and Supplementary Payments

- In the last Quarter, a total of 657,533 families received Child Benefit payments, an increase of 19,533, or 3%, compared to Quarter 1 2022.
- 98% (647,420) of recipients of Child Benefit were female, while 2% (10,113) were male.
- The number of people in receipt of the Back to Work Family Dividend fell by 212, or 7%, from Q1 2022 to 3,037. The average payment for this scheme was €73.
- The number of recipients of Rent Supplement in Quarter 1 2023 totalled 9,489, a 27% decrease (-3,553) compared to the first quarter of 2022.
- There were 256,928 people receiving direct payments from the Household Benefits Package^[1] in the Quarter, representing a yearon-year increase of 31,916 or 14%.


Figure 10: Annual change (%) in Rent Supplement recipients by county





Additional Needs Payment (ANP)

- In the first three months of 2023, a total of 35,260 ANP claims were registered. This is a decrease of 20% (- 8,725) compared to the final Quarter of 2022, but an increase of 87% (16,410) compared to the same period last year.
- A total of 23,751 ANPs were awarded in the first Quarter of 2023. This
 is a decrease of 24% (-7,328) from Q4 2022, but an increase of 86%
 (10,993) compared to Q1 2022.
 - Figure 11 ANP awarded claims this quarter by broad category



- The broad ANP category with the greatest number of awarded claims in the first three months of 2023 was Clothing (9,955), followed by General (5,664) and Housing (5,331). Combined, these three ANP groups account for 88% of all awarded ANP claims in this period.
- Year-to-date ANP expenditure amounted to €17.4 million. Housing accounted for over 60% of total ANP expenditure.

Figure 12 ANP awarded claims year-on-year percentage change



Notes

Methodology and quality considerations

The expenditure details in this report are based on estimates. The finalised expenditure information can be viewed in the latest Appropriation Accounts for Vote 37¹, or the latest Annual Statistics Report². Note that the estimated expenditure figures in this report may not add up exactly due to rounding.

When comparing to a previous quarter or previous year, the comparison can sometimes be impacted by the number of pay days that fall in a particular quarter. This may account for skews in expenditure and/or recipient totals in certain quarter periods.

The recipient totals were extracted from the Department's administrative systems, and include people who were issued at least one payment for a particular scheme in a given quarter. In the majority of cases the date in which the payment was made reflects the entitlement period .i.e. when the payment was issued the recipient's claim was open. However payments can be issued in respect to different entitlement periods (arrears payments). The figures produced in this report are calculated with reference to the date the payment was issued, and are therefore inclusive of arrears payments. Note that a person can be in receipt of payment for more than one scheme.

The recipient figures quoted in the Annual Statistics report are not directly comparable to the numbers shown in this publication. The Annual Statistics report counts only those awarded and in receipt of payment at a point in time (December 31st) to ensure comparability with a series of statistical reports dating back to 1983.

Glossary of Terms

Recipient: A person receiving at least one Social Welfare payment in a given quarter period.

Social Assistance: payments funded from voted expenditure, which cover people who do not have sufficient PRSI contributions to qualify for the equivalent social insurance payments, or where entitlement to the social insurance payment has expired. These payments are typically means-tested.

Social Insurance Fund: a current account and an investment account managed by the Minister for Social Protection and the Minister for Finance, respectively. The current account consists of monies collected from people in employment, self-employment, and employer contributions. This money is then used to fund social insurance payments.

Open Data

Each report in this series will be available in formats consistent with the Open Data Technical Framework³. Any open data produced by the Department will be accessed through the National Open Data portal at: https://data.gov.ie/

Revisions

Revisions may occur as a result of changes in methodology, an update to a series or errors in the original data. Any significant revisions will be footnoted in the report and will describe the reason for the change and its impact on comparability (.i.e. with other schemes or over time).
