
1. Minutes of ESEG meeting of 10 February & actions arising

2. Sectoral Updates

a) Gas update - including on interconnector capacity.

Aidan Bugler provided an update on gas demand and storage positions across Europe (presentation circulated to the group). He noted that wholesale gas prices have started to come down and that the supply situation is currently stable.



b) Oil update


John Burke advised that there were no significant changes in the oil supply position, and interactions with industry have indicated that they were broadly unaffected by sanctions on Russian oil.

c) Electricity update

Rodney Doyle provided an update on electricity supply, noting the effects of recent temporary closure of several plants on supply. EirGrid are working on securing interconnector trades to mitigate the risk of an amber alert. Infrastructure for the installation of temporary generation in North Wall has arrived this week which will improve the supply situation once constructed and energised.

CRU and EirGrid are to provide an update on future auctions for the next meeting.
