#### 1. Minutes of the last meeting

- 1.1. The Chair opened the meeting and welcomed Brendan O'Connell, IPS Psychology Service as a new member of the Subgroup
- 1.2. Group agreed that the SG3 Final report is made up of three main documents on Community, Throughcare and Primary Care/Social Inclusion and the focus for the Subgroup is to now pull together the different strands of each and build the recommendations for Final report

#### 2. Document on Courts

- 2.1. It was raised that there are a large number of people with mental health challenges before the Courts and this cohort of people need to be diverted away from the CJ system
- 2.2. There is a need for new legislation in order to successfully divert people away from Courts system
- 2.3. Measures could include assisting Judges with more information, ensuring adequate staffing and funding for the in-reach prison service
- 2.4. There is a need for a more integrated team approach from the Probation Service and the Courts as people have challenges access different types of services
- 2.5. It is important to have an adequate referral pathway and to ensure any barriers to access to housing are removed
- 2.6. Important to address the area of dual diagnosis of both substance abuse and mental health issues throughout the report
- 2.7. The Group acknowledged that due to the end of institutional mental healthcare there is a now a pattern of people with mental health issues gravitating towards the Criminal Justice System
- 2.8. The Group agreed that those in need should be assessed correctly and the whole area should not be viewed as criminalising mental health
- 2.9. There are already some diversion services available in Cloverhill but there are number of other Courts already diverting people away from the Criminal Justice system where possible
- 2.10. The Group agreed that resourcing as regards the availability of delivering service was of utmost importance
- 2.11. It was also suggested that there needs to be a mental health diagnosis before a Court appearance
- 2.12. There was a lengthy discussion regarding the area of drug possession and how the mental health diversion model could be applied to drug possession
- 2.13. It is hoped the Primary care networks will be developed in the coming months
- 2.14. The Group discussed the importance of Housing relating to the model of care for homelessness within the HSE and the homelessness outreach programme run by D/Housing
- 2.15. The Group acknowledged the challenges faced within homeless services outside Dublin a Housing First discussion paper is being developed and it is hoped a new model will roll out from the Dublin to the wider regions. There will be a new Housing First National Director starting soon
- 2.16. It was raised that there are barriers in place to accessing treatment facilities for substance misuse at the end of prisoners' sentences. There was a consensus there will need to be a recommendation for better access to beds relating to same
- 2.17. The Group agreed that there will be a number of critical recommendations to be included in the conclusion of the report
