Incorrectly completed forms will be returned for amendment to the **parent/legal guardian** that signed the original application seeking home tuition hours.

- Please use black or blue ball point pen and clear BLOCK CAPITAL letters.
- Corrective fluid such as Tippex must not be used.
- A separate claim form must be completed for each tutor.
- All claims for hours completed **must follow the deadlines** set out overleaf. Only sanctioned tuition hours completed during the payment period will be paid in the designated pay run.
- Under **no circumstances** are hours to be claimed for administration or preparatory work. Payable hours are **only** those dedicated to providing one-to-one tuition in the student's home.

All overpayments of grant funds will be managed in line with the provisions set out in the Department circular 0084/2015. Where necessary, such cases might lead to a referral to either/both An Garda Síochána and The Teaching Council.
