## INSTRUCTIONS FOR COMPLETION AND RETURN OF THE CLAIM FORM

Please submit the full four-page form with **all** sections completed from **PART A** to **PART C**. Please do **not** complete in respect of months/hours already claimed.

Incorrectly completed forms will be returned for amendment to the **parent/legal guardian** that signed the original application seeking home tuition hours.

- Please use black or blue ball point pen and clear BLOCK CAPITAL letters.
- Corrective fluid such as Tippex must not be used.
- A separate claim form must be completed for each tutor.
- The claim form must be completed at the end of **the calendar month** in which completed tuition was provided. Only sanctioned tuition hours completed **on or before the latest date under the signatures in Part C** date will be paid.
- Under **no circumstances** are hours to be claimed for administration or preparatory work. Payable hours are **only** those dedicated to providing one-to-one tuition in the student's home.
