Notice to all Shipowners, Fishing Vessel Owners, Agents, Shipmasters, Skippers, Fishers,
Yachtsmen and Seafarers

Sceirde Rocks Windfarm Project – Benthic and Geotechnical Surveys

1. Notice of Activity

The Department of Transport has been advised by Fuinneamh Sceirde Teoranta (FST) that Benthic and Geotechnical Survey vessels will be deployed in the Western Coastal Area Connemara / Outer Galway Bay/Atlantic Ocean. The deployment will take place between **29 July and 30 November 2023**, subject to weather and operational constraints.

2. Location of Activity

The equipment for both surveys will be deployed within the bounds of the area detailed in the table below and as set out in the map in the Appendix to this Notice.

Note: Survey Operations will take place at multiple locations within the area specified.

3. Details of Survey Vessels

The Benthic Survey will take place using the vessels **Ocean Navigator (call sign EI018)**, **Situla (call sign HO8727)** and **Roman Rebel (call sign 2ICA5)**. These vessels will operate 24 hours per day.

The Geotechnical Survey will take place using the vessels **Geoquip Seehorn (call sign 5BSW)** and **Glomar Vantage (call sign HO3057)**. These vessels will operate 24 hours per day.

Throughout operations, the vessels will be displaying the appropriate lights and shapes as required under the COLREGS Rule 27 (b). During operations, the vessels will be restricted in their ability to manoeuvre. Vessels are requested to leave a wide berth during the deployment operations. Radio transmissions will be conducted with other seafarers to notify them of the operations. All vessels will monitor channel 16 for emergency communications with other seafarers and then mutually agree another channel to switch to for further discussion (as needed).
