Notice To all Fishing Vessel Owners, Agents, Skippers, Fishing Vessel Crew Members and Fishermen

Code of Practice for the safety of Small Fishing Vessels, less than 15m – Panel of Surveyors

The Department of Transport wishes to advise that it has re-established a Panel of Surveyors to conduct surveys of Small Fishing Vessels of less than 15m, to check for compliance with the Department's Code of Practice for such vessels. This panel is established from **25 January 2024** until **24 January 2027**.

A list of the Panel of Surveyors is also contained in the Annex to this notice.

Note: We wish to remind owners of Fishing Vessels that a copy of the Declaration of Compliance and a Record of Equipment must be sent to the Marine Survey Office on completion of the survey by the panel surveyor.
