

Notice of Intention to Renew a Prospecting Licence

Pursuant to section 8(6) of the Minerals Development Act 1940, as inserted by section 2 of the Minerals Development Act 1995, the **Minister for the Environment, Climate and Communications** intends to renew the prospecting licence for Barytes, Gold (Ores of), Silver (Ores of) and Platinum Group Elements (Ores of) to Teck Ireland Limited, Arklow Business Enterprise Centre, Kilbride Industrial Estate, Arklow, Wicklow, Y14 T440, Ireland over the following Townlands in County Kildare.

Townlands in Ikeathy and Oughterany Barony:

Aghafullim, Ballybrack, Ballycaghan, Ballycanon, Ballyloughan, Baltracey, Barreen, Belgard, Boycetown, Branganstown, Clonduff, Clonfert North, Clonfert South, Clonsast, Clonshanbo, Commons East, Commons South, Commons West, Courtown Great, Courtown Little, Duncreevan, Farranadum, Gragadder, Graiguepottle, Hodgestown, Kilcock, Kilmagorroe, Laragh, Laragh Demesne, Newtownlaragh, Pitchfordstown, Portgloriam, Roestown.

Submissions to the renewal of the licence should be made within **30 days** of the date of this Notice. Submissions can only be made by either posting them to the Geoscience Regulation Office at the address below or by using the **online submissions form** www.gov.ie/gsroSubmissions. The Minister reserves the right to make details of the submissions available to the applicant in order to fully consider their validity.

Please note: A Prospecting Licence entitles the holder to explore for mineral deposits only and **does not authorise mining of any minerals**. The prospecting activities permissible under a licence are, in general, non-invasive and of minimal environmental impact.

The Minister has assessed the exploration programme proposed by the Company and has determined that the activities are not likely to have a significant effect on the environment. Activity

Mineral exploration consisting of desk studies, geological mapping, geochemistry, geophysics, and drilling.

Environmental Considerations

Desk studies, geological mapping, geochemistry, and geophysics are temporary, non-intrusive activities, involving minimal disturbance and with a limited zone of influence. The activities are not likely to have a significant effect on the environment.

If the activities are undertaken at or in the vicinity of a Natura 2000 site, the activities will be subject to a separate screening assessment.

If drilling is undertaken, this activity will be subject to a separate screening assessment.
