Notice to all Shipowners, Fishing Vessel Owners, Agents, Shipmasters, Skippers, Fishers, Yachtsmen and Seafarers

# Arklow Bank Geophysical Survey – Including Uncrewed Vessels

#### 1. Notice of Activity

The Department of Transport has been advised that geophysical surveys will be undertaken in the Irish Sea (off the Wicklow and Wexford coast) to provide site investigation information to facilitate the development of the Arklow Bank Wind Park 2 project. The survey campaign will involve the use of non-intrusive Seismic, Multibeam Echosounder, Side-scan Sonar, Sub-Bottom Profiler and Magnetometer surveys to acquire data. The survey work is anticipated to run from **26 June 2024** to **30 September 2024**, subject to weather and operational constraints.

#### 2. Location of Activity

The survey campaign will be confined to the proposed Arklow Bank Wind Park 2 Foreshore Licence area and focused on the offshore export cable routes from landfall and the array area. The Arklow Bank area is located approximately 3nm to 7nm off the coast of counties Wicklow and Wexford and consists of a north-south trending sandbank around 12nm in length and sub-parallel to the coastline between Ardmore point and Kilmichael point. The geophysical survey area is provided in the table below and within the area shown in the map in Appendix 1 at the end of this notice.

### 3. Details of the Survey Vessels

The operations will be conducted by the following vessels:

- "Roman Rebel" (call sign 2ICA5)
- "Lady Kathleen" (call sign EIXT2) and
- 4 XOCEAN USVs (Uncrewed Surface Vessels) as follows:

As the survey vessels will be restricted in their ability to manoeuvre when surveying, due to the deployment of the towed survey equipment from the vessels for the duration of the survey activities, all vessels operating within this area are requested to keep their distance and pass at minimum speed to reduce vessel wash.

The work will be conducted during 24 hr operations on board the "Roman Rebel" and XOCEAN USVs and 12 hr operations on board the "Lady Kathleen". Mariners are advised to keep continuous watch on VHF radio channel 16 when navigating the area. The vessels will display appropriate lights and signals.
