Minutes:

- 1. Welcome DoH Chairperson.
 - 1.1 Chair opened the meeting by welcoming those attending.
- 2. Minutes of meeting of September 2023.
 - **2.1** The minutes of the fifth Steering Committee meeting were agreed by the Committee.
- 3. Mapping process outline of work undertaken to date.
 - **3.1** The mapping process was generally to clarify roles and responsibilities, with on-going monitoring. In overall terms, it would be good to synchronise reporting requirements for the agencies where possible, to avoid duplication.
 - **3.2** DoH spoke about tracking software which is linked to the online portal for Connecting for Life (CfL). This is working well and the tracking system will be rolled out to Sharing the Vision (StV) during 2024.
 - **3.3** The HLTF SC will look to the possibility of adopting this 'ActionTrack' software to streamline the reporting process after StV has done same.

- **3.4** In light of this for DoH, manual updates will be sought for now with a hope to move to automated tracking in future.
- **3.5** There are set dates for updates on CfL and StV. The Justice workstream under StV interacts with the IPS and NFMHS, and a number of the HLTF recommendations fall under this workstream. Work continues to scope out alignment of reporting dates to ensure that any burden associated with duplication of reporting is avoided.
- **3.6** The Steering Committee will aim for the annual progress report (as recently published for Sept '22 to Sept '23), and quarterly reporting from agencies will assist in seeing that implementation is on-track.
