## Decision (Aarhus) on Specific Prospecting Activities

The Minister has assessed the exploration project proposed by the company and has determined that the activities are not likely to have a significant effect on the environment and proposes to grant the following Prospecting Licences (PL).

PL Area 3066 and 4098 (Counties Cavan and Monaghan)

Company Conroy Gold (Longford Down) Ltd

Activity Mineral exploration including; prospecting, geological mapping, soil geochemistry, ground geophysical surveys, deep overburden sampling, stream sediment sampling and diamond drilling and/or trenching.

Environmental Considerations Prospecting, geological mapping, soil geochemistry and ground geophysical surveys are temporary field activities which involve minimal disturbance and have a limited zone of influence. Deep overburden sampling using a motorised auger has the potential to temporarily generate elevated noise. Any deep overburden sampling that is proposed to be undertaken within 1.5km of a designated environmental site will be the subject of additional environmental screening by GSRO. Stream sediment sampling is only permitted in the period start of July to end September. Any potential drilling or trenching will also be subject to further environmental screening assessments, once the locations for these activities are notified to GSRO.

In the event that the company plans to carry out any activity within or in close proximity to a proposed Natural Heritage Area (e.g. Dromore Lakes, Cootehill Church pNHAs), this will be the subject of additional environmental screening.

European Sites Lough Oughter and Associated Loughs SAC (Site Code 000007)

A screening determination has been carried out for the project. Particular attention has been paid to the European Site listed above.

It has been determined that the project does not have the potential for significant effects on a European Site on the basis that:

- Prospecting, geological mapping, soil geochemistry and ground geophysical surveys will be temporary, involve minimal disturbance and have a limited zone of influence.
- All exploration activities will take place at least 7 km from the nearest European Site.
- Any potential drilling or trenching will be subject to further environmental screening assessments, once precise locations of the activity are known.
