Notice to all Shipowners, Fishing Vessel Owners, Agents, Shipmasters, Skippers, Fishers, Yachtsmen and Seafarers

North Celtic Sea Offshore Wind Farm Deployment of Metocean Equipment

1. Notice of Activity

The Department of Transport has been advised by Energia that they intend to deploy marine metocean equipment between **2 April 2024** and **4 April 2024**, subject to weather and operational constraints. The equipment will consist of a floating LiDAR (FLiDAR) buoy, a Datawell Waverider buoy and a Seabed mooring which will remain on site for a period of 6 months within the North Celtic Sea. **The equipment will be serviced over one day from 26 July 2024, subject to weather constraints.**

2. Location of Activity

The deployments will take place at the locations indicated in the table below in the North Celtic Sea. Further information on these locations is available in the map in the Appendix to this Marine Notice.

The FLiDAR buoy records meteorological data and is anchored to the seabed by means of a mooring chain and a ground weight. The buoy has dimensions of 4m x 4m, and when deployed the tallest mast on the buoy sits approx. 4m above the water line. The lantern will

have a flash sequence (FI) (5) Y 20s. The wave buoy deployed will be a yellow spherical buoy, measuring 1.1 m in diameter, and fitted with a flashing antenna with sequence FI (5) Y 20s.

3. Details of the Survey Vessel

The operations will be conducted by the “**CT Vector**” (**Call sign: 2BBA2**). As the vessel will be deploying buoy equipment the vessel will be restricted in its ability to maneuver, therefore all vessels are requested to leave a wide berth during the operations and pass at minimum speed to reduce vessel wash. The vessel audio transmissions will be conducted with other seafarers to notify them of the operations.

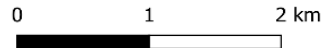
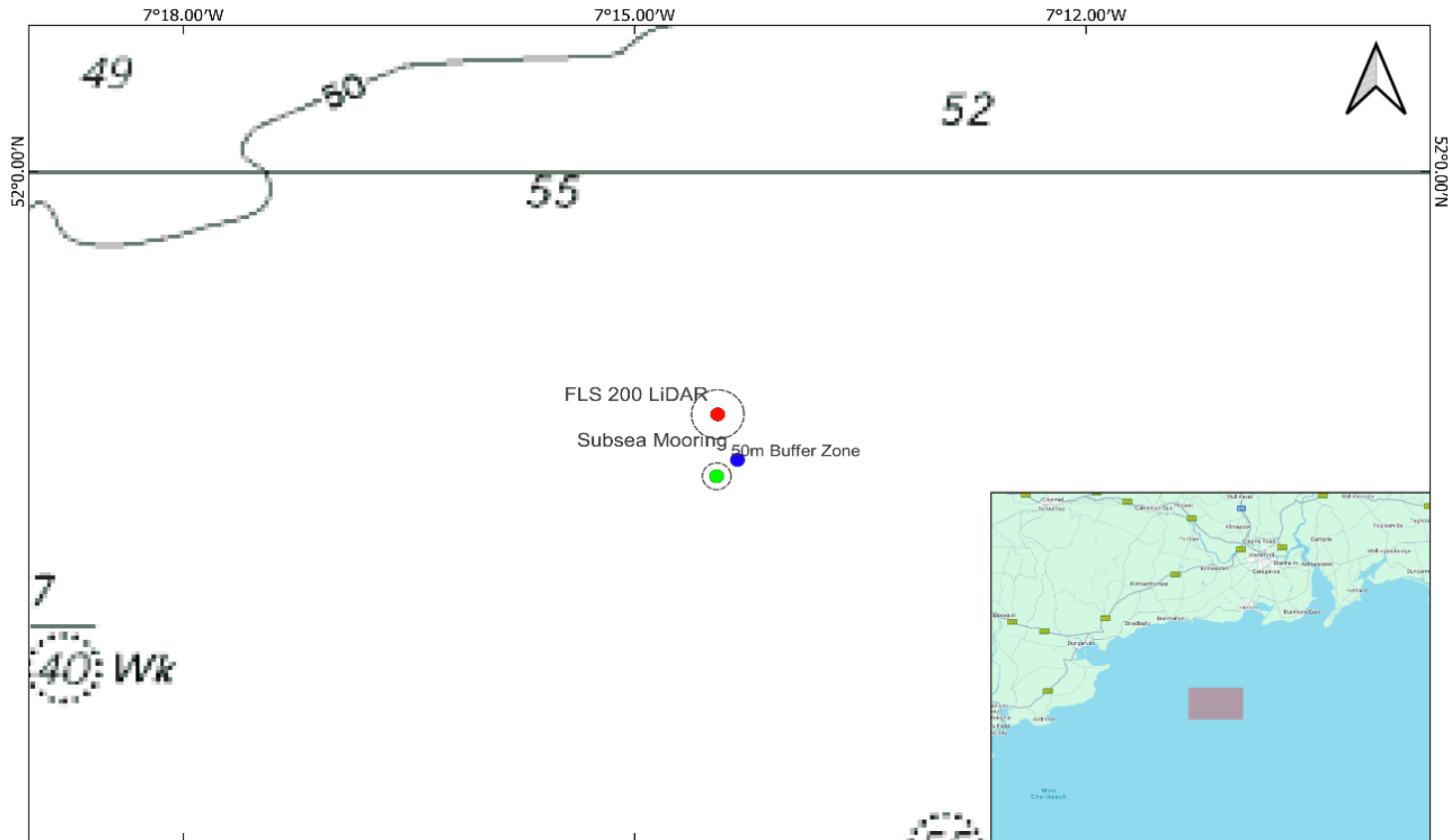
