We would like the endorse the Submission to the Department of Rural and Community Development being made by The Wheel on our behalf.

Carlingford Lough Heritage Trust (trading as Carlingford Heritage CLG), as its name implies, operates

as a social enterprise mainly in the category of Heritage Festivals, Arts & Druger Endustry. It also

provides critical and much needed service in providing Community Infrastructure & Development in the Carlingford and Cooley Peninsula area, including cross-border communities. Our diverse range of services are covered by the definition of social enterprise and in the categorisations provided on page 3 of the Public Consultation Document – providing support for enterprise (i.e. office space) and as a 'deficient demand' social enterprise.

The commitment to provide a range of supports to social enterprises to ensure they 'can become equipped, to the greatest extent possible, with the skills needed for the future is very much welcomed. We also heartily endorse the Government's objective 'to ensure that an appropriate range of supports is available for social enterprise and to address any unwarranted restrictions which may preclude their access'.

We welcome the emphasis on growing the sector and increasing the awareness among young people of the opportunity to build a career in the sector. We recognise the need to improve the image of the sector which can provide interesting, dynamic, well-managed, socially worthwhile and decently paid working lives to people of all ages.

There has been much public discussion around the subject of retirement, pensions and the desirability, from a societal and economic perspective, as much as personal, of strict end of working life timelines. Indeed, Government policy now makes it possible for those reaching the age of 66 'from

January 2024 to choose to start claiming State Pension (Contributory) anytime between the ages of 66 and 70' 1. We believe that such flexibility should, in the relevant, appropriate circumstances be applied in the context of grant funding for those employed in the social enterprise sector.
