Welcome and Opening Remarks	 Minister O'Donnell opened the meeting and welcomed the attendees.
Introduction to the Session	 It was advised the Planning Bill was approved at Cabinet yesterday and an overview would be provided to the Group later in the morning.
Terms of Reference	 The revised Terms of Reference were discussed. A request for additional time to consider the revised Terms of Reference and the minutes of the Inception meeting of the PAF (which took place on 6th July 2023) was agreed to with observations requested by Wednesday 11th October.
Report of the Expert Review Group	 A summary of the Report of the Expert Group review was provided. An overview of the recommendations from the Expert Group's Report was discussed.
Session 1 – Issues Paper (Part 1)	 A briefing regarding the three topics was provided to the group. The first breakout and discussion session took place regarding: Climate transition and our Environment; Population and Demographics; Regional Growth and Ambition; Compact Growth Feedback was provided from each of the five tables by a designated rapporteur.
Session 2 – Issues Paper (Part 2)	 A second breakout and discussion session took place regarding a) Digitalisation; and b) Investment and Prioritisation. Feedback was provided from each of the five tables by a designated rapporteur.
The Planning Bill	 An update on the Planning Bill was provided outlining the next steps in the process. The floor was opened up for questions regarding the Planning Bill.

	 Observations and contributions were made relating to the following: Issues raised; it was noted there was no change, just clarification. The right to consult, to include local employers as well as developers.
Closing Remarks	 Minister O'Donnell thanked the Forum Members for attending and advised on the next stages including the closing date of 20th October for submissions on the Issues Paper from Forum members.
