Marine Notice No. 23 of 2023

This Marine Notice supersedes Marine Notice No. 41 of 2022. Amended 02/12/2024 Notice to all Shipowners, Fishing Vessel Owners, Agents, Shipmasters, Skippers, Fishers, Yachtsmen and Seafarers

Port and Sea Areas

This Marine Notice provides information regarding the Port and Sea Areas of the State, which are listed in Appendices I and II. It supersedes Marine Notice No. 41 of 2022.

The Port Area of Howth Sound has recently been updated as set out in the following extract from Appendix I:

The following paragraphs give further information regarding the Port Areas and Sea Areas of the State.

1. Port Areas

The purpose of the designated Port Areas is to indicate areas where vessels may operate without being considered to be at sea, hence the expressions "smooth" or "partially smooth". The areas may also be considered to be port areas under the European Union <u>Directive 2009/45/EC</u>¹, as defined in Article 2(r). In particular, the designated Port Areas impact on the plying limits indicated on the Passenger Ship Certificate for vessels of Class IV and Class V and for the plying limits stated on P1, P2 and P4 Passenger Boat Licences. For other vessels, the requirements of the Load Line Rules become relevant when proceeding outside Port Areas.

¹ Directive 2009/45/EC of the European Parliament and of the Council of 6 May 2009 on safety rules and standards for passenger ships, as amended by Commission Directive 2010/36/EU of 1 June 2010, Commission Directive (EU) 2016/844 of 27 May 2016, Directive (EU) 2017/2108 of the European Parliament and of the Council of 15 November 2017 and Commission Delegated Regulation (EU) 2020/411 of 19 November 2019.

Port Areas were originally derived early in the last century and were appropriate for the trading and operating conditions at that time. However, many of the State's ports and harbours are not listed in statutory schedules. Therefore, the purpose of this Marine Notice is to address this issue and to designate, where practical and safe to do so, areas of smooth or partially smooth water in ports or harbours, etc. that were not previously listed.

If an area is not listed or a person(s) or body with local knowledge are of the view that the Port Areas are insufficient, bearing in mind parameters of safety, sea, weather and tidal conditions, a submission may be made in writing for the consideration of the Irish Maritime Administration. Such a submission should be accompanied by supporting factual information, data, etc.

Similarly, if a person(s) or body with local knowledge considers a designated Port Area is excessive, a submission may be made in writing for the consideration of the Irish Maritime Administration.

The Port Areas may have been designated on the basis of, inter alia:

- 1. Areas which are not fully exposed to open sea forces;
- 2. A recent study by an organisation into wave heights around the coast;
- 3. Feedback from competent persons and persons with local knowledge.

See Appendix I for details of the Port Areas of the State.

2. Sea Areas

The following legislation is relevant to the establishment of the Sea Areas in the State:

- Directive 2009/45/EC on Safety Rules and Standards for Passenger Ships;
- Schedule 2 of the European Union (Passenger Ships) Regulations 2019 (<u>SI 676 of 2019</u>);
- Regulation 8 of the European Union (Passenger Ships) (Amendment) Regulations 2022 (<u>SI 19 of 2022</u>);
- Regulation 2 of the European Union (Passenger Ships) (Amendment) Regulations 2023 (<u>SI 108 of 2023</u>);
- Schedule 1 of the Merchant Shipping (Passenger Ships) Rules 2020 (SI 640 of 2020);
- Rule 2 of the Merchant Shipping (Passenger Ships) (Amendment) Rules 2020 (<u>SI 49</u> of 2022);
- Rule 2 of the Merchant Shipping (Passenger Ships) (Amendment) Rules 2023 (<u>SI 109</u> of 2023);

Vessels proceeding beyond the Port Areas listed in Appendix I are considered to be at sea.

The Sea Areas of the State are divided into 4 categories (listed in Table 1 below) in accordance with Article 4(1) of Directive 2009/45/EC, as amended, and are specified in Schedule 2 to the European Union (Passenger Ships) Regulations 2019 (SI 676 of 2019), as amended by S.I. No. 19 of 2022 and S.I. No. 108 of 2023.

For passenger ships below 24 metres in length, Rule 2(2) and (3), and the associated Schedule 1 to the Merchant Shipping (Passenger Ships) Rules (S.I. No. 640 of 2020), as amended by S.I. No. 49 of 2022 and S.I. No. 109 of 2023, relate to the Sea Areas in the State.

Table 1Sea Area Categories

"Area A"	means a sea area outside of areas B, C and D.
"Area B"	means a sea area, whose geographical coordinates are at no point more than 20 miles from the line of coast of the State, corresponding to the medium tide height, but which is outside of areas C and D.
"Area C"	means a sea area whose geographical coordinates are at any point no more than 5 miles from the line of coast of the State, corresponding to the medium tide height, but outside of sea area D if any, and the probability of the significant wave height exceeding 2.5 metres is smaller than 10 per cent for a period of one year for all-year-round operation, or for a specific period for seasonal operation, such as summer period operation.
"Area D"	means a sea area whose geographical coordinates are at any point no more than 3 miles from the line of coast of the State, corresponding to the medium tide height, and the probability of the significant wave height exceeding 1.5 metres is smaller than 10 per cent for a period of one year for all-year-round operation, or for a specific period for seasonal operation, such as summer period operation.

Similarly, under Article 4(4) of Directive 2009/45/EC, Regulation 4(2) of S.I. No. 676 of 2019 and Regulation 3(2) of S.I. No. 640 of 2020, passenger ships are divided into classes (see Table 2 below) according to the Sea Area in which they may operate.

Such passenger ships are issued with a Passenger Ship Safety Certificate under S.I. No. 676 of 2019 in accordance with European Union Directive 2009/45/EC or a Passenger Ship Certificate in accordance with S.I. No. 640 of 2020.

"Class A"	means a passenger ship engaged on a domestic voyage in Areas A, B, C and D
"Class B"	means a passenger ship engaged on a domestic voyage in Areas B, C and D
"Class C"	means a passenger ship engaged on a domestic voyage in Areas C and D
"Class D"	means a passenger ship engaged on a domestic voyage in Area D.

The outer limits of the smooth water areas specified in the second column above shall be taken to be the corresponding inner limits of the partially smooth water areas specified in the third column.

Unless otherwise indicated, these limits apply at all times of the year.

In the above Table, "summer" means the months of April to October inclusive, and "winter" means the months of November to March inclusive.

"Favourable Weather"

As defined in the Merchant Shipping (Passenger Ship Construction and Survey) Rules 1985 (SI 274 of 1985), favourable weather "means fine, clear settled weather with a sea state such as to cause moderate rolling and/or pitching", and as defined in the Merchant Shipping (Passenger Boat) Regulations 2002 SI 273/2002, as amended, favourable weather "means weather when the visibility is good and when the combined effects of wind, sea and swell on the passenger boat are never greater than those which would cause moderate rolling or pitching or result in the shipping of green seas on the weather deck or, in the case of an open boat, over the gunwhale."

Weather conditions should be such that passengers are not unduly wetted by spray or unduly discomforted by the motion of the vessel.

It is appreciated that each passenger ship may behave differently in varying weather conditions. Factors such as the size, type and sea-handling capabilities of the passenger ship together with its intended area of operation must be taken into consideration by the Master prior to each voyage. The Master should have a sound working knowledge of the ship and should be familiar with the behaviour of the vessel under varying weather conditions. The Master should have a good knowledge of the area of operation and should have an updated weather forecast to hand prior to each journey.
