

Minister's Foreword

Rural Ireland makes a huge contribution to our economy and society. Rural areas support innovative industries of varying sizes, across a wide range of sectors, from the traditional to more modern industries. Our towns and villages are at the heart of rural communities, engaging in thriving community activity, attracting tourism, and preserving and developing our creativity and culture.

The Government is supporting rural communities across the country, through a wide range of initiatives, many of which are outlined in this Progress Report. The cross-Government approach of the Action Plan is reaping rewards, with Ireland's economy growing and unemployment falling in the regions. Key impacts include:



- Between Q1 2015 and Q2 2018 there has been an increase in numbers employed of 146,400 in regions outside of Dublin and 240,600 additional jobs nationwide.
- 281 projects were funded under the Town and Village Renewal Scheme in 2017. A further 224 projects were approved for funding of €21.2 million under the 2018 scheme. This brings to over 670 the total number of projects support by the Government under this scheme since the second half of 2016.
- A total of 1,567 allocations, with a total value of almost €46 million, were made to projects outside of Dublin under the Sports Capital Programme.
- The development of a new tourism brand for the Midland region, "Ireland's Hidden Heartlands" has been launched by Fáilte Ireland, further boosting employment in local economies.

Earlier this year Project Ireland 2040 built further on the commitments in the Action Plan for Rural Development. The National Planning Framework sets out a strategic objective of Strengthened Rural Economies and Communities. It places a focus on supporting the traditional pillars of the rural economy, diversifying rural economies and strengthening our rural communities so that they remain great places in which to live, work and raise a family.

The Rural Regeneration and Development Fund, launched in May 2018, further demonstrates this Government's commitment to supporting rural development. The Fund will provide an additional €1 billion investment for collaborative and complementary projects to transform our rural towns and villages and outlying rural areas. The Fund will further support rural renewal, and deliver real and lasting impact for people who live and work in rural areas throughout Ireland.

As Minister for Rural and Community Development I am committed to ensuring the measures set out in the Action Plan for Rural Development continue to be delivered and that the positive impacts of both policy measures and increased investment in rural Ireland are felt throughout the country. I look forward to continuing to working with my colleagues throughout Government to achieve this goal.

Executive Summary

Background

Realising our Rural Potential, the Government's Action Plan for Rural Development, was launched in January 2017. The Action Plan contains 277 actions for the delivery across Government, State agencies and other bodies over the next three years to support the economic and social progress of rural Ireland.

The actions are broken down across 5 thematic Pillars as follows:

Pillar 1: Supporting Sustainable Communities
 Pillar 2: Supporting Enterprise and Employment
 Pillar 3: Maximising our Rural Tourism and Recreation Potential
 Pillar 4: Fostering Culture and Creativity in rural communities
 Pillar 5: Improving Rural Infrastructure and Connectivity

Each action has been assigned to a lead body which is responsible for implementation of the action. Progress on the implementation of the actions is overseen by a Monitoring Committee which includes senior representatives of relevant Government Departments and key rural stakeholder interests.

Progress Reports on the implementation of the Action Plan are published twice-yearly. Following on from an interim Progress Report in May 2017, the first Progress Report was published in August 2017, followed by the second Progress Report in May 2018. These reports are available on the website of the Department of Rural and Community Development at www.drcd.gov.ie.

Summary of Progress

This Third Progress Report outlines the progress which has taken place in relation to all of the actions due for delivery between January and June 2018, or which are being implemented on an ongoing basis over the course of the three year Action Plan.

A total of 275 actions are reported on in this latest Progress Report, covering measures due for delivery between January and June 2018, or which are being implemented on an ongoing basis. Of the actions reported on, 266 have been completed or are substantially advanced, representing a delivery rate of 96%. 9 actions due for delivery were delayed. These are summarised in the following table.

Key Developments and Case Studies

Pillar 1 – Supporting Sustainable Communities

The objective of this Pillar is to make rural Ireland a better place in which to live and work; to achieve this, we must support our rural communities. We need to enhance local services, support social cohesion and empower the people that live in our communities to ensure that their voices are heard.

- 281 projects were supported across the country under the <u>Town and Village Renewal Scheme</u> in 2017 to a value of €21.6 million. A further 224 projects were approved for funding of €21.2 million under the 2018 scheme. (Action 1, DRCD)
- 2. On 11 October a pilot scheme was announced to develop innovative <u>proposals to encourage town centre living</u>. The pilot will involve six rural towns (Boyle, Callan, Ballinrobe, Banagher, Castleblayney, Cappoquin). Each of these towns will receive funding of up to €100,000 to engage with their communities and local businesses, and arrive at practical solutions that can be delivered to achieve the objective of increasing the number of people living in rural towns. The lessons learnt through the pilot will inform future investment in rural towns and villages. (Action 2, DRCD)
- 3. As part of Budget 2018, additional capital funding was secured to increase the <u>Social Housing Build</u> Acquisition and Leasing targets under Rebuilding Ireland from 47,000 to 50,000 units, with a greater emphasis on accelerating new build activity. Budget 2019 has now secured further capital funding, to increase 2019 targets by a further 460 homes, or 10,000 units overall. Strong progress against these targets is already being made. The latest quarterly Construction Status Report (Q2 2018) includes 1,067 schemes (or phases), delivering 16,351 homes a substantial increase on the 11,049 homes which were in the programme at the end of the same quarter last year. (Action 5, DHPLG)
- 4. Draft Planning and Development (Amendment) No. 2 Regulations 2018, relating to change of use of vacant commercial properties into residential units, were signed into law on 8 February 2018, bringing them into operation with effect from that date. In addition, in July the Planning and Development (Amendment) Act 2018 relating to derelict sites was signed into law, commenced upon enactment. These legislative changes will strengthen the powers of local authorities to tackle dereliction and facilitate urban regeneration. (Action 6, Action 8, DHPLG)
- 5. Under <u>CLÁR</u> 2017, €6.9 million was provided for 231 projects, providing funding for small scale infrastructural projects in disadvantaged rural areas that have experienced significant levels of depopulation. The 2018 CLÁR programme was launched on 15 March 2018. Total funding of €8.7 million was allocated to 310 projects across Measures 1-3 in June and July 2018. Further funding has been

- announced under Measure 4 (Mobility and Cancer Care Transport) to the value of €1.5m in August 2018 programme (Action 10, DRCD)
- 6. The Heritage Council, in partnership with the Department of Agriculture, Food and the Marine, manage an annual grants scheme for the <u>conservation and repair of traditional farm buildings</u> and related structures for farmers in the Green Low-Carbon Agri-Environment Scheme (GLAS) scheme. In 2018, it is anticipated that up to 59 projects, comprising 97 buildings, will be supported under the scheme. (Action 14, Heritage Council)
- 7. The Department of Rural and Community Development is on course to provide, by the end of 2018, €3.7 million <u>funding for Volunteer Centres and Volunteer Information Services</u>, as well as national organisations such as Volunteer Ireland, which aims to strengthen those organisations and foster a culture of volunteering in Ireland. (Action 19, DRCD)
- 8. A new pilot initiative called '<u>Digital Assist</u>', which enables local post office to be used as a digital gateway for Government business, has now been launched. The Minister for Communications, Climate Action and Environment unveiled the first "Digital Assist" unit in Ballymore Eustace on 1 October 2018 (Action 20, DCCAE)
- 9. 257 GP practice units are in receipt of supports under the <u>Rural Practice Support Framework</u>, encompassing 347 individual GPs benefiting under the new scheme. This is a significant increase in the number of GPs benefitting from rural supports, which stood at 167 prior to the introduction of the new scheme in May 2016. (Action 24, HSE)
- 10. Between January and end June 2018, 9 <u>Primary Care Centres</u> have become operational. These are in Ballymote, Co Sligo; Ballinrobe, Co Mayo; Claremorris, Co Mayo; Westport, Co Mayo; Boyle, Co Roscommon; Wexford Town, Co Wexford; Kilcock, Co Kildare; Carrick-on-Suir, Co Tipperary; Drogheda North, Co Louth. A further two, in Dungarvan and Tullamore, will also become operational in 2018 and will complete the delivery of the 18 Primary Care Centres. (Action 28, HSE)
- 11. Since 2015, annual funding of up to €50,000 has been provided by the Department of Rural and Community Development in respect of each <u>Public Participation Network</u>, supplemented by at least €30,000 from the relevant local authority. Funding is used for the purposes of developing the PPN including the cost of employing a Resource Worker, renting office space and other ancillary expenses incurred in carrying out activities. (Action 37, DRCD)
- 12. Over 1,300 projects have now been approved for <u>LEADER</u> funding, representing a value of over €39 million, with a further 295 projects at various stages of the approval process. In this year alone, over €20m in funding has been approved for a myriad of projects across all programme themes, demonstrating the increased level of engagement with rural communities by the LAGs. The LEADER Food initiative was launched on the 1st May 2018. An overall budget of €15 million is being made available for the artisan/small food and beverage businesses, with an initial tranche of at least €5 million in 2018. (Action 47, DRCD)

- 13. To date in 2018, the Minister for Agriculture, Food and the Marine has announced the award of €3.1 million in EMFF <u>FLAG grants</u> to 247 beneficiaries. These investments will add to the €1.8 million paid out in 2017 by the 7 FLAGs. Successful projects included investments in micro seafood enterprises, marine tourism and marine leisure projects, heritage projects, small harbour facilities, and environmental and training projects. (Action 48, DAFM)
- 14. The new <u>Social Inclusion and Community Activation Programme</u> (SICAP) commenced on 1 January 2018 and will run until the end of 2022. It replaces SICAP 2015-2017. SICAP 2018–2022 has supported a total of 1,386 local community groups with over 5,000 interventions recorded for mid-year 2018. SICAP 2018-22 has supported 14,155 clients from target groups such as low income workers, disadvantaged young people, disadvantaged women, lone parents, the unemployed. In doing so the programme has supported lifelong learning and community education opportunities for disadvantaged communities and individuals. Over 42,000 interventions were recorded to date for mid-year 2018. The average number of interventions per Individual was 3. (Action 49, DRCD)
- 15. Up to June 2018 just under 2,000 recruits have attested as members of An Garda Síochána and have been assigned to mainstream duties nationwide. A further 400 recruits will attest before the end of this year. It is anticipated that the overall number of Gardai will stand at approximately 14,000 by the end of 2018. As at 31 May 2018 there were approximately 2,300 civilians employed in An Garda Siochána. The number of civilians working in An Garda Síochána continues to increase. (Action 56, DJE)
- 16. On 02 January 2018, the Minister for Justice and Equality announced that his Department would be providing an additional €50,000 in financial support to Community Text Alert Groups as a further measure in this Government's support to crime prevention. This is in addition to the €100,000 which the Minister announced at the National Ploughing Championships in September 2017. (Action 59, DJE)
- 17. Under the <u>Seniors Alert Scheme</u> investment of €2.68 million was made in 2017. The 2018 spend is estimated to be in the region of €6 million. The Scheme has a total of 33,217 participants as of 31 July 2018. This represents an increase of 100% (16,290 new participants) since the relaunch of the scheme in October 2017. (Action 61, DRCD)
- 18. Men's Sheds: The reach, scale and ambition of Sheds for Life has continued to expand in 2018. As well as the expanded offering to shed members, such as the large-scale Health Expo being arranged for the IMSA's annual conference in Cork, a major research project, run in conjunction with the Irish Research Council and the Waterford and Carlow Institutes of Technology, will commence in October 2018. (Action 67, Irish Men's Sheds Association)

Case Study: Supporting Sustainable Communities

Town and Village Renewal Scheme: Cnoc na Gaoithe Centre, Co. Clare

Formerly a Mercy Convent the building in Tulla, Co. Clare, now operates as a cultural centre known as Cnoc na Gaoithe (Windswept Hill), run by the renowned Comhaltas organisation. The centre opened its doors in 2012 and has thrived ever since, teaching traditional Irish music, song, dance and Irish language, along with classes teaching computer skills, French language, yoga and meditation. Top class musicians, singers and dancers have emerged from the centre since its opening, with many All-Ireland titles to their name. Cnoc na Gaoithe has taken performing groups to Europe, America and China. The centre has also hosted groups from Washington D.C., Shetland Islands, and Norway.



In order to build on the success of the existing centre and continue to attract national and international groups, students and visitors Clare County Council have expanded the services of Cnoc na Gaoithe by offering accommodation. The proposed expansion sought to turn the first floor of the building into facilities capable of hosting up to 30 visitors. This project came to fruition using the €100,000 in funding provided by the Town and Village Renewal Scheme.

The images below show before and after pictures of the community room which was just one of the rooms renovated for the accommodation section. Additionally there were also bedrooms, en-suite bathrooms and a hallway renovated.

The project was completed in June 2018 and opened its doors to the public on the 1 July 2018. This expansion of Cnoc na Gaoithe is also set to generate prosperity for the wider community of Tulla and Clare. The availability of accommodation allows the centre to offer week long workshops and also packages which combine these workshops with afternoon tours to the attractions of County Clare. Literary and wellness retreats can also now be facilitated in the centre.

Due to the increase in visitors that these activities will attract, Cnoc na Gaoithe will also become a tourist information point with stands containing information about tourist attractions all over Clare and also flyers from businesses like local restaurants, pubs and shops. It is also expected that additional employment opportunities will be created due to the influx of visitors to the area. Furthermore this refurbishment completes the restoration of a listed building in the village which is of significant historical, heritage, and conservation importance.

Case Study: Supporting Sustainable Communities

A Framework for Town Centre Renewal

Towns and villages across the country face many challenges in creating vibrant, thriving town centres. Addressing the challenges of town centre renewal was identified as a key issue by members of the Retail Consultation Forum as a means of strengthening recovery in the retail sector, both in terms of sustainable jobs growth and retail sales.

The Retail Consultation Forum is an initiative of the Department of Business, Enterprise and Innovation, established to provide a platform for structured engagement between the Retail sector and relevant Government Departments/bodies. The Retail and Town Centre Renewal Working Group, as part of the Retail Consultation Forum, was set up to examine and identify practical ways to give effect to recommendations that focused on making towns and village centres better places to work, shop and live in. The objective of the Working Group was to develop a Framework for Town Centre Renewal.

The Framework, published in 2017, sets out the key characteristics of a successful town centre and identifies both existing supports and best practice examples from

around the country. The Framework includes an Action Plan for Town Centre Renewal which is intended to be a blueprint for policy makers, Local Authorities and key stakeholders in towns and villages, guiding them through the three stages of town centre renewal:

- 1. Stakeholder Engagement and Health Check The first step is to prepare a database of all key stakeholders in order to engage with them as part of the Health Check. Carrying out a Health Check will give the stakeholders vital information on the key attributes and opportunities within the town, which will help inform a Town Centre Plan.
- 2. Establish a Town Centre Management Partnership or "town team" A core group of key stakeholders should be brought together as a Town Team or Partnership to oversee the recommendations of the Health Check and development of a Town Centre Renewal Plan.
- 3. Prepare and Implement a Town Centre Plan The Town Team needs to prepare a Town Centre Plan which sets out the vision for the town, the strategy of key objectives, priority projects and measurable goals or Key Performance Indicators. The Plan needs to be implemented, monitored, and reviewed.

The Framework also includes a number of case studies which provide practical examples of best practice from a number of towns and villages around the country which demonstrate the significant improvements that can be achieved through the dedication and hard work of the people throughout Ireland who are passionate about their town or village. A number of recommendations in the Framework document are being progressed. For example, as part of the collaborative Town Centre Health Check Training Programme, managed by The Heritage Council, pilot Town Centre Health Checks are underway in seven towns (Ballina, Cashel, Ennis, Dundalk, Monaghan, Naas, Tralee). To date Town Centre Health Check reports have been published for Tralee, and Ennis.

Pillar 2 - Supporting Enterprise and Employment

The focus of this Pillar is on supporting enterprises to start up and grow, and supporting job seekers in rural areas to access jobs. Increasing employment opportunities for people across all regions of the country is a key objective for the Government. Supporting the growth of enterprises at regional level – whether start-ups, scaling companies or FDI companies – will bring increased job opportunities for people who live in in rural areas, and will increase economic activity in rural areas.

- 1. In 2015 the Regional Action Plan for Jobs initiative was launched, supporting a key Government ambition to create 200,000 new jobs by 2020, 135,000 of which would be outside of Dublin. Progress across the eight regions has been very positive since the launch, with an increase in numbers employed of 146,400 from Q1 2015 to Q2 2018 in regions outside of Dublin and 240,600 additional jobs nationwide. In April, Minister Humphreys requested that the Regional Action Plan for Jobs Implementation Committees in each region lead a process to 'Refresh and Refocus' their Plans to ensure their relevance out to 2020. (Action 68, DBEI)
- 2. In May 2017 Enterprise Ireland launched the Regional Enterprise Development Fund (REDF) with funding of up to €60m, designed to support the ambition, goals, and implementation of the Regional Action Plans for Jobs. The second call for projects from the remaining balance (approximately €30m) of the €60m budget available opened for applications on 16 April and closed on 28 June 2018. The results of the second call will be announced during Q3/Q4 2018. (Action 69, Enterprise Ireland)
- 3. IDA's current strategy places a large focus on winning investments for the regions. IDA have some significant announcements in regional locations across the country to date in 2018, which include 600 jobs in the Mid-West at Edwards Life Sciences, and 400 new jobs promised for Dundalk by Chinese life sciences company Wuxi Biologics. There were also two significant announcements in Longford in Avery Dennison and Red Seal Sups, bringing 300 jobs to the Midlands region. IDA will finish its current programme of regional property investment with new Advanced Buildings in Limerick, Dundalk and Waterford. There have been 344 investments approved for the regions in the three and a half years of the IDA's current five year Winning strategy. (Action 70, IDA)
- 4. As part of a €150m property investment programme IDA Ireland has directly completed the construction of five new Advance Building Solutions under the current building programme and has successfully secured investments for three of the buildings at Waterford, Athlone and Sligo. The two remaining buildings, Castlebar and Tralee, are being actively and extensively marketed by IDA. In 2018 IDA is continuing with the building programme with three buildings currently under construction in Limerick, Waterford and Dundalk and tenders recently received for the planned Galway. There are also buildings planned for Athlone and Carlow. (Action 71, IDA)
- 5. In Q1 2018, LEOs organised over 300 events during '<u>Local Enterprise Week</u>' across every Local Authority area. These events included one-to-one business clinics, start your own business boot

- camps, finance workshops, trading on-line seminars, data protection briefings and Brexit-themed workshops. (Action 74, LEOs)
- 6. The development of the <u>Atlantic Economic Corridor</u> is being progressed with the aim to attract investment, grow jobs and economic opportunities in the western region. AEC Officers in local authorities across the Corridor are working to further develop and progress the initiative at local level. A website <u>www.atlanticeconomiccorridor.ie</u> was launched in June to promote the opportunities available across the Corridor. (Action 78, DRCD)
- 7. In partnership with DCU Ryan Academy, Boeing, Datalex, the Irish Aviation Authority and Enterprise Ireland has successfully launched 'Propeller Shannon' an aviation/aerospace start-up accelerator programme, which will drive the development of innovative Irish and international start-up companies in the aviation sector. The initiative will provide them with the opportunity to tap into the unique aerospace ecosystem that has seen over 60 companies employ over 2,600 people in Shannon Free Zone, reaffirming its position as the largest Aviation/Aerospace cluster in Ireland. (Action 84, Shannon Group)
- 8. Over 150 female entrepreneurs have taken part in ACORNS to date. Many report increased sales, exports and job creation. Progress made by participants on most recent programme demonstrates these encouraging outcomes: Participants reported an increase in annualised sales of 97% over the six months of the cycle. There were nine participants that became exporters for the first time, representing an increase of 112%. There were 13 additional full-time employees and 19 additional part-time employees hired during the period. A new cycle of the ACORNS programme was launched in August 2018 by the Minister for Agriculture, Farming and Marine. (Action 94, DAFM)
- 9. The Audiovisual Action Plan launched in June 2018 is an industry-wide, long-term plan, under the Creative Ireland Programme, which will support the Government's ambition to <u>enable Ireland to become a global hub for the production of Film, TV drama and animation</u>. The Action Plan is underpinned by an Economic Assessment of the Audio-Visual Industry in Ireland, carried out by international consultants Olsberg SPI with Nordicity. (Action 95, DCHG)
- 10. Implementation of Ireland's Seafood Development Programme is funded under the European Maritime & Fisheries Fund (EMFF) Operational Programme 2014-2020, which is in its third full year of operation, with 19 support schemes currently operational. Investment to end 2017 was €58 million, with expected investment of €40 million forecast for 2018. Areas being funded include Fisheries, Aquaculture, Data Collection, Control & Enforcement, Fisheries Local Action Groups (FLAGS), Seafood Processing and Integrated Maritime Policy. (Action 111, DAFM)
- 11. Following the publication of the National Policy Statement on the Bioeconomy in March 2018, an Implementation Group consisting of representatives from key Government Departments and State Agencies has been established to address a number of key actions for the future success of the Bioeconomy in Ireland. The Bioeconomy promotes the more efficient use of renewable resources supporting economic development and employment in rural Ireland. (Action 118, DCCAE)

- 12. Since the establishment of the <u>Regional Skills Fora</u> there is a greater focus on strengthening and establishing positive relationships between employers and the education and training system in the different regions. 2018 trends show Manufacturing, Construction and ICT continue to be the three main sectors engaged with by the Regional Skills Fora and the focus of engagement continues to be with Small, Medium and Micro Enterprises (60% of interactions in 2017). Audits of skills needs within individual enterprises continue to be carried out by the Regional Skills Forum Managers in each of the nine regions as part of the Skills for Growth project. (Action 121, DES)
- 13. To date 11 new <u>apprenticeships</u> (2 in 2018) are operational. A further 10 programmes are scheduled to get underway during 2018. As of 30 June 2,280 new apprentices registered on apprenticeship programmes in 2018. A total of 14 new traineeships (4 in 2018) have now been developed with 1,184 enrolments to-date in 2018. Apprenticeships and traineeships are regionally dispersed and offer good opportunities for training and employment in the regions. (Action 122, DES)
- 14. In April 2018, <u>Tech Week</u>, Ireland's national festival of technology aimed at students, parents and the public, took place all over Ireland. Over 120,000 students took part in a range of fun activities, including the finals of several national Tech Week events. (Action 125, SFI)
- 15. In the first half of 2018, SFI funded five awards for research proposals in <u>Smart Agriculture/Precision</u>
 <u>Agriculture</u> to improve farm management and increase quality of life for farmers in rural Ireland. The combined value of these five awards was greater than €5 million. (Action 126, SFI)
- 16. During Q1 2018, 1,103 training places were provided to industry professionals through the ConnectEd Programme which aims to provide businesses and professionals working with the agrifood sector structured access to Teagasc research, education, knowledge resources and online tools. Eleven regional economic briefings were delivered across the country during February and March. (Action 130, Teagasc)
- 17. The Opt-In portal, aimed at helping rural dwellers find the means and skills necessary to increase their income generating options, is now live and has over 300 people registered to receive information. The ETBs and LEOs have agreed automated update of the Opt-in Website from their respective websites and the portal is also being used by LEADER, Skillnets and Teagasc to promote their respective courses. (Action 133, DAFM)
- 18. In July, the <u>Dormant Accounts Action Plan 2018</u> was launched. Funding of almost €40 million was announced for 45 measures across 10 Departments and State Agencies. The measures provide supports for economically, educationally and socially disadvantaged people and people with disabilities in communities across the country. (Action 138, DRCD)

Case Study: Supporting Enterprise and Employment

Westire Technologies Teo continue to brighten our nights!

Westire Technologies Teo, based in the idyllic northwest Mayo Gaeltacht town of Béal an Mhuirthead (Belmullet), design and manufacture photocells and photoelectric sensors that control streetlights. From this rural base on the Wild Atlantic Way, the company has invented and patented a ground-breaking technology in the streetlighting control space.

Westire Technology Limited, originally known as SELC IRELAND, was established in 1982 by Seán Noone with the support of Údarás na Gaeltachta. It was, and continues to be, an important employer in this rural Gaeltacht town which currently supports over 32 jobs in the area.



Seán, an astute electronic engineer and successful inventor, was inspired to develop the light sensor device now used on street lights and soon after setting up SELC, Seán and his team launched a ground-breaking Silicon Eye ambient light sensor. It became the industry standard globally as it switched on streetlights accurately and this led to energy efficiency and energy savings on street lights of up to 40%. This Gaeltacht company have brought a new meaning to street lighting controls, pioneering game-changing technologies such as: Silicon Eye Response Ambient Light Detectors. RAT Switching, Candelon PLC Communications, Smart HID Ballasts, Dimmable Electronic Ballasts and Astro Time Clocks.

With over 35 years' experience in the provision of photocell street lighting technologies, Westire Technologies are supplying Utilities, Lighting Luminaire OEM's, and Municipalities throughout Europe, North America, Canada & South Africa.

Údarás na Gaeltachta have supported Westire Technologies Teo and its predecessors every step of this inspirational journey, in a partnership that has supported enterprise and employment in the local area by encouraging innovation and skills development at every juncture.

Westire Technologies are committed to Research and Development and rely on the creative and diverse global team that they have assembled over the years to continue breaking new ground in the provision of world-class smart street light and smart city control products. From one of Ireland's most westerly points the world can look forward to continuous new breakthroughs in green technology development and in the Smart City green technology space.

So for anyone on a winter's evening stroll on a street lit path anywhere in the world it was most likely ground-breaking technology from the Béal an Mhuirthead Gaeltacht area that turned on the light for you!

Case Study: Supporting Enterprise and Employment

ACORNs Programme

The ACORNS programme, sponsored by the Department of Agriculture, Food and the Marine, addresses the skills, enterprise and capability gaps of rural start-up female entrepreneurs. The objective of ACORNS is to provide female entrepreneurs with the knowledge, support and networking opportunities to meet and even exceed their current aspirations. ACORNS (www.acorns.ie) is now in its fourth year, the latest round of the programme which will run from October 2018 to April 2019. In the course of the first three years, over 150 early stage female entrepreneurs were supported by ACORNS.

ACORNS 1: 43 entrepreneurs who participated in the pilot programme in 2016 availed of the opportunity to participate in a further development phase. The progress of these 43 entrepreneurs since their first involvement in ACORNS is very impressive. Their combined sales increased by just over €2million over the 15 months to the end of 2016, to €4 million (increase of 103%). The number of exporters increased to 11. Their combined employment increased over the 15 months by just over a third, to 107.



ACORNS 2: 55 participants completed ACORNS 2, which ran from October 2016 to April 2017. At the end of the cycle, 47 of the businesses were trading, including 9 that had started to generate sales for the first time during the cycle. Among those trading, there was a reported 21% increase in turnover over the six month cycle. 8 participants were already exporting before the start of the cycle, 3 more have since started to export.

ACORNS 3: Progress made by participants on this programme, which ran from October 2017 to April 2018, demonstrates these encouraging outcomes:

- Participants reported an increase in annualised sales of 97% over the six months of the cycle.
- There were nine participants that became exporters for the first time, representing an increase of 112%.
- There were 13 additional fulltime employees and 19 additional part-time employees hired during the period.

Past participants of ACORNS are also offered the opportunity to participate in a further development phase and to join the ACORNS Community, to ensure they continue to reap the benefits of the programme and of the valuable connections they have made through broadening their support network.

ACORNS has been selected to represent Ireland in the European Enterprise Awards 2018, *investing in entrepreneurial skills*.

Pillar 3 - Maximising our Rural Tourism and Recreation Potential

Tourism is a key driver of economic development in rural Ireland and this Pillar of the Action Plan aims to maximise the potential of the sector for the benefit of rural communities. In 2015, 85% of visitors to Ireland visited at least one region outside Dublin. With the revenue this generates in the regions, tourism has a significant role to play in supporting sustainable jobs and growth in rural areas and will be supported through targeted marketing initiatives and co-ordinated approaches at national and local level.

- Ireland's Hidden Heartlands, Fáilte Ireland's new experience brand for the Midland's region, campaign was launched in July 2018. An initial €2m has been allocated to start the development stage of the brand, with further funding to follow. This first round of investment will help to develop visitor experiences, support industry development and develop marketing campaigns for the region. (Action 153, Fáilte Ireland)
- 2. In January 2018, Tourism Ireland and Fáilte Ireland launched a joint initiative, specially designed to boost tourist numbers from Britain to the Wild Atlantic Way. A €1.35 million marketing campaign in Britain by Tourism Ireland is being complemented by a Fáilte Ireland €500,000 programme to support businesses along the Wild Atlantic Way to position themselves to benefit from the campaign, as well as to boost its own marketing campaigns in Northern Ireland. (Action 157, Tourism Ireland)
- 3. The <u>Strategy for the future development of National and Regional Greenways</u> was launched on 20 July 2018. The Strategy sets out how National and Regional Greenways in Ireland should be planned and constructed and is backed by a fund of €53m for the years 2019 to 2021. (Action 167, DTTAS)
- 4. The <u>Royal Canal Blueway in Mullingar</u> was officially launched in July. Blueway maps and promotional material for the Royal Canal Blueway in Mullingar have been created. An activity provider now operates from the Mullingar Blueway Hub, offering paddling and cycling facilities for members of the public. (Action 168, DCHG)
- 5. An indicative budget of €12 million is available to successful projects under the 2018 Outdoor Recreation Scheme. A total of 128 applications were approved for funding of €1.8 million under Measure 1 (Small Scale Maintenance/Promotion and Marketing) in September 2018. Successful projects under Measures 2 and 3 will be announced later in the year. (Action 170, DRCD)
- 6. Under the <u>Structures at Risk Fund</u> funding of €1.3 million is being provided in 2018 in respect of 76 projects. (Action 193, DCHG)
- 7. The <u>Historic Towns Initiative</u> was launched by the Heritage Council in early 2018 and capital funding totalling €1m has been made available under this Initiative. Projects in Youghal (Co. Cork), Carrick on Suir (Co. Tipperary), Kells (Co. Meath), Ballinrobe (Co. Mayo), Portlaoise (Co. Laois) and Kilmallock (Co. Limerick), have been offered a total of €1 million in capital funding. Works include conservation, public realm improvements and street scape conservation. (Action 196, Heritage Council)

Case Study: Maximising our Rural Tourism and Recreation Potential

Ireland's Hidden Heartlands

Following on from the highly successful worldwide marketing of the Wild Atlantic Way and Ireland's Ancient East, comes Fáilte Ireland's latest experience brand for the Midland's region, Ireland's Hidden Heartlands. The brand taps into the growing demand for soft activity holidays, offering visitors the chance to relax with friends and family, visit less well known areas, and experience nature at their own pace through a range of activities including walking, cycling, fishing, and boating. The Midlands region has an abundance of heritage sites and rich natural assets including its many lakes, walkways, and blueways, offering numerous options to explore the area.

Ireland's Hidden Heartlands covers the 'heart' of the country, from Leitrim down to East Clare and extending through Longford, Roscommon, East Galway, as well as parts of Westmeath, Cavan, North Tipperary and Offaly. The two central spines of the region are the River Shannon and the Beara Breifne Way, Ireland's longest inland walking and cycling trail, following the route taken by Gaelic armies during the early 17th century.



Activities available range from steering a cruiser along the Shannon, water sports and angling, to pony trekking and cycling trails that wind around the towns and small villages dotted along the Shannon and the Beara Breifne Way. There are castles, stately homes, award-winning pubs and restaurants, lakes, beautiful forests and even a mine to visit.

There is already considerable work taking place on the ground. A Shannon Master Plan is currently being developed by Waterways Ireland in partnership with Fáilte Ireland, to drive tourism opportunities both on and off the water and in the towns surrounding it. Work is also underway on an Activation Master Plan for the Beara Breifne Way, a long-distance route spanning the entire region that is another key asset for Ireland's Hidden Heartlands and where a compelling walking and cycling trail experience will be developed to international standards. This Plan will see a number of towns along the route identified as walking hubs to support this ambition and drive visitors into nearby areas.

While these key work strands will be central to Fáilte Ireland activity plans for 2019 and beyond, other plans also include the development of a food networks and trails, highlighting the local food scene and giving rise to further tourism and enterprise potential.

Outdoor Recreation Infrastructure Scheme: Royal Canal Greenway

The final section of the Royal Canal Greenway in Co. Longford was completed at the start of 2018, and officially opened by Minister Michael Ring in February. The 6km stretch of greenway between Ballymahon and Killashee was built by Longford County Council using €525,000 allocated from the Outdoor Recreation Infrastructure Scheme.



250 projects with a value of €13.6m were approved under the 2017 Outdoor Recreation Infrastructure Scheme to improve walking trails, greenways and other recreational amenities. Over €23 million has been allocated to almost 500 projects under this scheme since 2016.

With the opening of the Longford Greenway, there is now a continuous greenway along the Royal Canal all the way through counties Longford and Westmeath. This stretch of the Royal Canal Greenway provides an off-road cycling and walking route which will serve as a wonderful local amenity and encourage outdoor leisure activity within Co. Longford. It will also benefit tourism in the region and help attract visitors to the Longford area.

Opening the final section of the Royal Canal Greenway, Minister Michael Ring T.D. commented "According to Fáilte Ireland Tourism Facts 2016 over 2.5 million visitors engaged in either walking/cross country walking or cycling when they visited Ireland in 2016. This coupled with the increasing use of such facilities by our own population reinforces the importance of facilities such as the Royal Canal Greenway."

On 20 July 2018 the Minister for Transport, Tourism and Sport, Shane Ross and Minister of State for Tourism and Sport Brendan Griffin, launched the *Strategy for the future development of National and Regional Greenways* which sets out how National and Regional Greenways in Ireland should be planned and constructed and is backed by a fund of €53m for the years 2019 to 2021.

Pillar 4 - Fostering Culture and Creativity in Rural Communities

Many rural communities all over Ireland have a thriving arts scene and it is important that facilities and assets in rural areas are enhanced to strengthen the social fabric of rural life. This Pillar aims to increase access to the arts and to develop culture and creativity in rural communities. The Irish language is also a vital part of our culture and heritage and is a key resource in Gaeltacht communities.

- A total of €138,950 has been awarded to 15 projects in regional museums across the country under the <u>Regional Museum Exhibition Scheme</u> 2018 ensuring access to our cultural heritage for rural communities. (Action 204, DCHG)
- 2. A <u>Culture and Creativity Plan</u> in every county was included as part of the Creative Ireland programme. The plans were launched on 12 September 2018. (Action 211, LAs)
- 3. The <u>Creative Schools</u> initiative aims to put the arts and creativity at the heart of children and young people's lives by establishing a range of collaborative opportunities between schools and cultural organisations. The initiative is now taking place as a pilot in 150 schools, starting in September 2018, meaning more rural schools engaging with creativity in their school life and in the community. (Action 219, Arts Council)
- 4. The allocation for the <u>Irish-Language Assistants Scheme</u> increased by €230,000 to €1.02m in relation to the 2018/19 school year to facilitate the provision of language assistants in up to 136 schools throughout the Gaeltacht. The allocation for the Summer Camps Scheme increased by €30,000 in 2018 to €330,000 to facilitate over 200 summer camps for young people throughout the Gaeltacht in summer 2018. (Action 224, DCHG)
- 46 Festivals were funded under the Foras na Gaeilge <u>Festivals Scheme</u> with a budget of €116,379 approved. Applications under the <u>Drama Scheme</u> were approved in May 2018, with 18 Companies funded and a budget of €208,896 approved. (Action 229, Foras na Gaeilge)
- 6. Under <u>Foras na Gaeilge Schemes</u>, which create capacity building for young people in the Irish language community such as summer camps and special youth events, 86 Summer Camps were completed during Summer 2018 and 85 Youth Event Schemes approved for 2018/2019 (September to June). (Action 230, Foras na Gaeilge)
- 7. Under the <u>Techspace as Gaeilge</u> Initiative, the inaugural TechFéile event was held in Limerick School of Art and Design in April and the feedback from participants was very positive. Capital funding is provided to schools and youth groups to facilitate the purchase of equipment. STEM training will be provided by Camara Ireland in September/October in Kerry and Cork to teachers and youth club leaders. (Action 225, DCHG)

Case Study: Fostering Culture and Creativity in Rural Communities

Creative Schools



Creative Youth, A Plan to Enable the Creative Potential of Every Child and Young Person, was published in December 2017 as part of the Creative Ireland Programme. The Creative Youth Plan aims to give every child practical access to tuition, experience and participation in art, music, drama and coding by 2022.

The implementation stage of the five-year plan incorporates a number of actions commencing in 2018-2019. These include piloting Scoileanna Ildánaca/Creative Schools; piloting a Creative Clusters Schools Scheme to generate creative cultural and artistic projects; and developing creativity programmes for young people in disadvantaged communities.

Creative Schools is one of the key initiatives in the Plan and is led by the Arts Council in partnership with the Department of Education and Skills and the Department of Culture, Heritage and the Gaeltacht. The Creative Schools initiative aims to put the arts and creativity at the heart of children and young people's lives by establishing a range of collaborative opportunities between schools and cultural organisations. Schools will be partnered with a Creative Associate, who will support them in planning and implementing a creative programme for their school. The long term aim is for every school to be supported to fully embrace the arts and creativity.

Following receipt of applications from over 400 schools across the country, 150 schools have been selected to participate in the Creative Schools pilot programme beginning in September 2018. These include primary, secondary, special, DEIS and co-educational rural urban, single-sex and Irish-language medium schools, as well as Youthreach centres.

Case Study: Fostering Culture and Creativity in Rural Communities

Local history comes to life online - The Irish Community Archive Network

The National Museum of Ireland has partnered with the Creative Ireland Programme to encourage communities across the country to document and digitally safeguard the irreplaceable artefacts of their local heritage. The Irish Community Archive Network (iCAN) works with community volunteer groups to create online digital archives that record and reflect each locality's particular history, heritage and culture.

The strength of a community can often depend on how connected its people feel to it. With iCAN, active citizenship is bolstered and tangible creative engagement with cultural heritage grows. From old photographs to birth certs, children's toys to musical instruments, not to mention the stories people passed down from generation to generation, all of this contributes to the jigsaw that is a community's story. Community archives encourage all to collaborate with, and take ownership over these local collections.

Getting involved enables the community itself to curate its story onto custom-built 'community archive' websites, ensuring all manner of precious artefacts and memories are safely stored online for future generations and for the global Irish diaspora.



'Community archiving' is a relatively recent practice in Ireland and the National Museum of Ireland is the first National Cultural Institution to facilitate a project of this kind. With 2018 the European Year of Cultural Heritage, this is a timely opportunity to begin the process of documenting local history and heritage.

The project is taking place right across the country and will offer unprecedented insight into the life and history of individual Irish communities. In addition to learning about their history and heritage the initiative will get people learning new skills and connecting with others within their community and beyond.

The website www.ouririshheritage.org offers groups, schools or individuals with an interest in their local history and heritage an opportunity to contribute stories, memories, snapshots, research and observations of life around the country. The archive on the website contains information submitted by people from Ireland and abroad, with many of the photos, records, testimonies and memories having never before been published.

Pillar 5 - Improving Rural Infrastructure and Connectivity

The objective of this Pillar is to improve the connectivity of rural communities through improved broadband connection, improved transport links, and by reducing the risk of flooding in vulnerable areas.

- 1. The Government's <u>National Broadband Plan</u> aims to ensure high speed broadband access to all premises in Ireland, regardless of location. In 2012, approximately 700,000 or 30% of the 2.3 million premises in Ireland had access to high speed broadband. As of Q2 2018, this has risen to over 7 out of 10 of the 2.3 million premises in Ireland have access to high speed broadband. This includes 175,000 premises passed as of Q2 2018 as part of in the eir rollout of high speed broadband to 300,000 rural premises. (Action 232, DCCAE)
- 2. So far this year, DRCD has hosted five <u>Regional Action Group</u> (RAG) meetings. These meetings allow DRCD, DCCAE and other stakeholders to meet with Broadband Officers and other Local Authority personnel. The RAGs also provide a networking opportunity for Broadband Officers leading to the sharing of experiences, innovation, planning and co-ordination. (Action 235, LAs & DRCD)
- 3. DRCD has engaged the services of Indecon Economic Consultants to research and produce local Digital Readiness Assessments for all local authorities. These Assessments provide local authorities with the quantitative data needed to identify where their digital strengths and weaknesses are when preparing their Digital Strategies which are due to be completed by year end. (Action 236, DRCD)
- 4. Between January 2017 and June 2018, over 29,000 citizens, including 3,500 unemployed people, received training under the <u>Digital Skills Training Programme</u>. 28% of participants have stated that the skills learned will improve their job prospects and 60% of all trainees now feel competent to use online government services. (Action 237, DCCAE)
- 5. ComReg is in the process of developing a <u>national 'coverage map'</u> to help mobile phone users understand the quality and extent of coverage across Ireland. This map will show coverage across 2G, 3G and 4G platforms for all networks. (Action 245, COMREG)
- 6. DRCD and the Department of Communications, Climate Action and Environment are actively engaged with local authorities and mobile phone operators to address the issue of mobile phone blackspots. Specific measures in progress include: a mapping exercise to identify priority mobile phone blackspots and identify any infrastructure that could potentially be used to improve mobile coverage in these blackspot areas. (Action 246, DCCAE)
- 7. The second annual <u>Mobile Phone and Broadband Taskforce</u> was held on 12 October. The event brought together key stakeholders to engage in open dialogue, to discuss issues impacting on

- broadband and mobile phone coverage and to identify solutions to those challenges in order to enhance and improve services. (Action 247, DRCD)
- 8. A programme of <u>island infrastructure works</u> totalling over €1 million, has been agreed between the Department of Culture, Heritage and the Gaeltacht and relevant local authorities, for 2018. Project Ireland 2040 specifically refers to capital investment for marine infrastructure at Inis Oírr and Inis Meáin, County Galway and for Toraigh, County Donegal. This will greatly benefit those islands. (Action 250, DCHG)
- 9. New evening and night time Local Link Services were officially launched in Tipperary and Kerry in June 2018. Following a funding call, all 17 Local Link companies have been awarded funding to deliver a total of 64 new evening services nationally. These services will run until December 2018 on a pilot basis. (Action 252, NTA)
- 10. The 2018 <u>Local Improvement Scheme</u>, which covers improvement works on small private/non-public roads, was launched in February, with an indicative allocation of €10.8 million. A further €10 million in funding was announced in October. In total, since the Scheme was re-launched in 2017 over €37 million has been allocated, and over 1,100 individual roads have benefited. (Action 259, DRCD)
- 11. €17 million in additional capital funding was secured for the Regional Airports Programme as part of last year's Review of the Capital Plan, which will be available in the period 2019 to 2021. €21.7 million is being provided in 2019, an increase of €8 million over 2018. Funding under the Regional Airports Programme helps to support capital investments and operational aid in the areas of safety and security at the airports, as well as PSO air services between Dublin/Donegal and Dublin/Kerry. (Action 260, DTTAS)
- 12. The Government's National Development Plan 2018–2027 includes a total funding allocation of €940 million over the lifetime of the Plan to underpin the delivery of the existing <u>flood relief capital works</u> <u>programme</u> and additional recommended prioritised flood relief schemes. The annual allocation for flood defence measures will increase to €100 million by 2021 demonstrating the priority placed by the Government on addressing Ireland's flood risk. (Action 264, OPW)
- 13. An interagency taskforce to develop measures to revitalise the <u>Uíbh Ráthaigh Gaeltacht</u> area in Co. Kerry was established in September 2017 and has held a number of meetings to date. As part of research, a survey of those who have left the South Kerry area in the last 10 years has been completed. The Taskforce is finalising a comprehensive action plan for publication, and exploring funding options to resource the implementation of the action plan. (Action 277, Údarás na Gaeltachta)

Case Study: Improving Rural Infrastructure and Connectivity

Local Link

The National Transport Authority manages the Rural Transport Programme now operating under the 'Local Link' brand, and funded by the Department of Transport, Tourism and Sport. 17 Local Link Offices (Transport Coordination Units) around the country manage the delivery of the Local Link services on behalf of the NTA, including approximately 1,000 Public Bus Services in local and rural areas. During 2017 1.9 million passenger journeys were completed, these figures include 0.2 million passengers who required assistance. Over 400 private operators provide the services using almost 900 drivers. The funding allocation for Local Link services for 2018 is €14.9 million.



In June 2018 Minister for Transport, Tourism and Sport Shane Ross officially launched the nationwide new evening Local Link services. The new services are aimed at addressing unmet transport needs and social isolation in rural areas, and will run until December 2018 on a pilot basis.

A total of 65 additional services were approved for funding, throughout the country, covering all 17 Local Link areas. The new services in Kerry cover two loops from the outskirts of Listowel Town into the town centre, and will operate on Friday nights, offering door to door pick-ups for customers who wish to access services and amenities in the town. Local Link Kerry already co-ordinates 160 routes in rural Kerry, the weekend service is an extension of the existing network used by 150,000 passengers a year in the county.

In July 2018 Donegal Local Link and Fáilte Ireland announced a collaborative partnership aimed at improving public transport links between key attractions, while also promoting Local Link services on a county level. Speaking at the launch, Minister of State Brendan Griffin said: "In addition to providing a local transport service, the new routes resulting from this partnership will greatly enhance visitors' ability to access a range of tourism attractions along the Wild Atlantic Way, thus enhancing the tourist experience and further growing the brand".

Case Study: Improving Rural Infrastructure and Connectivity

gteic Gréasán Digiteach na Gaeltachta

gteic Gréasán Digiteach na Gaeltachta is a network of 31 innovation & digital hubs with high speed broadband connectivity to be developed by Údarás na Gaeltachta in locations throughout Ireland's Gaeltacht Area. The innovation hubs are to be dotted along the majestic Wild Atlantic Way in Donegal, Mayo, Galway, Kerry and Cork in addition to Waterford



and Meath in Ireland's Ancient East. Six Gaeltacht islands and seven non-Gaeltacht islands also form part of this growing digital ecosystem, which is providing vital infrastructure and facilitating worldwide connectivity to these rural areas.

Four hubs have been opened to date in Gaoth Dobhair in Co. Donegal, Béal an Mhuirthead in Co. Mayo, An Cheathrú Rua (pictured) in Co. Galway and the Mol Teic/Dingle hub in Daingean Uí Chúis in Co. Kerry. It is expected that a further two *gteic* hubs will be completed and welcoming customers in Na Forbacha and Carna in Co. Galway by the end of 2018.

The *gteic* digital hubs will provide a vibrant network of high speed broadband facilities in rural Gaeltacht areas to stimulate job creation, to assist remote working, to encourage and enable the return of Diaspóra na Gaeltachta, to facilitate concept development and new business and to develop a community of hubs where the unique Gaeltacht culture drives creativity and innovation.

gteic hubs include hot desk and shared space facilities for remote workers and e-workers in addition, depending on location, to fully equipped office spaces and incubation units with high speed internet connectivity to facilitate innovation and concept development.

These developments will give the Gaeltacht community, both at home and abroad, an opportunity to return to or live in their home area by providing remote working opportunities at hot desks, co-working spaces or private offices at these hubs. This in turn will support, bolster and assist these unique language communities and help them to face the challenges of rural depopulation.



This growing digital ecosystem is providing an excellent opportunity for new technology companies to establish or locate themselves in the rural areas which encompass the Gaeltacht and for their employees to enjoy the excellent work-life balance that these picturesque areas can offer.
