

## Marine Notice No. 54 of 2019

Notice to all Fishing Vessel Owners, Agents, Shipmasters, Skippers, Fishers, and Masters, Seafarers and Yachtsmen

## S.I. No. 625 of 2019 - Harbours Act 1996 (Limits of Wexford Harbour) Order 2019

Notice is hereby given that the Minister for Transport, Tourism and Sport, in accordance with section 91 of the Harbours Act 1996, as amended by section 49 of the Harbours Act 2015, has signed into law the *Harbours Act 1996 (Limits of Wexford Harbour) Order 2019* - S.I. No. 625 of 2019. The Order will come into operation on 1<sup>st</sup> January 2020.

The purpose of the *Harbours Act 1996 (Limits of Wexford Harbour) Order 2019* is to define the limits of Wexford Harbour, being a harbour under the control or management of Wexford County Council. The original harbour limits were defined in the Wexford Harbours Act of 1874. Given the changes to the harbour's use over time, the limits of the harbour are being reset to more practical limits in line with the current use of the harbour.

The Order was made following consultations with Wexford County Council, the Marine Survey Office, the Marine Planning-Foreshore Section of the Department of Housing, Planning, and Local Government, Waterways Ireland and the Inland Waterways Association of Ireland.

With effect from 1<sup>st</sup> January 2020, the limits of Wexford Harbour are defined as the following:

- (a) the seaward limit consisting of an imaginary line drawn from Raven Point to Rosslare Point;
- (b) the inland limit being at the southern side of the Old Bridge on the River Slaney in Enniscorthy Town.
