Report of the Scoping Group on Sexual Violence Data		

1. Scoping Group on Sexual Violence Data

Background

In late 2017, the Government agreed to establish a scoping group to consider the availability of data and make recommendations on a national survey to identify the prevalence of sexual abuse and violence in Ireland today and emerging trends. The membership and terms of reference for the group are at appendix 1. In line with the terms of reference, a key consideration is the drawing up a set of data points that it considers relevant to the formulation of policy in this area.

The agreed terms of reference for the Scoping Group also provide that following the conclusion of the initial Scoping Group exercise on sexual abuse and violence, a reconstituted Scoping Group will consider the separate but related area of sexual harassment in the workplace. This work will take place as a second module. The Cabinet Committee on Social Policy will agree new Terms of Reference and revise, inter alia, representation on the Scoping Group for the second module of its work which will examine qualitative and quantitative data available to Government in respect of sexual harassment in the workplace and the adequacy of the framework in place to protect employees. More detailed terms of reference will be brought forward under the direction of the Taoiseach. That Group will also report no more than three months after its first meeting.

Meetings of the Scoping Group

The Scoping Group agreed a work plan at its first meeting on 5th January, 2018 which included 4 meetings. The agreed terms of reference provided that the Group would report to the Cabinet Committee on Social Policy within 3 months of the first meeting of the group i.e. by 5th April. The 3rd meeting of the Group had to be rescheduled due to storm Emma, and a revised reporting date of 19th April was scheduled by the Group.

Presentations from key NGOs were made to the Group at its meeting on 5th January and additional submissions received from the sector since then have been considered.

Following the 1st meeting of the Scoping Group, and in line with the Group's terms of reference and Work Plan, the Group's academic members prepared a paper on data points. This paper was presented to the Scoping Group for their deliberation and discussed at the 2nd meeting of the Group on 16th February. The Group's 3rd meeting was Monday 12th March when recommendations for a way forward regarding data points, survey methodology (mode, sample framework etc.), ethical considerations and the feasibility of sustainable/periodic data collection over time were considered. The Group's 4th and final meeting took place on 9th April.

Work of the Group

The Scoping Group members agreed that a new collection of data on the sexual abuse and violence in Ireland was necessary. The last major study that covered most of these areas – the Sexual Abuse and Violence in Ireland (SAVI) study – was conducted in Ireland in 2002. Data is needed to inform policy in several areas, including justice and equality policy, health and social service provision, education and children. The required data includes updated information on the prevalence of sexual abuse and violence, the forms it takes (including emerging forms of abuse involving the internet and social media), which groups are most at risk and the extent to which those experiencing this behaviour report it or seek services. While acknowledging that no one data collection exercise can meet all information needs for planning prevention strategies and support to those affected, a substantial overview study is needed so that the scope and nature of the problem can be established.

In accordance with the terms of reference as agreed with the Scoping Group, the methodology employed for the purpose of completing the work was as follows:

- The data points in SAVI (McGee et al., 2002) were examined as a point of departure. This formed the baseline data identified as needing to be made available to the Government for policy purposes in relation to the prevalence of sexual abuse and violence in Ireland.
- 2. Building on that original data involved the following steps:
 - a) Keeping original data points and variables as per SAVI where they remain relevant to the development of policy in the area;
 - Expanding and enhancing the original data points where emerging issues needed to be added or in order to reflect shifts in commonly-used terminology;
 - c) Deleting original data points that held no further relevance to the terms of reference so as to achieve a survey instrument length that was feasible for administration.

Other relevant international surveys were reviewed and cross referenced to identify gaps in the original data points and address those gaps by adding in new data points and variables not present in the original SAVI survey. These gaps are firstly specific to conducting a prevalence study on sexual abuse and violence in general, and secondly, specific to conducting such a prevalence study in an Irish context. A full bibliography (appendix 6) is available which sets out the research evidence drawn on in addition to the available international studies.

In-depth examination and deliberation on the data points prepared by the academic members of the Group resulted in the finalisation of the overview of the Work Book of data points, the Work Book itself (appendices 3 & 4) and the Explanatory Note Book for the Work Book (appendix 2) by the Scoping Group for the project going forward. The overview of the Work Book (appendix 3) is an abridged form of the Work Book (appendix

4) which the Group used as a framework for considering survey structure and overall feasibility of the project. The Work Book itself sets out the sections, data points and variables identified by the Scoping Group as integral to a prevalence study on sexual abuse and violence in Ireland. This Work Book of data points is NOT a questionnaire, but a listing of data points together with suggested item coding. Any successful tenderer will be required to develop the data points into a working questionnaire, taking account of question flow, overall length and clarity (which will also be assessed in the pilot study recommended to test the survey questionnaire – see Section 2 of this report entitled "Pilot").

Key Recommendations of the Scoping Group

The Scoping Group recommends that

- A comprehensive national survey on the prevalence of sexual violence, with a substantial number of participants should be undertaken.
- The survey should be repeated every ten years.
- In the intervening period, a range of supplementary data collection exercises to determine the experience of sexual violence of certain vulnerable and minority groups would be desirable.
- The data points identified in appendices 3 and 4 should all be included in the survey.
- The data points should be developed into a serviceable questionnaire which should be pilot-tested before the main data-collection exercise.

Recommendations in relation to methodology, project management and further detail in relation to recommended sustainability of the survey into the future are set out in the report. Details of the estimated cost of the project are being provided separately.

2. Methodology of the Survey

The recommendations in relation to the methodology of the survey are set out beneath.

Survey Mode

A number of modes of data collection, each with its own strengths and weaknesses, were considered by the group. Face-to-Face interviews with a self-completion component, for particularly sensitive topics, have traditionally been regarded as the 'gold standard' method of data collection. This method typically results in higher cooperation and lower refusal rates; it allows for longer, more complex interviews; higher response quality, and it can facilitate better multi-method data collection. Disadvantages include increased cost of administration, longer periods of data collection and concerns from interviewers and interviewees particularly around sensitive topics such as this topic.

For reasons, including the need to capture a nationally representative sample, an online survey is NOT recommended. Sexual abuse and violence are examples of sensitive topics on which people can be relatively reluctant to participate.

Given the sensitivity of the topic and the importance of respondent confidentiality, telephone interviewing offers a number of advantages. A random-digit dialling method can be adapted to afford the interviewee superior levels of anonymity and privacy relative to other methods. The centralised nature of interviewing work ensures that the quality of the interviewing can be monitored and that interviewers can be supported. Computer Assisted Telephone Interviewing (CATI) also facilitates efficiency in interview time and data set preparation. The electronic recording of responses avoids errors that can arise due to data entry and due to complex routing procedures. It is the Group's view that this approach has many merits not least that

survey participants are more likely to engage in such a survey rather than one face-toface and is the preferred option.

A primary concern for the Scoping Group was the length of time it would take an interviewer to complete the questionnaire. From the outset, the Group identified a larger set of data points than that presented in the current Work Book (appendix 4). Having calculated the interview time required to capture all of the information, it was decided that this would prove impracticable in execution. As a result, the Group had to limit its recommendations to a lesser set of data points, i.e. those most relevant to the work proposed. Based on the Work Book presented in this report (appendix 4) interviews will run to an average of 25 minutes (without an introduction) for respondents who have experienced no form of sexual harassment, abuse or violence. If respondents report having experienced multiple forms of sexual violence, it is estimated that the interview could potentially take in excess of 90 minutes. Having regard to surveys of this type in other jurisdictions, this appears relatively lengthy. This issue will need to be revisited at the point of survey/questionnaire design and following the pilot study recommended to test the survey.

Population and Sampling

Target population

The target population for the survey consists of adults, aged 18 and over, resident in private households in Ireland.

Sample design

The sample must be a probability sample with each unit having a specified probability of selection. For the purposes of clarity the methodology assumed here is Computer-assisted Telephone Interviewing (CATI). A random procedure should be used to select a set of landline telephone numbers. Experience suggests that the best approach for selecting an individual to interview at each private household would be to use a

stratification grid to ensure representative proportions of the population by gender, broad age group and whether or not in employment.¹

Given the fall in the number of households with landline telephones, it is imperative that the survey include a mobile telephone component. For the mobile telephone sample, a random procedure should be used to select mobile telephone numbers.

In both the landline and mobile telephone contacts, special care needs to be taken to ensure that the person contacted is aged 18 or over before proceeding with the survey.

Sample Size

The larger the sample, the greater the precision of the estimates from the survey. This is particularly noticeable for analysis of subgroups. Table 1 (beneath) illustrates the levels of precision arising from different potential sample sizes, using illustrative figures from the SAVI survey. The margin of error represents the amount of uncertainty around a figure calculated from a sample survey. For instance, if it is found that 30.4 per cent of women have experienced sexual abuse or violence in childhood, the margin of error around this figure is plus or minus 2.9 percentage points for a sample size of 3000 (i.e. 1,500 women). This means that there can be 95 per cent confidence that the figure in the population lies between 27.5 per cent and 33.3 per cent.

When the figures are drilled down, it is frequently smaller samples which are being examined. For questions about those women who experienced abuse in childhood, for instance, our sample size is reduced to about 30 per cent of the original (about 460 women for a total sample of 3,000 and about 1,140 for an original sample of 7,500).

² The margin of error is calculated assuming a design effect of 1.5, which is not atypical of telephone surveys where the data need to be weighted to ensure representativeness.

This means that the margins of error become wider for questions answered by those who experienced abuse, such as whether they ever told anyone about it before the interview. There is a further reduction in sample size for even more detailed questions, such as why the person did not tell anyone: based on SAVI estimates, this would be about 228 women for a total sample of 3,000 and 570 for a total sample of 7,500.

The margins of error in the table are illustrative. In practice, researchers and policy makers will require information about levels of abuse in different population subgroups such as younger and older persons or urban and rural residents. For this reason, we recommend a sample size of at least 5,000 so that a sufficient number of males and females who have experienced abuse can be included in the study.

Calibration and Weighting

Prior to analysis, the representativeness of the sample should be checked against the population using large representative national sources such as the Labour Force Survey and Census. If necessary, the survey data should be calibrated to population control totals on the basis of the following:

- Gender by age group
- Gender by education for those aged 25 and over.
- Gender by Economic Status (Usual situation At work, Unemployed, Other)
- Gender by broad age group by marital status
- Household size (number of males and number of females aged 18 and over in the household)
- Region (NUTS 3 regions)

Interviewer Recruitment and Training

In recruiting interviewers, particular attention should be paid to:

- Capacity to handle a complex computer-based questionnaire, including following skips and routing instructions accurately
- Experience in telephone work, particularly listening skills and a proven ability to convey a non-judgemental attitude
- Resilience in the face of accounts from respondents which may be disturbing
- An assessment of suitability during the training week

As well as the general training provided to all interviewers, those working on this study should have training (five days, estimated) in the following areas:

• The nature and impact of sexual abuse and violence

- Telephone techniques (including listening skills and conveying a nonjudgemental attitude)
- Addressing respondent distress
- Working systematically through all sections of the questionnaire clarifying any misunderstandings or ambiguities and explaining the rationale for each question
- The CATI system, where computer assisted interviewing is used (this is the preferred option)
- Fieldwork protocols and record-keeping, including keeping detailed records of all attempted calls and call backs, the outcome of each call and the use of the within household random selection procedure.
- Strategies for coping with the stressful material of the survey
- Open discussion of the issues raised
- Role play (face-to-face and on the telephone) of the interview situation.

Fieldwork protocols (See also General Care Protocols for participants, below)

Due consideration must be given as to how the interviewees concerned may be impacted during and after participating in this survey on such a delicate area. Requisite procedures and protocols to mitigate against negative effects for participants and experienced interviewers are highlighted below.

Care for respondents

Protocols should be developed for the survey in order to address the following:

- Ensuring that the respondent is aged 18 or over
- Introduction of the topic of the survey once the respondent has been selected (i.e. not necessarily to the first person contacted on a landline number)
- Clarity regarding the subject of the survey
- Ensuring that the respondent has enough time if it emerges that they have experienced one or more incidents of sexual abuse or violence
- Respondent distress

- Offering helpline numbers
- A Freephone telephone number for respondents to check the validity of the survey or to have their questions addressed.

Care for Interviewers

Protocols should be developed for the survey to protect and care for the interviewers, including:

- Careful recruitment and training of interviewers for this specific project
- Supervisor support available at all times
- Debriefing by supervisor at the end of each shift and at the end of the project.

Quality Protocols

In a survey of this kind, it is crucial to maximise the response rate. Among the most important quality protocols are strategies for improving response rates, particularly among younger respondents. These include:

- Up to ten call-backs to each number in order to make contact
- Calls at different times of the day and different days of the week at least two
 evening calls after 7:00pm and at least two weekend calls.
- Willingness of interviewer to call back at a more suitable time if initial contact time is not convenient
- Emphasis on importance of including a wide range of people in the study.

Pilot

A pilot study should be designed to test the survey questionnaire and interview practice and process. First, the items, codes and scales used in the questionnaire should be piloted. Many of the items are well-established, but some have never been applied in the Irish context. Items developed specifically for the study as well as items adapted for the purpose of the study are to be used in the pilot questionnaire. Second, the whole set of interviewing procedures and processes needs to be tested in the pilot,

simulating the main study as closely as possible. For instance, it is intended that the pilot should test the use of open-ended questions as opposed to closed and the use of language particularly around the concept of "consent".

The pilot study should comprise approximately 200 interviews completed. The resulting data should be subjected to quality checks including range, logic, consistency, and variable distribution. Validity and reliability analyses should also be undertaken. The results and conclusions from these analyses ought to directly inform the refinements applied to the main study questionnaire and procedures.

Child Welfare and Related Issues

Compliance with relevant child welfare and protection legislation and related obligations will be a requirement of this project. Although children will not be interviewed as part of the survey, the interviewers may become aware of information which indicates that children may be at risk. Child welfare and protection legislation requires the reporting to relevant authorities of incidents or knowledge regarding children at risk. Relevant legislation will include, but is not limited to, the Children First Act 2015 and the Criminal Justice (Withholding of Information on Offences against Children and Vulnerable Persons) Act 2012. In addition to certain legal obligations arising from particular legislation, non-statutory best practice supporting the identification and reporting of children at risk is outlined in Children First: National Guidance for the Protection and Welfare of Children.³

Ethical Approval and Data Protection

Ethics Committee

In line with international best practice, the proposed research must be conducted in accordance with the ethical standards of an institutional and/or national research

committee and with the 1964 Helsinki declaration and its later amendments or comparable ethical standards. An Ethics Committee will be required to give ethical clearance for the survey.

Data protection proofing

It will be important for the successful tenderer to be fully aware of their obligations and responsibilities as data controllers under the Data Protection Bill 2018 and the source legal instrument - the EU General Data Protection Regulation⁴. This comes into effect in May 2018 and will require the implementation of suitable and specific safeguards that increase protection to individuals participating in the research as required under legislation. Tenderers will be asked to address this issue in detail as part of the application process.

General Care Protocol for Participants (including those in distress)

Prior to the interview

Informed consent and limits to confidentiality

The researcher should talk through the information sheet or introductory materials with the participant and discuss with them the limits to confidentiality. The participant will be reminded that should they make a disclosure the researcher will talk to them first about their concerns and what will happen next.

Due consideration will also have to be given as to care / action protocols or guiding principles for participants who disclose sexual violence or are in distress. If there is a reasonable expectation that the survey target population will disclose information triggering the need for support, a plan for this circumstance must be included in the research protocols.

Distress

The interviewer should acknowledge the sensitive nature of the research topic and how the participant may become upset or feel uncomfortable in answering some of the questions which is perfectly understandable. The participant is to be reminded that taking part is entirely their choice and that the interview can be stopped or ended at any time and they can take as many breaks as needed.

The interviewer will recognise that having talked about a personal experience in the research some people might feel the need to continue to talk about it with someone afterwards. A list of support services should be provided and, if appropriate, the participant should be referred to them.

During the interview

Participant becomes distressed

The interviewer should remain aware throughout the research process of both verbal and non-verbal signs of distress from the participant. As a trained experienced listener the interviewer will be attentive to the needs of the participant as they talk about their own personal experiences and will suggest a break if they feel it is required. If the participant becomes obviously upset, the interviewer should acknowledge the participant's distress and stop the interview. The interviewer should listen with empathy.

The protocols for dealing with these and other aspects of the fieldwork need to be developed in close consultation with the research ethics committee. The following principles should be considered in the developing of such protocols, policies, procedures, and processes. This list is not exhaustive.

- Interviewers have a duty of care towards research participants.
- Interviewers will need clear protocols on what is and is not within their remit in caring appropriately for victims.

- Due regard is to be given to all child protection legislation and legislation in relation to withholding disclosures.
- Interviewers should have to hand full details of support services available.
- Project managers should put in place clear and full protocols for addressing respondent distress.
- Interviewers should be in a position to make known to survey participants reporting resources and options as well as confidential helplines and supports.
- Interviewers should be mindful of the participants' safety, the safety of the participants' children and that of the researcher.

Disclosure of abuse

If the interviewer gets a sense that the participant may be about to disclose abuse then the interviewer should remind the person again of the limits to confidentiality and the reasons why the interviewer may have to inform others.

If a disclosure of abuse is made the interviewer will allow the participant to speak without any interruption and listen with empathy.

These are suggestions which should be developed further in the context of an actual study and in discussion with the steering group and research ethics committee.

Project Management

At this stage, it is envisaged that the overall management of the various stages of this work should sit within the Department of Justice and Equality with considerable input⁵ from other Government Departments, such as the Department of Children and Youth

Affairs and the Department of Health and the successful tenderer for the work. The details as to the role and input of each stakeholder in the implementation of this work have yet to be specified. An interdepartmental / interagency project of this scale would benefit greatly from the establishment of a small Steering Group to assist in the planning and commissioning, research design and roll-out, co-ordination of fieldwork (data collection, collation and analysis), stakeholder participation and monitoring of progress. The terms of reference and work plan of the Steering Group are to be devised. Many specifics will fall to be determined in the planning to undertake this work and much project management will be required at ALL stages, most particularly at the phases of project initiation. To ensure that the project is managed effectively, it is critical that the number of members of the Steering Group should be small.

Once feasible and practicable parameters for the work have been established, a European tendering process will have to be embarked upon and managed and considerable matters regarding ethics, data protection and protocols for execution will require elaboration. Following a robust tendering process (planning and commissioning), the successful tendering body will be recruited, research design built upon, survey questionnaires developed, study piloted and a framework for project management discussed, agreed and put in place. It is envisaged that the Steering Group will report on progress at regular intervals to senior Departmental management. The level of complexity involved guarantees that issues (some contested) will arise and it is only with careful analysis, concession and conciliation that these matters will be resolved at project management level.

Those tasked with carrying out the survey would be well advised to consult with relevant stakeholders in this area, including groups supporting victims.

Sustainability of Survey into the Future

The Scoping Group recommends that this survey be repeated periodically every ten years. Considerations that fed into this timing proposal included the need to monitor change on an on-going basis; the expectation of a relatively slow pace of change, especially in lifetime prevalence and in the risk factors associated with sexual abuse and violence; the probable cost and challenges of conducting a full-scale national survey; and the availability of more frequent and less costly public attitude surveys to monitor change in attitudes. The Group also recommends, in the intervening period, a range of supplementary data collection exercises be undertaken to determine the experience of sexual violence of vulnerable and minority groups (see appendix 5).

A permanent infrastructure for the ongoing storage and management of data to enable utilisation by other researchers and data linkage should be developed (for example, a Health Research Board report from May 2016 presents a data model for discussion called the DASSL model⁶). Access to data would be subject to data protection and ethical safeguards.

The possibility of providing the appropriate resources to the Central Statistics Office (CSO) for undertaking this work on a sustainable basis into the future could also be considered. In the meantime, the CSO may be consulted as appropriate on issues relating to statistical methodology, data management and storage. There may also be scope under the legal framework of the Statistics Act 1993 for the CSO to facilitate researcher access to the survey microdata subject to the requirements of the CSO's

Policy on Access to Microdata. The Scoping Group recommend that this option be explored further.

Cost

In parallel with the work of the group, Cosc has undertaken a market testing exercise to establish a rough cost estimate for the survey. The results of this work have been notified in parallel with the Report, as this is commercially sensitive information.

Appendix 1

Scoping Group to consider the availability of data and make recommendations on a study to identify the prevalence of sexual abuse and violence in Ireland today and emerging trends.

TERMS OF REFERENCE

Output

The group will:

- consider the data available to the Government in developing policy to address sexual abuse and violence from both a qualitative and quantitative perspective;
- assess if there are gaps in the available data in a policy development context with particular regard to comparable jurisdictions;
- draw up a set of data points which it considers to be relevant to the formulation of policy in this area including in assessing the effectiveness of existing policy and legal frameworks;
- make recommendations in respect of a national survey methodology; and,
- make recommendations on a framework that ensures regular updates of available data in a consolidated, coherent framework to inform policy formulation.

Work

- 1. The group will examine the data points in SAVI (2002) as a point of departure.
- 2. It will consult with key external groups and organisations as appropriate.
- 3. It will consider contemporary data available in FRA (2014), Eurobaromoter (2016), any other relevant Irish data in this area and international data that includes Ireland, along with CSO published material and data sets.
- 4. It will take into account any planned future work on relevant data gathering at national level.

- 5. It will have regard to the experience of national studies in other comparable jurisdictions, in so far as time permits.
- 6. It will consult with relevant Government Departments.
- 7. It will draw up a set of data points which it considers to be relevant to the formulation of policy in this area; and make recommendations in respect of a national survey methodology.
- 8. It will present recommendations on how the study will be conducted.
- 9. Following the conclusion of an initial scoping exercise on sexual abuse and violence, a reconstituted Scoping Group will consider the separate but related area of sexual harassment in the workplace. This work will take place as a second module, following completion of the first scoping exercise. The Cabinet Committee on Social Policy will agree new Terms of Reference and revise inter alia the Government representation on the Scoping Group for the second module of its work which will examine qualitative and quantitative data available to Government in respect of sexual harassment in the workplace and the adequacy of the framework in place to protect employees. More detailed terms of reference will be brought forward under the direction of the Taoiseach.

Reporting

The Scoping Group will report to the Cabinet Committee on Social Policy within three months of its first meeting in respect of its work on data on sexual abuse and violence. Following that report, the reconstituted Scoping Group will report to the Cabinet Committee on Social Policy no more than three months after its first meeting.

Explanatory Note Book for Work Book on Data Points on Sexual Violence

Introduction

This 'Explanatory Notebook' is intended as an accompanying guide to the Work Book which sets out the sections, data points and variables identified to date by the Academics on the Scoping Group as integral to a prevalence study on Sexual Abuse and Violence in Ireland. This document sets out the rationale and evidence base for the inclusion of new material, over and above what was contained in SAVI (McGee et al, 2002) and indeed the suggested deletion or amendment of original SAVI data points. In accordance with the terms of reference as agreed with the Scoping Group, the methodology employed for the purpose of completing this task was as follows:

- 1. Examine the data points in SAVI (McGee et al., 2002) as a point of departure⁷.

 This formed the base line data identified;
- 2. Building on that original data involved the following steps:
 - a. Keeping original data points and variables as per SAVI;
 - Expanding and enhancing the original data points with additional words to improve clarity;
 - c. Including additional variables to the original data in order to expand the optional answers;
 - d. Deleting original data points that held no further relevance;
- 3. Reviewing and cross referencing to other relevant international surveys to identify gaps in the original data points and address those gaps by adding in new data points and variables not present in the original SAVI survey. These gaps are firstly specific to conducting a prevalence study on sexual abuse and violence in general, and secondly, specific to conducting such a prevalence study in an Irish context. A full bibliography is available at the end of this document which sets out the research evidence drawn on in addition to the available international studies.

⁷ With the original electronic code book unavailable to the academics, this starting point represented a hardcopy questionnaire. Rationale for inclusion of Domestic Violence and Abuse in Prevalence study on Sexual Violence and Abuse

Domestic abuse has been firmly established as a significant indicator for various forms of child abuse, where at its most basic level, living with the abuse of their mother can be considered a form of emotional abuse (Wolfe *et al.*, 2003) with negative implications for children's emotional and mental health and future relationships (Holt et al., 2008; Overlien, 2010).

Domestic abuse is also an important indicator of the risk of direct physical and sexual abuse of children. For example, Edleson's (1999) review of 35 published studies of the co-occurrence of domestic violence established that there was a high level of overlap ranging from 30-60% in most studies reviewed. Cross referencing police records with child protection referrals by Beeman *et al.* (2001) identified over 64% of cases as dual violence families, while Shepard and Raschick's (1999) research with child welfare workers highlighted that 71% of the families in crisis had reported issues relating to domestic abuse. Radford *et al.*'s more recent (2011) UK NSPCC study confirms the overlap with children exposed to domestic abuse between 2.9 and 4.4 times more likely to experience physical abuse from a caregiver than those not exposed.

Although relatively little attention has been devoted to the overlap between domestic abuse and child sexual abuse, there is empirical evidence attesting to an elevated prevalence of co-occurrence. Again, convergence on rates varies, primarily influenced by the sample and location the data are drawn from. For example, 4% of Smith *et al.*'s (1997) community sample of 54 abused mothers reported the sexual abuse of their child by their ex-partners, while a higher rate of co-occurrence was recorded in a more recent follow-up study with 164 (7-19 year old) young people who had previously disclosed sexual abuse and attended a sexual abuse clinic (Kellog & Menard, 2003). Interestingly, this later research nonetheless identified a concurrent rate of 77% when the sexual abuse offender was also the perpetrator of the inter-parental abuse. In the Irish context, both the Kilkenny Incest Investigation (McGuinness, 1993) and the West of Ireland Farmer Case (North Western Health Board, 1998) found the co-occurrence of multiple forms of child abuse in the context of domestic violence.

There is evidence that children from violent families go on to be violent or be abused in their adult intimate relationships (Coohey, 2004; Guille, 2004; Margolin et al., 2003; Whitefield, Anda, Dube, & Felitti, 2003). Amato's (2000) review of a 12-year longitudinal study found that young adults who had been exposed to parental violence as children were 189% more likely than those not exposed, to experience violence in

their own adult relationships. More recently, Ehrensaft and colleagues (2003)

conducted a three generation, prospective longitudinal study of children over a 20

year period. At 20 years, they found that exposure to dv tripled the odds of

perpetrating violence towards a partner. Reflecting on this in 2012, Ehrensaft and

Cohen found that children's exposure to domestic violence and their history of

physical abuse in childhood predicted externalising behaviours among their children.

The correlation between domestic abuse and other forms of victimisation alongside

the very complex nature of domestic abuse provides challenges to policy makers and

practitioners alike in a number of ways. Childhood exposure to domestic abuse is now

considered to be an Adverse Childhood Experience (ACE; McGavock and Spratt, 2016)

and as such, domestic violence is rarely the only adversity families living with DV

experience. According to Finklehor et al. (2010), domestic violence 'clusters' very

comfortably with all forms of child abuse and is one of the accepted 'toxic trios'

(Cleaver et al., 2010) alongside substance misuse and mental health difficulties.

Stark (2017) asserts that coercive control is the single most common context in which

child abuse occurs, quoting data from NISVS (2010), with lifetime reports by US

women of sexual violence stating the following in terms of female sexual victimisation:

Victimisation by a Current/former partner: 51%

Victimisation by an Acquaintance: 41%

Victimisation by a Family member: 13&

Victimisation by a Stranger: 13%

Appendix 5

Future Data Requirements

The Scoping Group recommend that further consideration be given to the development of appropriate supplementary data collection exercises to explore the experiences of sexual violence for members of vulnerable and minority groups in the population. This is because a national survey by its nature cannot achieve data to make any useful or meaningful conclusions in relation to small groups.

The Group recommends, subject to resources being made available that the following groups be researched:

- o LGBTQI
- those with disabilities
- homeless
- those in institutional settings
- migrant groups
- those in prostitution;
- members of the Roma Community
- trafficked persons
- o members of the Traveller Community.

Finally, the Scoping Group recommend, subject to resources being made available, that a special module of research on access to counselling and other support services be undertaken.
