Hello ,

I am writing to make a submission re Designated Salmonid Waters Bye-law.

Firstly I absolutely commend Mr. Kyne for bringing in the bye law to protect salmon and trout stocks. However this change should be implemented throughout the country and not just in the 7 designated lakes.

I have been fishing on Lough Derg for almost forty years now and have witnessed firsthand the decimation of the trout stock over the years. Despite the great work being done on rivers psawning beds etc by both the Inland fisheries and indeed the local clubs the single biggest impact on stocks is the continued C&R of pike on our lake. It is having a huge effect on the dwindling trout stocks.

I fully appreciate that there are some tourism benefits from pike angling in Ireland and that a very limited number of local ghillies take tourists out on the lake to fish. However as can be seen from their weekly reports on catches on your website the numbers of pike being caught is massive. In the Fishing Ireland report (link below) one boat with two men on Lough Derg caught 33 pike in one day. In our club the Mayfly has been up for the past two weeks and the TOTAL CATCH FOR THE ENTIRE CLUB TO DATE IS LESS THAN 40 TROUT . THAT IS 20-30 ANGLERS PER DAY FOR 14 DAYS FOR LESS THAN 40 TROUT.
