A Chara,

As a member of the Oughterard Angling Club, which is affiliated to the Lough Corrib Angling Federation, I fully support the draft legislation proposed by Minister Seán Kyne including the Salmonid designation for Lough Corrib and especially the rescinding of the protection afforded to invasive pike in designated trout fisheries. The Conservation of Pike Bye-Law No. 805 (2006) should never have been applicable to Ireland's game fisheries when made law in 2006.

Firstly, no scientific literature has ever been produced, which shows that pike have a benign influence on wild salmonid fisheries. There have been many reports and academic papers produced over the years in Ireland, Finland, Russia, Sweden, Canada and the USA that proves the destructive nature of pike in salmonid fisheries.

There are numerous reports of the detrimental effects of introduced pike on salmonids. Effects on sport fisheries for trout have been reported for a variety of systems in North America (McMahon and Bennett 1996) and Europe (Broughton 2001). Aguilar et al. (2005) cites predation on stocked trout in Lake Davis, California, where illegal introduction of pike has been well studied and where there is also a threat to the native chinook salmon in nearby watersheds. Pike may also be involved in the decline of native cutthroat trout and bull trout in Montana (McMahon and Bennett 1996; Muhlfeld et al. 2008). Perhaps the most exhaustive assessment of the potential impact of pike introductions on salmonids is in Alaska.

The Southcentral Alaska Northern Pike Control Committee (2006) has reviewed the issue, and the following discussion is based on their report. The chief concern is predation on natural and supplemented populations of Pacific salmon *Oncorhynchus* spp., which could have both economic and ecological consequences given the salmon's position as a keystone species that acts not only as a consumer of prey but also as food for mammals and birds, as well as a supplier of nutrients to terrestrial ecosystems. Rainbow trout maintained in many Alaskan lakes by annual stocking programs are also believed vulnerable to predation by illegally introduced pike.

Brown trout angling on Lough Corrib and throughout Ireland is under threat because of the calls by the Irish Pike stakeholders/lobbyists for the cessation of all pike control on Ireland's managed trout fisheries. Pike (*Esox lucius*) is a destructive aquatic nuisance species (ANS) and is also listed as an invasive species to Ireland by the Global Invasive Species Database (GISD) that is managed by the IUCN Species Survival Commission. The EU WFD (Water Framework Directive) monitoring programme classifies fish species to one of four categories (1. Domesticated, 2. Non-native benign, 3. Non-native non-benign and 4. Invasive requiring management), in which pike are classified as being non-native non-benign in Ireland (Kelly et al., 2008; King et al., 2011). There has been no categorical or conclusive proof ever produced by fisheries scientists, which proves that pike are native to Lough Corrib and its tributaries. Pike have the potential to interfere with ecosystem function and destroy economically important fisheries as they are voracious predators who prey heavily on juvenile salmonoids (trout & salmon) and other fodder fish.

Recent IFI surveys on Lower Corrib have shown that potentially large numbers of salmon smolts can be cropped by pike on their way to sea.

In relation to Lough Corrib, over exploitation of salmonid stocks by anglers is not an issue for the lake. In a 2012 Lough Corrib fish stock survey carried out by the IFI, they noted the following:

"If excessive angling catches were responsible for reducing trout stocks in recent years then a significant reduction should be seen in the numbers of larger older fish in the 2012 survey – this is not the case."

Habitat degradation is an issue for the Corrib but it is also an issue for every other watercourse in the country. Anglers through the clubs situated throughout Lough Corrib contribute roughly €10,000 per year to Cairde Loch Coiribe. This fund goes into stream enhancement and improvement works for salmonoid spawning. There is also countless unseen man hours

contributed by volunteers to improve Lough Corrib as a salmonid fishery. The Oughterard hatchery is run solely by volunteer anglers. Every October anglers under a strict IFI licensing regime net the Owenriff river for migratory trout. These fish are stripped for their ova and milt, which produces on average 300,000 to 400,000 eggs annually. These eggs are incubated over a four to five month period and monitored daily by volunteer anglers until the fry are ready to be released back in to the Corrib system. All stripped fish are returned unharmed to the lake. This annual conservation measure occurs with no cost to the Irish state.

A small cohort of fundamentalist pike anglers are having a disproportionate and nefarious influence on shaping game angling policy in Ireland. In 2014, both trout and pike stakeholders were consulted and reached agreement on a new "Pike Policy Document" with the IFI. The 2014 policy stated that pike management (gill netting/electro-fishing) should continue on the seven designated trout fisheries (Corrib, Mask, Carra, Conn, Cullin, Sheelin & Arrow). It also stated that the Pike Conservation By-Law No. 805 (2006) should be repealed on the seven trout lakes in order for pike numbers to be controlled by rod and line. Irish pike stakeholders (Irish Federation of Pike Angling Clubs) being directed by the Pike Anglers' Club of Great Britain (PACGB) reneged on this agreement and mounted a very vociferous and malignant protest campaign against the IFI and its pike management practices, which culminated in protests outside the Dáil and IFI HQ during 2016. As it stands, the IFI are now asking the relevant stakeholders to review a policy that was never implemented.

Nonetheless, with respect to the science it is completely disingenuous by pike lobbyists to state that Lough Corrib can be a great salmonid fishery and pike fishery simultaneously. Lough Corrib is either a 'game/salmonid fishery' or it is a 'mixed fishery', it cannot be both. Salmonids will always suffer in the presence of pike due to prodigious pike fecundity and piscivorous feeding habits. While the percentage of salmonids predated on by pike in wild fisheries varies across the scientific literature, the biggest threat to Corrib salmonids is pike fecundity (fertility). According to a report for the National Strategy for Angling Development published in 2015, titled 'The Economic Contribution of Pike Angling in Ireland', stated that the total economic contribution of recreational angling in Ireland to be approximately €755 million. In the same report, domestic pike anglers had an annual domestic expenditure of €68,430,000. Overseas pike anglers had an annual expenditure of €5.8 million. The total estimated expenditure of all pike anglers is €75 million. In the same report, there are 84,962 trout anglers compared to 41,482 pike anglers. This figure is for domestic and foreign anglers. The gross expenditure per person for a trout angler is judged to be €1,281 compared to €1,808 for a pike angler. However, the gross expenditure for pike anglers is calculated to be €75 million (highlighted above) compared to €109 million for brown trout anglers and €154 million for salmon and sea trout anglers.

It must be also stated that indigenous pike anglers have done nothing to improve their own waters in any proactive way or even investigated various fishery management protocols to improve pike angling quality on Ireland's mixed fisheries. Irish pike anglers could also investigate what the Minnesota Dept. of Natural Resources are doing to improve and optimise pike angling in that state. In 2008, Minnesotan authorities decided on a 12 year plan to remove large numbers of small pike from certain lakes to improve overall population growth and for other less fertile lakes they decided to stock larger pike. In other words, the US authorities realised that to produce better pike fishing and more quality fish, pike stocks need to be managed/manipulated even in areas where they are considered native. Irish pike anglers need to sort out their own fisheries first by liaising with the IFI in a meaningful manner instead of this nefarious interfering in to Irish game fisheries.

The Oughterard Angling Club are not out to exterminate pike from Lough Corrib, which would be a futile exercise considering their fecundity. Pike will always be part of Lough Corrib and will always be there for anglers who wish to pursue them. However, strategic gill netting for pike must be maintained in order for their population to be kept as low as reasonably practical for the benefit of trout and salmon stocks. Gill netting on Lough Corrib must target pike at their spawning time on an annual basis for effectiveness and to minimise by-catch. According to expenditure figures released by the IFI, pike management (gill netting & electro-fishing) on Lough Corrib in 2014 cost a total of €20,536. This is a very small price to pay to keep Lough Corrib as a world class wild salmonid fishery.

This will be a useful measure in protecting trout stocks on the lakes and encouraging angling tourism by continental anglers who view Pike as a table fish.

4.2 The Necessity for Control

The necessity for controlling adult pike populations in managed lake trout fisheries is a straightforward issue for a number of reasons:-

I. Adult pike in trout lakes show a clear preference for consuming adult trout even in circumstances where other fish species are much more abundant than trout (roach and/or perch) (Table 1).

II. Pike, like all predatory fishes, have relatively poor maintenance and food conversion rates ? Fitzmaurice (1983) estimated that pike in Irish lakes had maintenance and food conversion rates of circa 5:1 and 7:1 respectively. In circumstances where pike are feeding principally on trout a relatively small adult pike population could consume a very substantial number of adult trout. For example a single pike which increased in weight from 2.3kgs to 3.6kgs in a year could have consumed 9.1kgs of trout (circa eighteen 3+ year-old fish). One can see that a substantial adult pike population can ?cap? an adult trout stock. This is the kernel of the issue. The quality of trout angling on many managed lake trout fisheries will decline markedly where adult pike stocks are not managed.
