Offshore Renewable Energy Steering Group Job Creation Working Group <u>Draft</u> 7th meeting – 25 July 2018

1. Tour De Table – EC opened the meeting with a brief tour de table to introduce new members.

- 2. Policy Updates DCCAE and SEAI EC began by giving an overview of the governance structure of the Offshore Renewable Energy Development Plan (OREDP) and the various steering and working groups that oversee its implementation. DM and EC explained the scale of, and limited window to exploit, the opportunity presented by Offshore Renewable Energy. The following three components have been identified as key to the successful development of offshore renewable energy (ORE) in Ireland.
 - i. A support tariff The RESS scheme which has recently been approved by Government aims to support the diversification of renewable energy in Ireland and it is envisaged that ORE projects will be included in this mix.
 - ii. Consenting framework Ongoing work on the Maritime Area and Foreshore Amendment act (MAFA), aims to provide a robust consenting regime for *inter alia* ORE activities. A number of participants highlighted in stark terms the need for this legislation and the potential missed opportunities that may result if the bill is not progressed in a timely manner.
 - iii. Grid Connection

A wide ranging discussion developed during which the group heard updates and suggested actions on the following areas.

- i. LL gave an update on the IPORES REPORT
- ii. DM spoke on the status of the 3 test sites

iii. DM noted that offshore floating wind is at commercial stage, tidal energy is showing promising signs of technology convergence and wave energy requires a lot more convergence before it will be commercially viable.

ACTION: Draft IPORES report to be circulated to group. Comments on the draft report to be returned by Friday 3rd of August.

3. Recommendations of the OREDP Interim Review – JCWG Implementation DM and EC introduced the work program and explained the context of the OREDP Interim Review and its recommendations. The draft updated work program was examined by the group with each item in the plan discussed in turn.
