Foreword from the Minister

I welcome this publication of Statistical Information on Social Welfare Services for 2008. This 26th edition of the Annual Statistical Report of the Department of Social and Family Affairs provides comprehensive statistical information on all programmes administered by my Department.

Accurate information is vital to support evidence-based policy making and enable the measurement of progress in these areas. Reliable data on outputs and trends as contained in this Report are invaluable elements in the development and implementation of policies to build social inclusion and progress social cohesion.

Supports administered by this Department provide for the complex and multi-faceted needs of people at every stage of life. Behind each and every one of these statistics is a real person or family, making it all the more important for us to see that delivering services is not just about numbers but about affecting the daily lives and wellbeing of all our citizens particularly in these challenging times.

This report shows that social welfare expenditure increased to over €17.8 billion in 2008, an increase of almost 15% on the previous year. This funding provided supports to children and families, people of working age, carers and people with disabilities as well as retired and older people. The increasing level of investment reflects the desire to achieve real social progress as well as meet the challenges facing a changing society. Statistics tell their own story and in 2008:

- Over 1.2 million people were in receipt of a weekly Social Welfare payment, which was paid in respect of 1.8 million beneficiaries;
- There was over €5.3 billion spent on supports for people of working age, an increase of almost 25% on the previous year. Within this, expenditure on Jobseekers supports increased by 48% rising to €2.1 billion
- Expenditure on State Pensions increased by 10.9% to €4.3 billion. Payments were made to over 364,000 people in this area.
- 596,108 families received a monthly Child Benefit payment, which was paid in respect of 1,141,938 children. Expenditure on Child Benefit increased by 10.0% to €2.5 billion.
- Family Income Supplement was paid to 27,798 families, an increase 21.8% on the previous year and benefiting over 58,000 children, 22.1% more than 2007. Expenditure on Family Income Supplement increased by 21.6% to €170 million;
- Expenditure on Carer's Allowance and Carer's Benefit increased by 24.6% and 25.2% respectively. The numbers in receipt of a Carer's payment increased from 35,147 to 45,818, an increase of 30.4%;

This report illustrates and charts the progress being made in improving and developing services, in tandem with wider Government aims and objectives, which have at their core the delivery of improved quality of life and opportunities to people of all ages. Every one of the services provided daily by the almost 5,000 staff of the Department is a core feature of our society, ensuring that supports are there for those who need them.

Réamhrá an Aire

Fáiltím roimh fhoilsiú seo Faisnéis Staitistiúil ar Sheirbhísí Leasa Shóisialaigh do 2008. Tugann 26ú eagrán seo de Thuarascáil Staitistiúil Bhliantúil an Roinn Gnóthaí Sóisialacha agus Teaghlaigh faisnéis chuimsitheach Staitistiúil maidir le gach clár atá á riaradh ag mo Roinn.

Bíonn eolas cruinn den riachtanas chun tacú le cinnteoireacht atá bunaithe ar fhianaise agus chun a chur ar ár gcumas dul chun cinn sna réimsí seo a thomhas. Gnéithe fíor-luachmhara atá i sonraí iontaofa maidir le torthaí agus treochtaí, mar atá sa Tuarascáil seo, ó thaobh polasaithe a fhorbairt agus a chur i bhfeidhm chun iniamh sóisialta a chothú agus comhtháthú sóisialta a chur chun cinn.

Déanann tacaíochtaí atá á riaradh ag an Roinn seo foráil do na riachtanais casta agus ilghnéitheacha a bhíonn ag daoine ag gach céim den saol. Tá duine daonna nó teaghlach taobh thiar de gach ceann de na staitisticí seo, rud a fhágann go bhfuil sé thar a bheith tábhachtach dúinne cinntiú go mbeidh seachadadh seirbhísí dírithe ní hamháin ar uimhreacha ach ar thionchar a imirt ar shaol agus leas laethúil ár saoránach uile, go háirithe sna cúinsí deacra ina bhfuilmid faoi láthair.

Taispeánann an tuarascáil seo gur tháinig ardú ar chaiteachas leasa shóisialaigh go dtí os cionn €17.8 billiún in 2008, ardú de bheagnach 15% i gcomparáid leis an mbliain roimhe sin. Soláthraíonn an maoiniú seo tacaíochtaí do leanaí agus teaghlaigh, do dhaoine atá in aois fostaíochta, do chúramóirí agus daoine le míchumais chomh maith le daoine atá imithe ar scor agus daoine níos sine. Tugann an t-ardleibhéal infheistíochta aitheantas don mhian atá ann dul chun cinn sóisialta dáiríre a bhaint amach chomh maith le dul i ngleic leis na dúshláin atá ann do shochaí atá ag athrú. Tugann staitisticí a léiriú féin ar an scéal féin agus in 2008:

- Bhí os cionn 1.2 milliún duine ag fáil íocaíocht sheachtainiúil Leasa Shóisialaigh, ar íocadh í ar son 1.8 milliún tairbhí;
- Caitheadh os cionn €5.3 billiún ar thacaíochtaí do dhaoine in aois fostaíochta, ardú beagnach 25% ar an mbliain roimhe sin. Laistigh den fhigiúr seo, tháinig ardú 48% ar chaiteachas dóibh siúd atá ag fáil tacaíochtaí Cuardaitheora Oibre, rud a d'fhág go bhfuil €2.1 billiún á chaitheamh anois air.
- Tháinig ardú 10.9% ar Phinsin Stáit go dtí €4.3 billiún. Rinneadh íocaíochtaí do níos mó ná 364,000 duine sa earnáil seo.
- Fuair 596,108 teaghlach íocaíocht mhíosúil Sochar Linbh, a íocadh i ndáil le 1,141,938 leanbh. Bhí ardú
 10.0% go dtí €2.5 billiún ar an méid a caitheadh ar Shochar Linbh.
- Íocadh Forlíonadh Ioncam Teaghlaigh do 27,798 teaghlach, ardú 21.8% ar an mbliain roimhe sin. Chuaigh sé seo chun tairbhe os cionn 58,000 leanbh, 22.1% níos mó ná 2007. Bhí ardú 21.6% go dtí €170 milliún ar chaiteachas ar Fhorlíonadh Ioncam Teaghlaigh;
- Tháinig ardú 24.6% and 25.2% faoi seach ar chaiteachas ar Liúntas Cúramóra agus ar Shochar Cúramóra. Bhí ardú i líon na ndaoine a bhí ag fáil íocaíocht Cúramóra ó 35,147 go dtí 45,818, ardú de 30.4%;

Taispeánann agus léiríonn an tuarascáil seo an dul chun cinn atá á dhéanamh ó thaobh seirbhísí a fheabhsú agus a fhorbairt, i gcompháirt le haidhmeanna agus le cuspóirí níos leithne an Rialtais, a bhfuil sé mar mhóraidhm acu caighdeán maireachtála níos fearr agus deiseanna a sheachadadh do dhaoine de gach aois. Tá gach ceann de na seirbhísí seo á gcur ar fáil ar bhonn laethúil ag beagnach 5,000 ball foirne na Roinne agus gné lárnach dár sochaí atá iontu anois, agus iad ag cinntiú go bhfuil tacaíocht ar fáil dóibh siúd a bhfuil sé ag teastáil uathu.

Introduction

General

This is the twenty sixth issue of the annual "Statistical Information on Social Welfare Services" prepared by the Department of Social and Family Affairs. It sets out comprehensive data relating to services provided by the Department.

The statistics set out in this report relate to 2008 and earlier years. In the case of data relating to recipients and beneficiaries, the figures, unless otherwise stated, refer to the 31st December each year. Several tables, which provide a breakdown of recipients or beneficiaries by some characteristic such as number of dependants or age, are referred to as "estimated". This means that the proportionate breakdown, which is considered to be a reliable estimate, was established at a date other than, but close to, 31st December.

Expenditure figures for 2008 are provisional pending certification by the Comptroller and Auditor General. All Expenditure figures have been converted to Euro amounts.

Source of Data

The source for the statistics presented, unless otherwise stated, is the Department of Social and Family Affairs.

Time Series and Changes to Existing Payments

Time Series data are given, where available. However, the introduction of new payments and changes to existing payments affect the comparability of different years' figures in some instances. Relevant tables are footnoted where appropriate.

Section E provides details of expenditure and recipients of Illness Benefit, Invalidity Pension, Disability Allowance, Blind Pension, Carers Allowance and Occupational Injury Benefits.

Section F provides details of jobseeker's payments.

Section G provides details of employment supports including Back to Work Allowance, Back to Work Enterprise Allowance, Back to Education Allowance, the Family Income Supplement and Farm Assist. For the first time, this report includes data relating to the number of people referred to FÁS under the National Employment Action Plan.

Section J provides details of Treatment Benefits, Free Schemes and other miscellaneous payments. This section includes the number of Personalised Public Service numbers issued by Nationality.

SECTION A SUMMARY AND FINANCIAL

Section A: Summary and Financial

Expenditure

Total Social Welfare expenditure in 2008 was €17,815million, an increase of 14.8% over 2007. Expenditure in 2008 represented 33.4% of Gross Current Government expenditure and was equivalent to 11.4% of GNP (Table A2). The main areas of expenditure by programme group were Older People (24.1%), Widow's, Widower's and One Parent Families (14.0%), Illness, Disability and Caring (18.5%), Jobseeker's Supports (11.8%), Child Related Payments (15.7%), Supplementary Welfare Allowance (4.5%) and Employment Supports (2.3%). Administration of the social welfare system accounted for 3.3% of total expenditure (Graph A1).

Total Social Welfare expenditure was financed by the Exchequer (52.9%) and the Social Insurance Fund (47.1%). The Social Insurance Fund was financed by Pay-Related Social Insurance contributions from employers (73.0%), employees (20.1%), the self-employed (5.0%) and Investment Income (2.0%). See Tables A6 and A7.

Recipients of Weekly Social Welfare Payments

Over 1,208,800 people were in receipt of a weekly social welfare payment at the end of 2008. As these payments included increases in respect of over 145,200 Qualified Adults and over 445,700 children, there were over 1,799,800 beneficiaries in all. The number of recipients increased by 148,556, year on year, while the number of beneficiaries increased by 222,412.

Notes: Scheme Changes and Comparability of Year-on-Year Data

(a) In 2006 age related pensions were replaced by State Pensions, with significant administrative alterations to several weekly payment types which had up to that point provided for people aged over 65. These alterations, implemented in stages following the introduction of the State Pensions, have resulted in substantial migrations of recipients between scheme types, with accompanying changes in expenditure and recipients on these schemes. The most significant transfers of recipients were those involving State Pension (Contributory), formerly known as 0ld Age Pension (Contributory), and State Pension (Transition), formerly known as Retirement Pension.

Recipients of Widow/er's Pension, Deserted Wife's Allowance, Blind Pension, One Parent Family Payment and Prisoner's Wife's Allowance have since 2006 transferred to State Pension (Non-Contributory) upon reaching 66 years of age, resulting in some decreases in recipients and expenditure on such schemes and concomitant increases in recipients and expenditure on State Pension (Non-Contributory). Recipients of Invalidity Pension aged 66 years or over are now automatically transferred to State Pension (Contributory) on reaching that age threshold.

One effect of these changes is the erosion of data comparability between 2006 and 2007 in relation to recipients and expenditure on the schemes altered in 2006 and 2007. For instance, expenditure on State Pension (Contributory) rose by 74.3% between 2006 and 2007, while that on State Pension (Transition) fell by 90.8% over the same period, due to the major shifts in numbers of recipients of these weekly payment types.

- (b) Increases in the maximum duration and maximum payment of Maternity Benefit have resulted in a significant increase in expenditure on the scheme. In March 2006 the maximum duration of Maternity Benefit, Adoptive Benefit and Health and Safety Benefit claims was increased from 18 to 22 weeks, with a subsequent extension of Maternity Benefit in March 2007 to 26 weeks.
- (c) From September 2007 a person may receive half rate carer's allowance while in receipt of another social welfare payment. This may result in double counting.

Graph A1: Expenditure on Social Welfare by Programme, 2008



Graph A2 Expenditure on Main Social Insurance Schemes, 1999 to 2008








Graph A3: Expenditure on Main Social Assistance Schemes, 1999 to 2008



Graph A7: Recipients of Main Social Assistance Payments, 1999 to 2008



Graph A8: Analysis of Insured Population, 2007



Section B: Older People

Expenditure and Recipients

Expenditure on payments for older people was over €4,300 million in 2008. This represents an increase of 10.9% on 2007.

The overall number of payments for older people rose by 12,215 in 2008, an increase of 3.5% on 2007. The number of people in receipt of a contributory pension (State Pension (Contributory) and State Pension (Transition)) based on social insurance contributions rose by 13,909 while the number of people in receipt of the means tested State Pension (Non-Contributory) increased by 58. The number of people in receipt of Pre-Retirement Allowance fell by 1,752 in 2008.

Notes: Scheme Changes and Comparability of Year-on-Year Data

In 2006 age related pensions were replaced by State Pensions, with significant administrative alterations to several weekly payment types which had up to that point provided for people aged over 65. These changes, implemented in stages following the introduction of the State Pensions, have resulted in substantial migrations of recipients between scheme types, with accompanying changes in expenditure on these schemes. The most significant transfers of recipients were those involving State Pension (Contributory), formerly known as Old Age Pension (Contributory), and State Pension (Transition), formerly known as Retirement Pension.

Recipients of Widow/er's Pension, Deserted Wife's Allowance, Blind Pension, One Parent Family Payment and Prisoner's Wife's Allowance have since 2006 been transferred to State Pension (Non Contributory) upon reaching 66 years of age, resulting in some decreases in recipients and expenditure on such schemes and concomitant increases in recipients and expenditure on State Pension (Non Contributory). Further alterations have resulted in Qualified Adults of a State Pension (Non Contributory) aged over 66 qualifying for a pension in their own right, with recipients of Invalidity Pension aged 66 years or over being automatically transferred to State Pension (Contributory) on reaching that age threshold.

A side-effect of these changes is the erosion of data comparability between 2006 and subsequent years in relation to recipients and expenditure on the affected schemes

Graph B1: Number of Recipients of State Pensions, 1999 to 2008



Section C: Widows, Widowers and One Parent Families

Expenditure and Recipients

Expenditure on Widows, Widowers and One Parent Families increased by 8.8% overall in 2008.

The payment type in this programme group with both the largest expenditure and number of recipients is Widow/er's (Contributory) Pension. At the end of 2008 there were 112,237 recipients (97,790 widows and 14,447 widowers). Expenditure in 2007 was nearly €1,300 million which represented an increase of 7.8% over 2007.

The number of recipients of Deserted Wife's Benefit and Deserted Wife's Allowance fell by 339 and 76 respectively during 2008.

Expenditure on One-Parent Family Payment increased by 10.9%, while the number of recipients rose by 2,756, an increase of 3.2% on 2007.

Graph C1: Number of Recipients of One-Parent Family Payment by Age and Sex, 2008



Section D: Child Related Payments

Expenditure and Recipients

This section relates to payments made in respect of children such as Child Benefit, Guardian's Payments and Maternity related payments. For ease of reference, this section also gives details of increases in respect of qualified children which are payable with social welfare payments (See Table D10). It should be noted, however, that for the purpose of apportioning expenditure between programmes, the cost of qualified child increases is included with the main payment e.g. Qualified Child increases paid with State Pensions are included in the 'Older People' programme.

Expenditure on payments in this programme group rose by 11.7% in 2008. The breakdown of Child Benefit by family size shows that 76.4% of recipient families in 2008 have either one or two children. The equivalent percentage for 1999 was 72.4%. See Table D8 and Graph D1. The number of families receiving Child Benefit rose by 16,496 to 596,108. The total number of children in respect of whom Child Benefit is paid increased by 31,223 to 1,141,938.

Expenditure on Child Benefit increased by over €222 million in 2008, an increase of 10.0% while Maternity Benefit expenditure increased by over €57 million, an increase of 22.5%.

Notes: Scheme Changes and Comparability of Year-on-Year Data

Increases in the maximum duration and maximum payment of Maternity Benefit, in addition to the increases in the female population and the national birthrate, have resulted in a significant increase in expenditure on the scheme. In March 2006 the maximum duration of Maternity Benefit, Adoptive Benefit and Health and Safety Benefit claims was increased from 18 to 22 weeks, with a subsequent extension of Maternity Benefit in March 2007 to 26 weeks.

A side-effect of these changes is the erosion of data comparability between 2006 and subsequent years in relation to recipients and expenditure on the affected schemes.

Graph D1: Number of Families Receiving Child Benefit by number of Child Beneficiaries, 1999 to 2008



SECTION E ILLNESS, DISABILITY AND CARING

Section E: Illness, Disability and Caring

Expenditure and Recipients

Expenditure on Illness Benefit and Invalidity Pension increased by 12.9% and 10.9% respectively. Expenditure on Disability Allowance increased by 16.8% to over €1.05 billion. There are now 95,754 recipients of the scheme.

Expenditure on Carer's Allowance increased by over €89 million in 2008, an increase of 24.6%. There are now 43,569 recipients of the Scheme, an increase of 10,502 year on year.

Graph E1 and Table E4 show details of the numbers of Carer's Allowance recipients from 1999 to 2008.

Carer's Benefit is a payment made to insured persons who leave the workforce to care for a person(s) who require full time care and attention. The number of recipients increased by 169 to 2,249 in 2008.

Notes: Scheme Changes

Recipients of Blind Pension have since 2006 been transferred to State Pension (Non Contributory) upon reaching 66 years of age, resulting in decreases in recipients and expenditure on the scheme. Recipients of Invalidity Pension have been transferred to State Pension (Contributory) upon reaching 66 years of age, this change also having been introduced in 2006.

A side-effect of these changes is the erosion of data comparability between 2006 and subsequent years in relation to recipients and expenditure on the affected schemes.

From September 2007 a person may receive half-rate Carer's Allowance while in receipt of another social welfare payment. This may result in some double counting.

There were 15,790 recipients of a half-rate Carer's Allowance at the end of 2008.

Graph E1: Number of Recipients of Carer's Allowance by Sex, 1999 to 2008



SECTION FJOBSEEKER'S SUPPORTS

Section F: Jobseeker's Supports

The statistics in this section of the report relate to the Live Register, expenditure and recipients of jobseeker's payments.

Live Register and Jobseeker's Payments

The Live Register is a monthly statistical count compiled by the Central Statistics Office of certain categories of persons registered with the Department of Social and Family Affairs for Jobseeker's Benefit, Jobseeker's Allowance and credited Social Insurance contributions.

The Live Register comprises of the following classes of people under the age of 65 years:

- (i) all claimants of Jobseeker's Benefit excluding systematic short-time workers,
- (ii) applicants for Jobseeker's Allowance excluding smallholders and self-employed persons,
- (iii) other registrants including applicants for credited Social Welfare contributions but excluding those directly involved in an industrial dispute.

This means that not all persons who are in receipt of Jobseeker's Benefit or Allowance are on the Live Register. Some persons who are included on the Live Register e.g. applicants for credited contributions, are not in receipt of a Jobseeker's Benefit or Allowance payment.

The jobseeker's recipients figure shown in Section A and tables F3 and F4 is not directly comparable with the Live Register figure, as this figure only includes those who were in receipt of a payment at the end of December.

Time Series and Changes to Existing Payments

Farm Assist was introduced in April 1999 and replaced the Smallholders Unemployment Assistance scheme. The new scheme provides an income supplement for low-income farmers. The great majority of existing recipients of Smallholders Unemployment Assistance transferred to Farm Assist during the course of 1999 and 2000.

Data on expenditure on Farm Assist and recipients of Farm Assist/Smallholders is contained in Section G (Employment Supports). Expenditure on Jobseeker's Allowance shown in this section includes expenditure on Smallholders Unemployment Assistance in 1999. This affects the comparability of different years' figures in this section and in Section G.

Trends

Overall expenditure on Jobseeker's Supports increased by 47.7% over 2007.

Expenditure on Jobseeker's Benefit and Jobseeker's Allowance rose by nearly €385 million and €293 million compared with 2007, increases of 70.6% and 33.4% respectively.

The Live Register increased by 120,987 during 2008, an increase of 71%. Table F14 shows the numbers on the Live Register by County from 1999 to 2008 and the percentage increase in each county.

Graph F2: Number of Persons on the Live Register by Age and Sex, 2008





SECTION G EMPLOYMENT SUPPORTS

Section G: Employment Supports

The statistics in this section of the report relate to expenditure and recipients of a range of Employment Supports provided by the Department of Social and Family Affairs. These include:

- Family Income Supplement
- Back to Work Allowance
- Back to Work Enterprise Allowance
- Back to Education Allowance
- Part Time Job Incentive Scheme
- Farm Assist

Time Series and Existing Payments

Farm Assist was introduced in April 1999 and replaced the Smallholders Unemployment Assistance Scheme. The new scheme provides an income supplement for low-income farmers. The great majority of existing recipients of Smallholders Assistance transferred to Farm Assist during the course of 1999 and 2000.

Data on expenditure on Farm Assist and recipients of Farm Assist/Smallholders is contained in this Section. Expenditure on Smallholders Unemployment Assistance is contained in Section F (Jobseeker's Supports). This affects the comparability of different years' figures in this Section and in Section F.

Trends

Overall expenditure on Employment Supports increased by €52 million in 2008, an increase of 14.3% over 2007. The total number of recipients of Employment Supports rose by 6,004 an increase of 13.2%.


Expenditure on Family Income Supplement increased by 21.6%. The number of recipients of Family Income Supplement increased by 4,975 an increase of 21.8% over 2007. Expenditure on Back to Work Allowance (including Back to Work Enterprise Allowance) increased by over €2 million, an increase of 3%. The number of recipients of Back to Work Allowance decreased by 747, a decrease of 17.4%. The number of recipients of Back to Work Enterprise Allowance decreased by 224, a decrease of 4.6%. The number of recipients of Farm Assist increased by 120, an increase of 1.6% from the previous year.

SUPPLEMENTARY WELFARE ALLOWANCE

Section H: Supplementary Welfare Allowance

This section relates to payments made under the Supplementary Welfare Allowance scheme and includes:

- Basic Supplementary Welfare Allowance payments
- Rent supplements and Mortgage Interest supplements
- Other supplements
- Exceptional Needs Payments and Urgent Needs Payments
- The Back to School Clothing and Footwear Allowance scheme

Expenditure and Recipients

Expenditure on Supplementary Welfare Allowance amounted to €804 million in 2008. This represents an increase of 17.8% on 2007. Expenditure on Rent Supplements rose by over €49 million in 2008, an increase of 12.6%. The number of recipients of Rent Supplement at the end of 2008 was 78,038, an increase of 24.0% on 2007.

Expenditure on Mortgage Interest Supplements increased by 126.9% to €27.7 million. The number of recipients at the end of 2008 increased to 8,091 an increase of 96.8%.

In 2007, a Back to School Clothing and Footwear Allowance was paid in respect of 200,246 children, an increase of 19,994 on 2007. Expenditure on the scheme increased by 23.5% to 49.6 million.

Net expenditure on Basic SWA payments in 2008 was €184.8 million, an increase of 22.9% on 2007. Table H3 shows gross expenditure (€295.6 million) on Basic SWA payments in 2008. This represents the gross amount of expenditure on such Basic SWA payments before inter scheme adjustments and refunds have been taken into account. There were 35,546 recipients of Basic SWA payments at the end of 2008, an increase of 8,167 on 2007.

Graph H1: Expenditure on Supplementary Welfare Allowance, 1999 to 2008









Appendix 1: Social Insurance and Social Assistance

The Department of Social & Family Affairs provides a range of payments which can be classified as follows.

Social Insurance

Payments made under the social insurance system are funded, in part, by contributions from employers, employees and the self-employed. Any deficit in the fund is met by Exchequer subvention. Entitlement to social insurance benefits is conditional upon the claimants having a certain number of contributions paid or credited in a specific period of time. The contributions conditions vary according to the different insurance schemes.

Social Insurance schemes comprise State Pension (Contributory), State Pension (Transition), Widow/er's (Contributory) Pension, Guardian's Payment (Contributory), Deserted Wife's Benefit, Invalidity Pension, Illness Benefit, Disablement Pension, Carer's Benefit, Jobseeker's Benefit, Maternity Benefit, Health and Safety Benefit, Adoptive Benefit, Treatment Benefit, Widowed Parent Grant, Bereavement Grants and Household Benefits and Free Travel.

Social Assistance

Social Assistance schemes are financed entirely by the Exchequer. One of the basic requirements to qualify for payment under the social assistance schemes is that the claimant must satisfy a means test.

Social Assistance schemes comprise State Pension (Non-Contributory), Widow's (Non-Contributory) Pension, Guardian's Payment (Non-Contributory), Deserted Wife's Allowance, Prisoner's Wife's Allowance, One Parent Family Payment, Jobseeker's Allowance, Farm Assist, Pre-Retirement Allowance, Supplementary Welfare Allowance, Family Income Supplement, Disability Allowance, Carer's Allowance, Blind Pension, Rent Allowance and Household Benefits and Free Travel.

Child Benefit

Child Benefit is funded entirely by the Exchequer; it is payable in respect of all children regardless of family means.

Appendix 3: Glossary

Recipient: Person actually receiving a social welfare payment.

Qualified adult: Person in respect of whom a Qualified Adult Increase is paid to the

recipient.

Qualified child: Child in respect of whom an Increase for a Qualified Child is paid to the

recipient. This allowance is payable at half the rate where a spouse/ partner, living with the recipient, is not a Qualified Adult. Each spouse/ partner may receive half the Increase for a Qualified Child where both are

in receipt of a social welfare payment.

Beneficiaries: Total number of recipients, qualified adults and qualified children.

Claim/claimant: An application/applicant for a social welfare payment.

Social Insurance Payments: These comprise State Pension (Contributory), State Pension (Transition),

Widow/er's (Contributory) Pension, Guardian's Payment (Contributory), Deserted Wife's Benefit, Invalidity Pension, Illness Benefit, Carer's Benefit, Jobseeker's Benefit, Maternity Benefit, Health and Safety Benefit,

Adoptive Benefit, Treatment Benefit, Widowed Parent Grant, Bereavement

Grants and Household Benefits and Free Travel.

Social Assistance Payments: These comprise State Pension (Non-Contributory), Widow/er's (Non-

Contributory) Pension, Guardian's Payment (Non-Contributory), Deserted

Wife's Allowance, Prisoner's Wife's Allowance, One Parent Family

Payment, Jobseeker's Allowance, Farm Assist, Pre-Retirement Allowance, Supplementary Welfare Allowance, Family Income Supplement, Disability

Allowance, Carer's Allowance, Blind Pension, Rent Allowance and

Household Benefits and Free Travel.

Appendix 4: Details of Scheme Changes

The new State Pension (Non Contributory) was introduced in September 2006 replacing the Old Age (Non-Contributory) Pension and, for recipients aged 66 and over, Blind Pension, Widow/er's Pension, One Parent Family Payment, Deserted Wife's Allowance and Prisoner's Wife's Allowance. Qualified Adults of a State Pension (Non-Contributory) aged over 66 also qualified for a pension in their own right.

Also effective from September 2006 recipients of Invalidity Pension aged 66 years or over were automatically transferred to State Pension (Contributory).

These changes will affect the comparability of different year's figures in Section B, Older People, Section C, Widows, Widowers and One Parent Families and Section E, Illness, Disability and Caring.
