Foreword from the Minister

I welcome the publication of the 23rd edition of the Annual Statistical Report, which provides comprehensive statistical information on all programmes administered by the Department of Social and Family Affairs.

Accurate information is vital to support evidence-based policy making and enable the measurement of progress in these areas. This Department has been to the forefront of the recent trend across Government towards evidencebased policy, with recent Departmental expenditure reviews developing a focus on more complex social outcomes. As part of this approach, reliable data on outputs and trends as contained in this Report are invaluable elements in the development and implementation of policies to build social inclusion and progress social cohesion.

Supports administered by the Department provide for the complex and often multi-faceted needs of people over a range of contingencies and at every stage of life. Continuing to reflect the trend of recent years, social welfare programme expenditure increased to €12.2 billion in 2004 an increase of 7.8% over the previous year. This reaffirms the Government's commitment to the welfare of all those in need of support in this modern, increasingly demanding and rapidly evolving society.

Statistics tell their own story and in 2004:

- Social Welfare Expenditure was €12.2 billion, representing 28.2% of Gross Current Government Expenditure.
- Over 976,000 people were in receipt of a weekly Social Welfare payment, which was paid in respect of 1.5 million beneficiaries.
- Family Income Supplement was paid to 17,448 families with 33,956 children, an increase of 18.5% on the previous year and the highest level in the history of the scheme.. Expenditure on Family Income Supplement increased by 29.3% to €72.2m.
- 547,000 families received a monthly Child Benefit payment, which was paid in respect of 1,060,740 children. Expenditure on Child Benefit increased by 7.6% to €1.9 billion.
- Expenditure on Carer's Allowance and Carer's Benefit increased by 122.4% and 24.6% respectively. The numbers in receipt of a Carer's payment increased from 23,709 to 25,837, an increase of 9%.
- Expenditure on Old Age has increased by 8.0% to €2.95 billion. Payments were made to 311,170 people in this area.

Behind every one of the statistics in this report are real people involved in the day to day stresses, strains and struggles of working to build better lives for themselves and, in many cases, their families. That is why I am determined that increasingly we must strive to get behind the payments and the statistics and confront the social issues and problems that lead to the needs for the benefits, supports and entitlements in the first place.

This report charts the progress being made in improving and developing services, in tandem with wider Government aims and objectives, which have at their core the delivery of improved quality of life and opportunities to people of all ages.

Cuirim fáilte roimh an foilsiú den 23 eagrán den Tuarascáil Staitistiúil Bhliantúil, a sholáthraíonn eolas staitistiúil chuimsitheach ar na cláir go léir atá riartha ag an Roinn Gnóthaí Sóisialacha agus Teaghlaigh.

Tá eolas chruinn riachtanach chun tacaíocht a thabhairt do chinnteoireacht atá bunaithe ar fhianaise agus chun tomhas a dhéanamh ar an dul chun cinn sna réimsí seo a chumasú. Bhí an Roinn seo ar thús cadhnaíochta an chlaonta is déanaí trasna an Rialtas i dtreo polasaí atá bunaithe ar fhianaise, le hathbhreithnithe caiteachais Rannacha is déanaí ag forbairt fócas ar thorthaí sóisialta níos casta. Mar chuid den chur chuige seo, tá sonraí iontaofa ar aschur agus claontaí mar atá sa Tuarascáil seo mar eilimintí fíorluachmhara san fhorbairt agus sa fhorfheidhmiú de pholasaí chun cuimsiú sóisialta a thógáil agus comhtháthú sóisialta a chur ar aghaidh.

Forálann tacaíochtaí riartha ag an Roinn do na riachtanais chasta agus iltaobhach go minic de dhaoine thar réimse teagmhais agus ag gach céim den saol. Ag leanúint ag léiriú claonadh na blianta deireanacha, mhéadaigh caiteachas an chláir leasa shóisialaigh go \leq 12.2 billiún i 2004 - méadú de 7.8% thar an bhliain roimhe sin. Athdhearbhaíonn é seo geall an Rialtais chuig leas iad siúd go léir a bhfuil tacaíocht de dhíth orthu sa tsochaí nua-aimseartha, níos éilithí seo agus atá ag dul in éabhlóid go tapaigh.

Insíonn na staitisticí a scéal féin agus i 2004:

- Ba é €12.2 billiún an Caiteachas Leasa Shóisialaigh, ag seasamh do 28.2% de Chaiteachas Chomhlán Reatha an Rialtais.
- Bhí thar 976,000 duine ag fáil íocaíochta Leasa Shóisialaigh sheachtainiúil, a d'íocadh i leith 1.5 milliún tairbhithe.
- Íocadh Forlíonadh Ioncaim Teaghlaigh i leith 17,448 teaghlach le 33,956 páiste, méadú de 18.5% ar an mbliain roimhe sin agus an leibhéal is airde i stair na scéime. Mhéadaigh caiteachas ar Fhorlíonadh Ioncaim Teaghlaigh faoi 29.3% go €720.2m.
- Fuair 547,000 teaghlach íocaíocht Sochair Leanaí míosúil, a d'íocadh i leith 1,060,740 leanbh. Mhéadaigh caiteachas ar Shochar Leanaí faoi 7.6% go €1.9 billiún.
- Mhéadaigh caiteachas ar an Liúntas Cúramóra agus Sochar Cúramóra faoi 122.4% agus 24.6% faoi seach. Mhéadaigh líon na ndaoine atá ag fáil íocaíochta Cúramóra ó 23,709 go 25,837, méadú de 9%
- Tá caiteachas ar an Seanaois méadaithe faoi 8.0% go €2.95 billiún. Rinneadh íocaíochtaí de 311,170 duine sa cheantar seo.

Tá daoine réalacha lena bhfuil baint acu le na struis, teanna agus coimhlintí laethúla a bhaineann le oibriú chun saolta níos fearr a thógáil dóibh féin agus, in a lán cásanna, a theaghlaigh taobh thiar de gach ceann de na staitisticí. Sin é an fáth go bhfuilim tiomanta go gcaithfimid ár ndícheall a dhéanamh i gcónaí chun tacaíochta a thabhairt do na híocaíochtaí agus na staitisticí agus na saincheisteanna agus na fadhbanna sóisialta a leanann don ghá do na sochair, tacaíochtaí agus teidlíochtaí sa chéad dul síos.

Léiríonn an tuarascáil seo go bhfuil dul chun cinn leanúnach á dhéanamh chun seirbhísí a fhorbairt agus a fheabhsú, in éineacht le haidhmeanna agus cuspóirí níos leithne an Rialtais, lena bhfuil an seachadadh de chaighdeán maireachtála agus deiseanna do dhaoine de gach aois mar chuid lárnach acu.

Introduction

General

This is the twenty third issue of the annual "Statistical Information on Social Welfare Services" prepared by the Department of Social and Family Affairs. It sets out comprehensive data relating to services provided by the Department.

The statistics set out in this report relate to 2005 and earlier years. In the case of data relating to recipients and beneficiaries, the figures, unless otherwise stated, refer to the 31st December each year. Several tables, which provide a breakdown of recipients or beneficiaries by some characteristic such as number of dependants or age, are referred to as "estimated". This means that the proportionate breakdown, which is considered to be a reliable estimate, was established at a date other than, but close to, 31st December.

Expenditure figures for 2005 are provisional pending certification by the Comptroller and Auditor General. All Expenditure figures have been converted to Euro amounts.

Source of Data

The source for the statistics presented, unless otherwise stated, is the Department of Social and Family Affairs.

Time Series and Changes to Existing Payments

Time Series data are given, where available. However, the introduction of new payments and changes to existing payments affect the comparability of different years' figures in some instances. Relevant tables are footnoted where appropriate.

SECTION A SUMMARY AND FINANCIAL

Section A: Summary and Financial

Expenditure

Total Social Welfare expenditure in 2005 was €12,168 million, an increase of 7.8% over 2004. Expenditure in 2005 represented 28.2 % of Gross Current Government expenditure and was equivalent to 9.0% of GNP (Table A2). The main areas of expenditure by programme group were Old Age (24.2%), Widow's, Widower's and One Parent Families (16.3%), Illness, Disability and Caring (17.2%), Unemployment Supports (8.9%), Child Related Payments (16.8 %), Supplementary Welfare Allowance (5.1%), and Employment Supports (2.0%). Administration of the social welfare system accounted for 3.8% of total expenditure (Graph A1).

Total Social Welfare expenditure was financed by the Exchequer (53.5%) and the Social Insurance Fund (46.5%). The Social Insurance Fund was financed by Pay Related Social Insurance contributions from employers (70.9%), employees (22.1%), the self-employed (6.2%) and Investment Income (0.8%). See Tables A6 and A7.

Recipients of Weekly Social Welfare Payments

Over 976,600 people were in receipt of a weekly social welfare payment at the end of 2005. As these payments included increases in respect of over 119,200 Qualified Adults and over 339,300 Children, there were over 1,469,100 beneficiaries in all. The number of recipients increased by 18,881 and the number of beneficiaries increased by 5,185 year on year.

Expenditure on Social Welfare by Programme, 2005





Expenditure on Main Social Assistance Schemes, 1996 to 2005



Financing of the Social Insurance Fund, 2005











SECTION B OLD AGE

Section B: Old Age

Expenditure and Recipients

Expenditure on Old Age payments was over €2,947 million in 2005. This represents an increase of 8.0% on 2004.

The overall number of Old Age payments rose by 7,517 in 2005, an increase of 2.5%. The number of people in receipt of a contributory pension (Old Age Contributory Pension and Retirement Pension) based on social insurance contributions rose by 8,405 while the number of people in receipt of the means tested Old Age (Non-Contributory) Pension fell by 718. The number of persons in receipt of Pre-Retirement Allowance fell by 170 in 2005.

Over the last ten years, the number of recipients of Old Age (Contributory) Pension rose by 56,623 and the number of recipients of Old Age (Non-Contributory) Pension fell by 17,170. The number of recipients of Retirement Pension increased by 21,307, and the number of recipients of Pre-Retirement Allowance has fallen by 3,093 in the same period. Number of Recipients of Old Age Pensions, 1996 to 2005



SECTION C WIDOWS, WIDOWERS AND ONE-PARENT FAMILIES

Section C: Widows, Widowers and One-Parent Families

Expenditure and Recipients

Expenditure on Widows, Widowers and One Parent Families increased by 8.5% overall in 2005.

The payment in this programme group with both the largest expenditure and number of recipients is Widow's and Widower's (Contributory) Pension. At the end of 2005 there were 109,017 recipients (96,214 widows and 12,803 widowers). Expenditure in 2005 was over €998 million which represented an increase of 10.2% over 2004.

The number of recipients of Deserted Wife's Benefit and Deserted Wife's Allowance fell by 589 and 74 respectively during 2005.

Expenditure on One-Parent Family Payment increased by 8.1%, while the number of recipients rose by 263.

Number of Recipients of One-Parent Family Payment by Age and Sex, 2005



SECTION D CHILD RELATED PAYMENTS

Section D: Child Related Payments

Expenditure and Recipients

This section relates to payments made in respect of children such as Child Benefit, Orphan's Pensions and Maternity related payments. For ease of reference, this section also gives details of increases in respect of qualified children which are payable with social welfare payments (See Table D10). It should be noted however, that for the purpose of apportioning expenditure between programmes, the cost of qualified child increases are included with the main payment e.g. Qualified Child increases paid with Old Age pensions are included in the 'Old Age' programme.

Expenditure on payments in this programme group rose by 7.4% in 2005. The breakdown of Child Benefit by family size shows that 73.6% of recipient families in 2005 have either one or two children. The equivalent percentage for 1996 was 68.9%. See Table D8 and Graph D1. The number of families receiving Child Benefit rose by 6,629 to 547,540. The total number of children in respect of whom Child Benefit is paid increased by 9,735 to 1,060,740.

Expenditure on Child Benefit increased by over €134 million in 2005, an increase of 7.6% while Maternity Benefit expenditure increased by nearly €11 million, an increase of 8.9%.

Number of Families Receiving Child Benefit by Number of Child Beneficiaries, 1996 to 2005



Section E: Illness, Disability and Caring

Expenditure and Recipients

Expenditure on Disability Benefit and Invalidity Pension increased by 12.8 % and 12.5% respectively. Disability Allowance was introduced in October 1996 and replaced Disabled Persons Maintenance Allowance (DPMA) which was administered by the Health Boards. Expenditure on Disability Allowance increased by 15.8% to over €630 million. There are now 79,253 recipients of the scheme.

Carer's Allowance was introduced in October 1990. Expenditure on Carer's Allowance increased by over €47 million in 2005, an increase of 22.4%. There are now 24,970 recipients of the Scheme, an increase of 1,940 year on year.

Graph E1 and Table E4 show details of the numbers of Carer's Allowance recipients from 1996 to 2005.

Carer's Benefit is a payment made to insured persons who leave the workforce to care for a person(s) who require full time care and attention. The number of recipients increased by 188 to 867, year on year.

Number of Recipients of Carer's Allowance by Sex, 1996 to 2005



SECTION F UNEMPLOYMENT SUPPORTS

Section F: Unemployment Supports

The statistics in this section of the report relate to the Live Register, expenditure and recipients of unemployment payments;

Live Register and Unemployment Payments

The Live Register is a monthly statistical count compiled by the Central Statistics Office of certain categories of persons registered with the Department of Social and Family Affairs for Unemployment Benefit, Unemployment Assistance and credited Social Insurance contributions.

The Live Register comprises of the following classes of persons under the age of 65 years:

- (i) all claimants of Unemployment Benefit excluding systematic short-time workers,
- (ii) applicants for Unemployment Assistance excluding smallholders and self-employed persons,
- (iii) other registrants including applicants for credited Social Welfare contributions but excluding those directly involved in an industrial dispute.

This means that not all persons who are in receipt of Unemployment Benefit or Assistance are on the Live Register. Some persons who are included on the Live Register e.g. applicants for credited contributions, are not in receipt of an unemployment benefit or assistance payment.

The Unemployment Recipients figure shown in Section A and tables F3 and F4 is not directly comparable with the Live Register figure, as this figure only includes those who were in receipt of a payment at the end of December.

Time Series and Changes to Existing Payments

Farm Assist was introduced in April 1999 and replaced the Smallholders Unemployment Assistance scheme. The new scheme provides an income supplement for low-income farmers. The great majority of existing recipients of Smallholders Unemployment Assistance transferred to Farm Assist during the course of 1999 and 2000.

Data on expenditure on Farm Assist and recipients of Farm Assist/Smallholders is contained in Section G (Employment Supports). Expenditure on Unemployment Assistance shown in this Section includes expenditure on Smallholders Unemployment Assistance in 1999 and earlier years. This affects the comparability of different years' figures in this Section and in Section G.

Trends

Overall expenditure on Unemployment Supports increased by 1.6% over 2004.

Expenditure on Unemployment Assistance rose by over €53 million compared with 2004, an increase of 8.7%. Expenditure on Unemployment Benefit fell by over €37 million, a decrease of 8.1% on 2004

The Live Register decreased by 2,983 during 2005, a decrease of 1.9%. Table F14 shows the numbers on the Live Register by County from 1996 to 2005 and the percentage decrease in each county.

Expenditure on Unemployment Benefit/Pay Related Benefit and Unemployment Assistance, 1996 to 2005



Number of Persons on the Live Register by Age and Sex, 2005






The statistics in this section of the report relate to expenditure and recipients of a range of Employment Supports provided by the Department of Social and Family Affairs. These include:

- Family Income Supplement
- Back to Work Allowance
- Back to Work Enterprise Allowance
- Back to Education Allowance
- Part Time Job Incentive Scheme
- Farm Assist

Time series and Existing Payments

Farm Assist was introduced in April 1999 and replaced the Smallholders Unemployment Assistance Scheme. The new scheme provides an income supplement for low-income farmers. The great majority of existing recipients of Smallholders Assistance transferred to Farm Assist during the course of 1999 and 2000.

Data on expenditure on Farm Assist and recipients of Farm Assist/Smallholders is contained in this Section. Expenditure on Smallholders Unemployment Assistance is contained in Section F (Unemployment Supports). This affects the comparability of different years' figures in this Section and in Section F.

Trends

Overall expenditure on Employment Supports increased by \in 7.9 million in 2005, a decrease of 3.3 % over 2004. The total number of recipients of Employment Supports decreased by 627, a decrease of 1.6%.

Expenditure on Family Income Supplement increased by 29.3%. The number of recipients of Family Income Supplement increased by 2,721, an increase of 18.5% over 2004. Expenditure on Back to Work Allowance (including Back to Work Enterprise Allowance) decreased by over €12 million, a decrease of 18.5% The number of recipients of Back to Work Allowance decreased by 1,065, a decrease of 22.6%. The number of recipients of Back to Work Enterprise Allowance decreased by 1,558, a decrease of 22.7%. The number of recipients of Farm Assist/Smallholders decreased by 526, a decrease of 6.3% from the previous year.

Expenditure on Employment Supports, 1996 to 2005



Section H: Supplementary Welfare Allowance

This section relates to payments made under the Supplementary Welfare Allowance scheme and includes:

- Basic Supplementary Welfare Allowance payments
- Rent supplements and Mortgage Interest supplements
- Other supplements
- Exceptional Needs Payments and Urgent Needs Payments
- The Back to School Clothing and Footwear Allowance scheme

Expenditure and Recipients

Expenditure on Supplementary Welfare Allowance amounted to over \le 624 million in 2005. This represents an increase of 3.7% on 2004. Expenditure on Rent Supplements rose by over \le 14 million in 2005, an increase of 4.2%. The number of recipients of Rent Supplement at the end of 2005 was 60,176, an increase of 4.0% on 2004

Expenditure on Mortgage Interest Supplements remained at \leq 6.3 million, with a small increase of 0.1%. The number of recipients at the end of 2005 decreased to 2,741, a decrease of 0.8%.

In 2005, a Back to School Clothing and Footwear Allowance was paid in respect of 157,254 children, an increase of 3,845 on 2004. Expenditure on the scheme decreased by 1.8 % to \leq 16.7 million.

Net expenditure on Basic SWA payments in 2005 was \le 162.4 million, a decrease of 2.4 % on 2004. Table H3 shows gross expenditure (\le 217.4 million) on Basic SWA payments in 2005. This represents the gross amount of expenditure on such Basic SWA payments before inter scheme adjustments and refunds have been taken into account. There were 28,066 recipients of Basic SWA payments at the end of 2005, a decrease of 1,682 on 2004.

Table H2 and Graph H1 show expenditure on Supplementary Welfare Allowance from 1996 to 2005.



Expenditure on Household Benefits and Free Travel, 2005





APPENDICES

Appendix 1: Social Insurance and Social Assistance

The Department of Social & Family Affairs provides a range of payments which can be classified as follows.

Social Insurance

Payments made under the social insurance system are funded, in part, by contributions from employers, employees and the self-employed. Any deficit in the fund is met by Exchequer subvention. Entitlement to social insurance benefits is conditional upon the claimants having a certain number of contributions paid or credited in a specific period of time. The contributions conditions vary according to the different insurance schemes.

Social insurance schemes comprise Old Age (Contributory) Pension, Retirement Pension, Widow's/Widower's (Contributory) Pension, Orphan's (Contributory) Allowance, Deserted Wife's Benefit, Invalidity Pension, Disability Benefit, Carer's Benefit, Unemployment Benefit, Maternity Benefit, Health and Safety Benefit, Adoptive Benefit, Treatment Benefit, Widowed Parent Grant, Bereavement Grants and Household Benefits and Free Travel.

Social Assistance

Social Assistance schemes are financed entirely by the Exchequer. One of the basic requirements to qualify for payment under the social assistance schemes is that the claimant must satisfy a means test.

Social Assistance schemes comprise Old Age (Non-Contributory) Pension, Widow's (Non-Contributory) Pension, Orphan's (Non-Contributory) Pension, Deserted Wife's Allowance, Prisoner's Wife's Allowance, One Parent Family Payment, Unemployment Assistance, Farm Assist, Pre-Retirement Allowance, Supplementary Welfare Allowance, Family Income Supplement, Disability Allowance, Carer's Allowance, Blind Pension, Rent Allowance and Household Benefits and Free Travel.

Child Benefit

Child Benefit is funded entirely by the Exchequer; it is payable in respect of all children regardless of family means.

Appendix 3: Glossary

Recipient: Person actually receiving a social welfare payment.

Qualified Adult: Person in respect of whom a Qualified Adult Increase is paid to the

recipient.

Qualified Child: Child in respect of whom a Qualified Child Increase is paid to the recipient.

This allowance is payable at half the rate where a spouse/partner, living with the recipient, is not a Qualified Adult. Each spouse/partner may receive half the Qualified Child Increase where both are in receipt of a social

welfare payment.

Beneficiaries: Total of recipients, qualified adults and qualified children.

Claim/Claimant: An application/applicant for a social welfare payment.

Social Insurance Payments: These comprise Old Age (Contributory) Pension, Retirement Pension,

Widow's/Widower's (Contributory) Pension, Orphan's (Contributory)
Allowance, Deserted Wife's Benefit, Invalidity Pension, Disability Benefit,
Carer's Benefit, Unemployment Benefit, Maternity Benefit, Health and
Safety Benefit, Adoptive Benefit, Treatment Benefit, Widowed Parent Grant,
Bereavement Grants and Household Benefits and Household Benefits and

Free Travel.

Social Assistance Payments: These comprise Old Age (Non-Contributory) Pension, Widow's (Non-
