Cuirim fáilte roimh fhoilsiú Thuairisc Bhliantúil Staitistiúil 2002, an fichiú eagrán den Tuairisc seo a sholáthraíonn eolas cuimsitheach staitistiúil ar na Seirbhísí Leasa Shóisialta go léir a fheidhmíonn an Roinn seo, chomh maith le heolas ar threochtaí le deich mbliana anuas.

Feidhmíonn an Roinn seo réimse leathan scéimeanna agus seirbhísí a théann chun leasa teaghlach mar aon le leas an phobail i gcoitinne agus tá sí lárnach maidir le cosaint shóisialta a sholáthar sa tír seo. Beidh luach sonrach ag baint leis an Tuairisc maidir le forbairt pholasaí a fhreagróidh ar a bhfuil ag teastáil ó dhaoine i réimse leathan imthosca.

Ón bhreith, tríd an saol go bás, cuidíonn ár gcóras tacaíochta sóisialta a fheidhmíonn mo Roinn, thart ar shaoránach amháin as gach triúr ag aon am ar leith. Caitheadh E9.52 billiún de bhuiséad anuraidh agus leis sin, tá an méadú de 21.4% i gcaiteachas leasa shóisialta fanta os cionn an ráta boilscithe agus tá méadú de níos mó ná E3.5 billiún tagtha air idir 1997 agus 2002.

I measc na bhforbairtí tábhachtacha i 2002 atá léirithe sa Tuairisc tá:

- E9.52 billiún an caiteachas iomlán Leasa Shóisialta i 2002, a bhí mar 28.8% de chaiteachas Comhlán Reatha Rialtais.
- Bhí níos mó ná 938,000 duine ag fáil íocaíochta seachtainiúla Leasa Shóisialta ag deireadh 2002.
- Tháinig méadú 15.5% ar chaiteachas ar Íocaíochtaí Seanaoise i gcomparáid le 2001.
- Tháinig méadú 49.2% ar Íocaíochtaí a Bhaineann le Leanaí i 2002.
- Tháinig méadú E30 milliún ar chaiteachas ar Liúntas Feighlí i 2002, méadú 22.8% le hais 2001.
- Tháinig méadú 4.1% ar líon na ndaoine a raibh Forlíonadh Ioncam Teaghlaigh á fháil acu, agus leis sin méadú 14.4% ar chaiteachas.
- Sa bhliain 2002, íocadh Liúntas Éadaí agus Bróg leo siúd ag bhí ag dul ar ais ar scoil i dtaobh 155,811 páiste, méadú de 12,782 páiste le hais 2001 agus leis sin, tháinig méadú 18.8% ar chaiteachas ar an scéim go dtí giota beag níos mó ná £15 milliún.

Déanann ár gcuid polasaithe maidir le seirbhísí sóisialta difir mór i saol ár saoránach nuair a chomhaontaítear iad lenár bpolasaithe maidir le hoideachas, tithíocht, sláinte, rialú agus eile, agus tá mé ceangailte le coinneáil ar aghaidh le cothabháil agus forbairt na seirbhísí sóisialta sin. Is gné thábhachtach den phróiseas seo eolas cruinn a chur ar fáil ag an am cuí agus cuireann an Tuairisc seo go mór leis sin ar bhealach tábhachtach.

Mar fhocal scoir, ba mhaith liom an deis seo a thapú buíochas a ghabháil leis an réimse leathan chomhaltaí foirne sa Roinn a chuidigh leis an Tuairisc a chur le chéile.

Foreword from the Minister

I welcome the publication of the 2002 Annual Statistical Report, the twentieth edition of this Report, which provides comprehensive statistical information on all Social Welfare Services operated by this Department, in addition to trends over the past ten years.

This Department operates a broad range of schemes and services to benefit families as well as the wider community and is central to the provision of social protection in this country. The Report will be of significant value in the development of policies responsive to the needs of people in a wide variety of circumstances.

From birth, through life to death, our system of social supports administered by my Department helps approximately one in three citizens at any one time. With a Budget spend last year of £9.52 billion the increase of 21.4% in social welfare spending has remained above the rate of inflation and increased by over £3.5 billion between 1997 and 2002.

Important developments in 2002 highlighted in the Report include:

- Total Social Welfare expenditure in 2002 was E9.52 billion, which represented 28.8% of Gross Current Government expenditure.
- Over 938,000 people were in receipt of a weekly social welfare payment at the end of 2002.
- Expenditure on Old Age Payments increased by 15.5% on 2001.
- Expenditure on Child Related Payments rose by 49.2% in 2002.
- Carer's Allowance expenditure increased by E30 million in 2002, an increase of 22.8% over 2001.
- The number of recipients of Family Income Supplement increased by 4.1% with an increase in expenditure of 14.4%.
- In 2002, a Back to School Clothing and Footwear Allowance was paid in respect of 155,811 children, an increase of 12,782 on 2001 with expenditure on the scheme increased by 18.8% to just over £15 million.

Our social service policies allied to our policies on education, housing, health and governance to name a few, make real differences to the lives of our citizens and I am committed to the ongoing maintenance and development of those social services. Timely and accurate information is a key input to this process and this Report makes an important contribution in this regard.

Finally, I would like to take this opportunity to thank the wide range of staff in the Department who contributed to the compilation of the Report.

Introduction

General

This is the twentieth issue of the annual "Statistical Information on Social Welfare Services" prepared by the Department of Social and Family Affairs. It sets out comprehensive data relating to services provided by the Department.

The statistics set out in this report relate to 2002 and earlier years. In the case of data relating to recipients and beneficiaries, the figures, unless otherwise stated, refer to the 31st December each year. Several tables, which provide a breakdown of recipients or beneficiaries by some characteristic such as number of dependants or age, are referred to as "estimated". This means that the proportionate breakdown, which is considered to be a reliable estimate, was established at a date other than, but close to, 31st December.

Expenditure figures for 2002 are provisional pending certification by the Comptroller and Auditor General. All Expenditure figures have been converted to Euro amounts.

Source of Data

The source for the statistics presented, unless otherwise stated, is the Department of Social and Family Affairs.

Time Series and Changes to Existing Payments

Time Series data are given, where available. However, the introduction of new payments and changes to existing payments affect the comparability of different years' figures in some instances. Relevant tables are footnoted where appropriate.

Section A: Summary and Financial

Expenditure

Total Social Welfare expenditure in 2002 was E9,520 million, an increase of 21.4% over 2001. Expenditure in 2002 represented 28.8% of Gross Current Government expenditure and was equivalent to 9.1% of GNP (Table A2). The main areas of expenditure by programme group were Old Age (24.1%), Widow's, Widower's and One-Parent Families (16.7%), Illness, Disability and Caring (15.4%), Unemployment Support (9.8%), Child Related Payments (16.6%), Supplementary Welfare Allowance (5.1%), and Employment Support (2.8%). Administration of the social welfare system accounted for 4.4% of total expenditure (Graph A1).

Total Social Welfare expenditure was financed by the Exchequer (54%) and the Social Insurance Fund (46%). The Social Insurance Fund was financed by Pay Related Social Insurance contributions from employers (73.4%), employees (20.3%), the self-employed (5.3%) and Investment Income (1.1%). See Tables A6 and A7.

Recipients of Weekly Social Welfare Payments

Over 938,000 people were in receipt of a weekly social welfare payment at the end of 2002. As these payments included increases in respect of over 126,000 Qualified Adults and over 405,000 Children, there were just over 1,495,000 beneficiaries in all. The number of recipients and beneficiaries increased by 35,596 and 36,140 respectively, year on year.

Expenditure on Social Welfare by Programme, 2002





^{(2) €635} million was transferred to the exchequer in 2002.





Section B: Old Age

Expenditure and Recipients

Expenditure on Old Age payments was over £2,296 million in 2002. This represents an increase of 15.5% on 2001.

The overall number of Old Age payments rose by 11,330 in 2002, an increase of 4.1%. The number of people in receipt of a contributory pension (Old Age Contributory Pension and Retirement Pension) based on social insurance contributions rose by 13,153 while the number of people in receipt of the means tested Old Age (Non-Contributory) Pension fell by 1,238. The number of persons in receipt of Pre-Retirement Allowance fell by 585 in 2002.

Over the last ten years, the number of recipients of Old Age (Contributory) Pension rose by 33,434 and the number of recipients of Old Age (Non-Contributory) Pension fell by 23,188. The number of recipients of Retirement Pension increased by 24,655, and the number of recipients of Pre-Retirement Allowance has fallen by 4,660 in the same period. Section C: Widows, Widowers and One-Parent Families

Expenditure and Recipients

Expenditure on Widows, Widowers and One-Parent Families increased by 12.7% overall.

The payment in this programme group with both the largest expenditure and number of recipients is Widow's and Widower's (Contributory) Pension. At the end of 2002, there were 102,494 recipients (91,826 widows and 10,668 widowers). Expenditure in 2002 was over £761 million which represented an increase of 13.2% over 2001.

The number of recipients of Deserted Wife's Benefit and Deserted Wife's Allowance declined during 2002. This arises as a result of the discontinuation of these payments for new claimants with effect from January 1997. One-Parent Family Payment replaced these payments, Prisoners Wife's Allowance and Lone Parent's Allowance from that date.

Expenditure on One-Parent Family Payment increased by 14.1%, while the number of recipients rose by over 2,000.



Section D: Child Related Payments

Expenditure and Recipients


This section relates to payments made in respect of children such as Child Benefit, Orphan's Pensions, and Maternity related payments. For ease of reference, this section also gives details of increases in respect of qualified children which are payable with social welfare payments (See Table D10). It should be noted, however, that for the purpose of apportioning expenditure between programmes, the cost of qualified child increases are included with the main payment e.g. Qualified Child increases paid with Old Age pensions are included in the 'Old Age' programme.

Expenditure on payments in this programme group rose by 49.2% in 2002. The breakdown of Child Benefit by family size shows that 74.2% of recipient families in 2002 have either one or two children. The equivalent percentage for 1994 was 67.2%. See Table D8 and Graph D1. The number of families receiving Child Benefit rose by 7,522 to 522,441. The total number of children in respect of whom Child Benefit is paid increased by 1,376 to 1,019,551.

Expenditure on Child Benefit increased by £498 million in 2002, an increase of 51.6% while Maternity Benefit expenditure increased by over £20 million, an increase of 25.6%.

Section E: Illness, Disability and Caring

Expenditure and Recipients

Expenditure on Disability Benefit and Invalidity Pension increased by 16.8% and 13.9% respectively. Disability Allowance was introduced in October 1996 and replaced Disabled Persons Maintenance Allowance (DPMA) which was administered by the Health Boards. Expenditure on Disability Allowance increased by 22.7% to over E407 million. There are now 62,783 recipients of the scheme.

Carer's Allowance was introduced in October 1990. Expenditure on Carer's Allowance increased by nearly E30 million in 2002, an increase of 22.8%. There are now 20,395 recipients of the Scheme, an increase of 1,610 year on year.

Graph E1 and Table E4 show details of the numbers of Carer's Allowance recipients from 1993 to 2002.

Carer's Benefit is a payment made to insured persons who leave the workforce to care for a person(s) who require full time care and attention. The number of recipients increased by 195 to 615, year on year.

Number of Reciepients of Carer's Allowance by Sex, 1993 to 2002





Section F: Unemployment Supports

The statistics in this section of the report relate to the Live Register, expenditure and recipients of unemployment payments:

Live Register and Unemployment Payments

The Live Register is a monthly statistical count compiled by the Central Statistics Office of certain categories of persons registered with the Department of Social and Family Affairs for Unemployment Benefit, Unemployment Assistance and credited Social Insurance contributions.

The Live Register comprises of the following classes of persons under the age of 65 years:

- (i) all claimants of Unemployment Benefit excluding systematic short-time workers,
- (ii) applicants for Unemployment Assistance excluding smallholders and self-employed persons,
- (iii) other registrants including applicants for credited Social Welfare contributions but excluding those directly involved in an industrial dispute.

This means that not all persons who are in receipt of Unemployment Benefit or Assistance are on the Live Register. Some persons who are included on the Live Register e.g. applicants for credited contributions, are not in receipt of an unemployment benefit or assistance payment.

Time Series and Changes to Existing Payments

Farm Assist was introduced in April 1999 and replaced the Smallholders Unemployment Assistance scheme. The new scheme provides an income supplement for low-income farmers. The great majority of existing recipients of Smallholders Unemployment Assistance transferred to Farm Assist during the course of 1999 and 2000. There were 750 recipients of Smallholders Unemployment Assistance at the end of 1999 163 at the end of December 2000, 88 at the end of December 2001 and 33 at the end of December 2002.

Data on expenditure on Farm Assist and recipients of Farm Assist/Smallholders is contained in Section G (Employment Supports). Expenditure on Unemployment Assistance shown in this Section includes expenditure on Smallholders Unemployment Assistance in 1999 and earlier years. This affects the comparability of different years' figures in this Section and in Section G.

Trends

Overall expenditure on Unemployment Supports increased by 29.8% over 2001.

Expenditure on Unemployment Assistance rose by over E82 million over 2001, an increase of 8.4%. Expenditure on Unemployment Benefit rose by nearly E133 million, an increase of 45.7% over 2001.

The Live Register increased by 13,736 during 2002, an increase of 9.0%. Table F14 shows the numbers on the Live Register by County in 2001 and 2002 and the percentage increase/decrease in each county.



Number of Persons on the Live Register by Age and Sex, 2002





Section G: Employment Supports

The statistics in this section of the report relate to expenditure and recipients of a range of Employment Supports provided by the Department of Social and Family Affairs. These include:

- · Family Income Supplement
- · Back to Work Allowance
- Back to Work Enterprise Allowance
- Back to Education Allowance
- · Part Time Job Incentive Scheme
- Farm Assist
- Student Summer Job Scheme

Time series and Existing Payments

Farm Assist was introduced in April 1999 and replaced the Smallholders Unemployment Assistance Scheme. The new scheme provides an income supplement for low-income farmers. The great majority of existing recipients of Smallholders Assistance transferred to Farm Assist during the course of 1999 and 2000. There were 8,514 recipients of Farm Assist/Smallholders at the end of 2002, of which 33 continued to be in receipt of Smallholders Unemployment Assistance.

Data on expenditure on Farm Assist and recipients of Farm Assist/Smallholders is contained in this Section. Expenditure on Smallholders Unemployment Assistance is contained in Section F (Unemployment Supports). This affects the comparability of different years' figures in this Section and in Section F.

Trends

Overall expenditure on Employment Supports decreased by £14.5 million in 2002, a decrease of 5.1% over 2002. The total number of recipients of Employment Supports decreased by 5,972, a decrease of 10.5%.

Expenditure on Family Income Supplement increased by 14.4%. The number of recipients of Family Income Supplement increased by 163, an increase of 1.4% over 2001. Expenditure on Back to Work Allowance (including Back to Work Enterprise Allowance) decreased by over £28 million, a decrease of 18.1%. The number of recipients of Back to Work Allowance decreased by 4,722, a decrease of 29.1%. The number of recipients of Back to Work Enterprise Allowance decreased by 2,483, a decrease of 15.5%. The number of recipients of Farm Assist/Smallholders increased by 134, an increase on 1.6% over the previous year.

Expenditure in 2002 shown in respect of the Students Summer Jobs Scheme declined by 98.4% over 2001 as responsibility for this scheme was transferred to the Department of Community, Rural and Gaeltacht Affairs during the year.

Expenditure on Employment Supports, 1993 to 2002



Section H: Supplementary Welfare Allowance

This section relates to payments made under the Supplementary Welfare Allowance scheme and includes:

- Basic Supplementary Welfare Allowance payments
- Rent Supplements and Mortgage Interest Supplements
- Other supplements
- · Exceptional Needs Payments and Urgent Needs Payments
- The Back to School Clothing and Footwear Allowance Scheme

Expenditure and Recipients

Expenditure on Supplementary Welfare Allowance amounted to £485 million in 2002. This represents an increase of 33.4% on 2001. Expenditure on Rent Supplements rose by over £72 million in 2002, an increase of 40.6%. The number of recipients of Rent Supplement at the end of 2002 was 54,213, an increase of 20.4% on 2001.

Expenditure on Mortgage Interest Supplements rose to over £7.6 million, an increase of 20.8%. The number of recipients at the end of 2002 increased to 4,359, an increase of 7.3%.

In 2002, Back to School Clothing and Footwear Allowance was paid in respect of 155,811 children, an increase of 12,782 on 2001. Expenditure on the scheme increased by 18.8% to over £15 million.

Net expenditure on Basic SWA payments in 2002 was £145 million, an increase of 28.4% on 2001. Table H3 shows gross expenditure (£194 million) on Basic SWA payments in 2002. This represents the gross amount of expenditure on such Basic SWA payments before inter scheme adjustments and refunds have been taken into account. There were 32,073 recipients of Basic SWA payments at the end of 2002, an increase of over 2,900 on 2001.

Table H2 and Graph H1 shows expenditure on Supplementary Welfare Allowance from 1993 to 2002.

Expenditure on Supplementary Welfare Allowance, 1993 to 2002



Expenditure on Free Schemes, 2002





Appendices

Appendix 1: Social Insurance and Social Assistance

The Department of Social & Family Affairs provides a range of payments which can be classified as follows.

Social Insurance

Payments made under the social insurance system are funded, in part, by contributions from employers, employees and the self-employed. Any deficit in the fund is met by Exchequer subvention. Entitlement to social insurance benefits is conditional upon the claimants having a certain number of contributions paid or credited in a specific period of time. The contributions conditions vary according to the different insurance schemes.

Social insurance schemes comprise Old Age (Contributory) Pension, Retirement Pension, Widow's/Widower's (Contributory) Pension, Orphan's (Contributory) Allowance, Deserted Wife's Benefit, Invalidity Pension, Disability Benefit, Carer's Benefit, Unemployment Benefit, Maternity Benefit, Health and Safety Benefit, Adoptive Benefit, Treatment Benefit, Widowed Parent Grant, Bereavement Grants and Free Schemes.

Social Assistance

Social Assistance schemes are financed entirely by the Exchequer. One of the basic requirements to qualify for payment under the social assistance schemes is that the claimant must satisfy a means test.

Social Assistance schemes comprise Old Age (Non-Contributory) Pension, Widow's (Non-Contributory) Pension, Orphan's (Non-Contributory) Pension, Deserted Wife's Allowance, Prisoner's Wife's Allowance, One-Parent Family Payment, Unemployment Assistance, Farm Assist, Pre-Retirement Allowance, Supplementary Welfare Allowance, Family Income Supplement, Disability Allowance, Carer's Allowance, Blind Pension, Rent Allowance and Free Schemes.

Child Benefit

Child Benefit is funded entirely by the Exchequer; it is payable in respect of all children regardless of family means.

Appendix 3: Glossary

Recipient:	Person actually receiving a social welfare payment.		
Qualified Adult:	Person in respect of whom a Qualified Adult Increase is paid to the recipient.		
Qualified Child:	Child in respect of whom a Qualified Child Increase is paid to the recipient. This allowance is payable at half the rate where a spouse/partner, living with the recipient, is not a Qualified Adult. Each spouse/partner may receive half the Qualified Child Increase where both are in receipt of a social welfare payment.		
Beneficiaries:	Total of recipients, qualified adults and qualified children.		
Claim/Claimant:	An application/applicant for a social welfare payment.		
Social Insurance Payments:	These comprise Old Age (Contributory) Pension, Retirement Pension, Widow's/Widower's (Contributory) Pension, Orphan's (Contributory) Allowance, Deserted Wife's Benefit, Invalidity Pension, Disability Benefit, Carer's Benefit, Unemployment Benefit, Maternity Benefit, Health and Safety Benefit, Adoptive Benefit, Treatment Benefit, Widowed Parent Grant, Bereavement Grants and Free Schemes.		
Social Assistance Payments:	These comprise Old Age (Non-Contributory) Pension, Widow's (Non-Contributory) Pension, Orphan's (Non-Contributory) Pension, Deserted Wife's Allowance, Prisoner's Wife's Allowance, One-Parent Family Payment, Unemployment Assistance, Farm Assist, Pre-Retirement Allowance, Supplementary Welfare Allowance, Family Income Supplement, Disability Allowance, Carer's Allowance, Blind Pension, Rent Allowance and Free Schemes.		

Appendix 4: Voluntary and Community Organisations

The Department of Social and Family Affairs grant schemes concentrate on a wide range of support for local self-help groups, community development, welfare rights and information work, and on the provision of seed money to enable community groups to pilot initiatives identified as meeting new and emerging community needs. To be eligible for funding, groups must subscribe to a self-help, community ethos and must involve the intended beneficiaries in the management and the design of the project. These grant schemes are aimed at developing people and their capacity to participate in society, rather than the provision of services or direct economic development or job creation initiatives.

Island Development Programme

A programme of core funding to five off-shore islands, Inishboffin, Inishturk, Sherkin, Clare Island and Bere Island, which is geared towards the specific needs of island communities and is funded under the Community Development Programme.

Community Development Programme

The programme provides financial assistance to projects towards the staffing and equipping of local resource centres which provide a focal point for community development activities and to other specialised community development projects and initiatives having a strategic importance. The projects provide a range of supports, development opportunities and services to community groups and individuals within their areas.

Responsibility for the administration of the above schemes transferred to the Department of Community, Rural and Gaeltacht Affairs with effect from 25 June 2002.

Family Resource Centres

The aim of a Family and Community Services Resource Centre is to help combat disadvantage by improving the functioning of the family unit. Centres can provide special services for lone parent families, young mothers and others considered in need of extra support and can act as a first step to community participation and social inclusion for the most vulnerable and marginalised families. Centres are also concerned with initiatives to enhance their parenting skills and initiatives to promote the greater involvement of young men in the life of the community.

Legislation to establish the Family Support Agency was passed in late 2001 and the agency was established on 6 May 2003. Responsibility for the administration of the Family and Community Services Resource Centre Programme has transferred to the new Agency.

Money Advice and Budgeting Service

At the end of 2002, the Money Advice and Budgeting Service (MABS) had 62 centres around the country which address the problems of moneylending and overindebtedness.

Appendix 5

Family Affairs Unit

The Family Affairs Unit was established in the Department of Social and Family Affairs in 1998. The responsibilities of the Unit are:

- to co-ordinate family policy;
- to pursue the findings in the Report of the Commission on the Family following their consideration by the Government;
- to undertake research and promote awareness about family;
- support for the marriage and child and bereavement counselling services;
- the Family Mediation Service;
- · an information programme on parenting issues.

Family Support Agency

Legislation to establish the Family Support Agency was enacted in December 2001. The Family Support Agency, which was established on 6 May 2003, has responsibility for a number of functions currently under the remit of the Family Affairs Unit. The new Agency will:

- provide a family mediation service
- support, promote and develop the provision of marriage and relationship counselling and other family supports and
- support, promote and develop the Family and Community Services Resource Centres programme.

The new Agency will undertake research, provide and disseminate information about parenting and family issues and provide advice to the Minister for Social and Family Affairs on matters relating to its functions.

The Family Support Agency will bring together the main programmes and pro-family services developed since 1997. It will provide a comprehensive and coherent response for families in need of these support services and for families generally. It will be a dedicated Agency and a resource for all those involved in the promotion of family well being.
