Guidance issued by the Department of Agriculture, Food and The Marine in accordance with point 10 of the Principles of Certification of the Veterinary Council of Ireland indicating the extent of enquiries the veterinary surgeon is expected to make, the examinations that he/she is required to carry out and to clarify details of the certificate requiring further interpretation.

1. The PVP should have a written declaration from the client, stored in practice files, stating that he/her or his/her practice has been assigned primary responsibility for veterinary work in the herd concerned for at least the period of time to which disease guarantee statements apply as specified in the text. The PVP or his/her veterinary practice, must have provided clinical veterinary services to this herd for this period of time. Where this period of time is less than that for which certification is required, the PVP will require further certification from the previous veterinary practice, or should make due enquiry of the farmer and the former veterinary practice, in order to be in a position to so certify.

2. After due enquiry regarding the health status of the herd, which should include;

- a review of records of visits undertaken, the PVP or his/her veterinary practice did not record
 any clinical cases of the diseases mentioned in this paragraph for the periods of time described

- due enquiry made of the farmer tofurther satisfy him/herself that there has been no evidence of such diseases for the requisite periods of time .
